Summary of Revenue Changes

A General Fund appropriation of \$433,560 is made to implement the provisions of the bill.

Summary of Subcommittee Action

Senate Bill 1 provides funding to the Office of Emergency Management within the Oregon Military Department for administering and staffing the seismic rehabilitation grant committee established under ORS 400.300. The funding is for the agency's responsibilities in administering and staffing the committee and developing a seismic rehabilitation grant program for critical public buildings. Eligible public buildings include hospital buildings with acute inpatient care facilities, fire stations, police stations, sheriffs' offices, other facilities used by state, county, district or municipal law enforcement agencies; and buildings with a capacity of 250 or more persons that are routinely used for student activities by kindergarten through grade 12 public schools, community colleges, education service districts and institutions of higher education.

The Subcommittee appropriated \$433,560 General Fund including the establishment of four permanent positions (2.67 full-time equivalent) for this purpose. The positions consist of one Program Analyst 3 (0.75 full-time equivalent), one Facilities Engineer 3 (0.67 full-time equivalent), one Accountant 3 (0.50 full-time equivalent), and one Administrative Specialist 1 (0.75 full-time equivalent).
