**WHAT THE MEASURE DOES:** Creates Education System Design Team. Specifies membership and duties of design team. Appropriates moneys from General Fund to Office of Governor for design team. Sunsets design team on date of convening of next regular biennial legislative session. Declares emergency, effective July 1, 2007.

## **ISSUES DISCUSSED:**

- 40-40-20 education goals (described below) and draft work on a preparing a unified PK-20 budget
- History of education enterprise and efforts of interim legislative committees
- Interest in updating legislative process for education budget and need for presession filing authorization
- Plans for a Post-Secondary Quality Education Commission by executive order
- Level of funding for staffing/support needed for design team to design a process and produce a report
- Difficulty of predicting level of federal funding for education

EFFECT OF COMMITTEE AMENDMENT: The amendment replaces the entire text of HB 3338.

**BACKGROUND:** HB 3338-A would create an 11 member Education System Design Team (five Representatives and five Senators not all from the same party, and a representative from the Governor's Office) to "design a new legislative process for review of and decision-making regarding state agency budgets relating to prekindergarten through higher education." HB 3338-A directs the design team to "work with the Quality Education Commission, Post-Secondary Quality Education Commission established by the Governor and with workgroups created by the Joint Boards of Education," to "design a legislative system to review a comprehensive prekindergaten through higher education budget and policy presentation," and "in collaboration with the office of the Governor and workgroups created by the Joint Boards of Education, design and recommend methods of financially supporting an education system that has the following goals: (A) all students graduate from high school; (B) forty percent of high school graduates each year go on to earn an associate degree or equivalent level work skills; (C) forty percent of high school graduates each year go on to earn a bachelor's degree; and (D) ensure that Oregon has world-class education institutions." HB 3338-A would direct the team to submit a report to the interim committees on education by February 1, 2008 and authorize the design team to presession file legislation.

HB 3338-A would direct the Office of the Governor to provide staff support to the design team, authorize the Governor's Office to contract for staff support, and direct state agencies and school districts to assist the design team. HB 3338-A would appropriate an undetermined amount for the work of the Education Design Team.
