# House Bill 2090

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Presession filed (at the request of Secretary of State Bill Bradbury)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Prohibits Secretary of State from disclosing Social Security numbers, federal employer identification numbers and taxpayer identification numbers provided in certain documents filed with Secretary of State.

Deletes requirement that certain documents filed with Secretary of State contain Social Security numbers, federal employer identification numbers and taxpayer identification numbers.

Directs Secretary of State to devise system for establishing unique identifiers for persons filing statements under central filing system for farm products. Directs Secretary of State to seek approval of system from Secretary of United States Department of Agriculture.

Declares emergency, effective on passage.

6 <u>SECTION 1.</u> Section 2 of this 2007 Act is added to and made a part of ORS chapter 56.

SECTION 2. (1) The Secretary of State may not disclose Social Security numbers, Internal Revenue Service taxpayer identification numbers or federal employer identification
numbers contained in documents filed with or created by the Secretary of State under ORS
chapters 58, 60, 62, 63, 65, 67, 70, 79, 87, 194, 305, 465, 466, 475, 554, 596, 634, 647, 648, 657 or
713 or under ORS 30.630, 80.115, 80.118 or 128.595.

(2) Any officer or employee in the office of the Secretary of State whose official functions
include disclosing documents in accordance with ORS chapter 192 shall be immune from civil
or criminal liability when the officer or employee, in good faith compliance with ORS chapter
192, discloses a document that contains a Social Security number, an Internal Revenue Ser-
