#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes technical changes to Public Contracting Code. Modifies provisions governing prevailing wage rates. Declares emergency, effective July 1, 2007.

13	(b) "Contracting agency" means a public body authorized by law to conduct a procurement.
14	"Contracting agency" includes, but is not limited to, the Director of the Oregon Department of Ad-
15	ministrative Services and any person authorized by a contracting agency to conduct a procurement
16	on the contracting agency's behalf. "Contracting agency" does not include the judicial department
17	or the legislative department.
18	(c) "Days" means calendar days.
19	(d) "Department" means the Oregon Department of Administrative Services.

(ii) An agreement under which a contracting agency provides moneys, property or other assistance, including but not limited to federal assistance that is characterized as a grant by federal law or regulations, loans, loan guarantees, credit enhancements, gifts, bequests, commodities or other assets, to a recipient for the purpose of supporting or stimulating a program or activity of the recipient and in which no substantial involvement by the contracting agency is anticipated in the program or activity other than involvement associated with monitoring compliance with the grant conditions.

(B) "Grant" does not include a public contract for a public improvement, for public works, as defined in ORS 279C.800, or for emergency work, minor alterations or ordinary repair or maintenance necessary to preserve a public improvement, when under the public contract a contracting agency pays, in consideration for contract performance intended to realize or to support the realization of the purposes for which grant funds were provided to the contracting agency, moneys that the contracting agency has received under a grant.

[(u)] (w) "Procurement" means the act of purchasing, leasing, renting or otherwise acquiring 24 goods or services. "Procurement" includes each function and procedure undertaken or required to 25be undertaken by a contracting agency to enter into a public contract, administer a public contract 2627and obtain the performance of a public contract under the Public Contracting Code.

[(v)] (x) "Proposer" means a person that submits a proposal in response to a request for pro-28posals. 29

(B) Emergency work, minor alteration, ordinary repair or maintenance necessary to preserve a 42 43 public improvement.

[(bb)] (dd) "Public improvement contract" means a public contract for a public improvement. 44 "Public improvement contract" does not include a public contract for emergency work, minor al-45

1 terations, or ordinary repair or maintenance necessary to preserve a public improvement.

2 [(cc)] (ee) "Recycled material" means any material that would otherwise be a useless, unwanted 3 or discarded material except for the fact that the material still has useful physical or chemical 4 properties after serving a specific purpose and can, therefore, be reused or recycled.

5 [(dd)] (ff) "Recycled oil" means used oil that has been prepared for reuse as a petroleum product 6 by refining, rerefining, reclaiming, reprocessing or other means, provided that the preparation or 7 use is operationally safe, environmentally sound and complies with all laws and regulations.

8 [(ee)] (gg) "Recycled paper" means a paper product with not less than:

9 (A) Fifty percent of its fiber weight consisting of secondary waste materials; or

10 (B) Twenty-five percent of its fiber weight consisting of post-consumer waste.

"Recycled product" includes any product that could have been disposed of as solid waste, having completed its life cycle as a consumer item, but otherwise is refurbished for reuse without substantial alteration of the product's form.

[(*hh*)] (jj) "Secondary waste materials" means fragments of products or finished products of a manufacturing process that has converted a virgin resource into a commodity of real economic value. "Secondary waste materials" includes post-consumer waste. "Secondary waste materials" does not include excess virgin resources of the manufacturing process. For paper, "secondary waste materials" does not include fibrous waste generated during the manufacturing process such as fibers recovered from waste water or trimmings of paper machine rolls, mill broke, wood slabs, chips, sawdust or other wood residue from a manufacturing process.

(kk) "Services" mean services other than personal services designated under ORS
279A.055, except that, for state contracting agencies with procurement authority under ORS
279A.050 or 279A.140, "services" includes personal services as designated by the state contracting agencies.

23 <u>SECTION 48.</u> This 2007 Act being necessary for the immediate preservation of the public 24 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect 25 July 1, 2007.
