6	"(3) 'Subject individual' means a person who is:
7	"(a) Employed or who seeks to be employed by the department to provide care;
8	"(b) A volunteer or who seeks to be a volunteer to provide care on behalf of the department;
9	or
10	"(c) Providing care or who seeks to provide care on behalf of the department or another
11	person.".
12	In line 18, delete "consider" and insert "use".
13	In line 19, after "department" delete the rest of the line and delete lines 20 through 30 and in-
14	sert "for the purpose of providing protective services or screening subject individuals.
15	"(2) The department shall adopt rules to carry out the provisions of subsection (1) of this sec-
16	tion.
17	"(3) The rules adopted in subsection (2) of this section may include:
18	"(a) Notice and opportunity for due process for a department employee found to be unfit; and
19	"(b) Notice and opportunity for hearing in accordance with ORS chapter 183 for a subject indi-
20	vidual described in section 1 (3)(c) of this 2007 Act.".
21	On page 2, delete lines 1 and 2.
22	In line 3, delete "ports." and begin a new paragraph and insert "(4)" and delete "subsection"
23	and insert "section".
24	After line 4, insert:
25	"SECTION 3. (1) The Department of Human Services shall convene a committee con-
26	sisting of employees of the department and representatives of entities that provide care on
27	behalf of the department to develop recommendations to the department for the use of abuse
28	and neglect reports to screen:
29	"(a) Persons who are licensed, certified, registered or otherwise regulated by the de-
30	partment to provide care; and
31	"(b) Employees of persons described in paragraph (a) of this subsection.
32	"(2) The recommendations of the committee under subsection (1) of this section shall
33	include, but not be limited to:
34	"(a) A process for the use of abuse and neglect reports in determining the fitness of in-
35	dividuals described in subsection (1)(a) and (b) of this section to provide care;

- 1 "(b) Detailed information about securing the resources for a data system to collect and 2 maintain all abuse and neglect reports;
- 3 "(c) Identification of the resources necessary to implement the recommendations; and
- 4 "(d) A schedule for implementing the recommendations.
- 5 "(3) The department may present a proposal based on the recommendations of the com-
- 6 mittee, the implementation plan and a supporting budget request to the Seventy-fifth Legis-

7 lative Assembly.".

- 8 In line 5, delete "3" and insert "4".
- 9 In line 9, after "Act" insert a period and delete the rest of the line and lines 10 and 11 and in-10 sert:
- 11 "<u>SECTION 5.</u> Section 3 of this 2007 Act is repealed July 1, 2009.".
