13	In line 25, delete "lender that is issued a consumer finance loan license" and insert "consumer
14	finance licensee".
15	On page 2, line 1, delete "lender are consumer finance loans" and insert "consumer finance
16	licensee have a term of not less than six months".
17	In line 3, before the comma insert "made under the consumer finance license" and delete
18	"lender" and insert "licensee".
19	In line 4, delete "consumer finance".
20	In line 6, delete "lender" and insert "consumer finance licensee".
21	Delete lines 20 and 21 and insert:
22	"SECTION 4. (1) If, under a consumer finance license, a consumer finance licensee makes a
23	loan secured by an interest in a borrower's vehicle, the licensee may not retain possession of".
24	In line 22, delete "lender" and insert "licensee".
25	In line 25, delete "lender in the business of making consumer finance loans" and insert "con-
26	sumer finance licensee".
27	In line 26, after "loan" insert "made under a consumer finance license".
28	In line 28, delete "lender in the business".
29	In line 29, delete "of making consumer finance loans" and insert "consumer finance licensee"
30	and delete "lender" and insert "licensee".
31	In line 30, after the period delete the rest of the line.
32	Delete lines 31 and 32.
33	In line 33, delete "loan".
34	In line 34, delete "loan".
35	In line 35, delete "loan" in both places.

- 1 On page 3, line 4, delete "loan".
- 2 In line 5, delete "loan".
- 3 In line 27, delete "loan" in both places.
- 4 On page 4, delete lines 2 through 4 and insert:
- 5 "(1) In accordance with ORS chapter 183, the Director of the Department of Consumer and
- 6 Business Services may adopt rules to implement, administer and enforce this chapter and to regulate
- 7 lending terms and practices, consistent with this chapter, for the protection of the public.".
