# House Bill 2626

Sponsored by Representatives DINGFELDER, BRUUN

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes statewide system administered by Department of Environmental Quality for collection, transportation and recycling of certain electronic devices. Requires manufacturers of covered electronic devices to register for participation in manufacturer program or contractor program. Requires manufacturer or group of manufacturers to provide collection sites. Directs department to provide consumer information explaining system for recycling covered electronic devices. Requires retailers to display and provide consumers with information on system for recycling covered electronic devices.

Prohibits charging of fee for collection of covered electronic devices, with exception for collectors who provide premium service.

Authorizes Environmental Quality Commission to adopt rules to implement system for recycling covered electronic devices. Imposes civil penalty for disposal of, or knowingly accepting for disposal, covered electronic

Imposes civil penalty for disposal of, or knowingly accepting for disposal, covered electronic devices at solid waste disposal site. Imposes civil penalties for other violations of provisions related to collection and recycling of electronic devices.

4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. The Legislative Assembly finds that:
6	(1) It is necessary to encourage the design of electronic devices that are more resource
7	efficient, more recyclable and less environmentally toxic;
8	(2) The development and availability of a statewide system that conveniently serves both
9	urban and rural areas of Oregon for the collection and recycling of electronic devices at the
10	end of their useful lives is in the best interest of the state; and
11	(3) A statewide collection and recycling system should be financed by the manufacturers
12	of those electronic devices.

14	DEFINITIONS
15	
16	SECTION 2. As used in sections 2 to 11 of this 2007 Act:
17	(1) "Brand" means a manufacturer's name, a brand name or a brand label or all man-
18	ufacturers' names, brand names and brand labels for which a manufacturer has responsibil-
19	ity.
20	(2) "Collector" means an entity that collects covered electronic devices for the purpose
21	of reuse or recycling and that meets standards or contract requirements set forth by the
22	Department of Environmental Quality.
23	(3) "Contractor program" means a statewide program for collecting, transporting and
24	recycling covered electronic devices that is provided by the department for manufacturers

who pay a recycling fee to the department for the purposes of sections 2 to 11 of this 2007 1 2 Act. 3 (4)(a) "Covered electronic device" means: (A) A computer monitor of any type having a viewable area greater than four inches 4 measured diagonally; 5 (B) A desktop computer or portable computer; or 6 (C) A television of any type having a viewable area greater than four inches when 7 measured diagonally. 8 9 (b) "Covered electronic device" does not include: (A) Any part of a motor vehicle; 10 (B) Any part of a larger piece of equipment designed and intended for use in an indus-11 12trial, commercial or medical setting, such as diagnostic, monitoring or control equipment; 13 or (C) Telephones or personal digital assistants of any type unless the telephone or personal 14 15 digital assistant contains a viewable area greater than four inches measured diagonally. 16(5) "Manufacturer" means a person that, irrespective of the selling technique used, in-17 cluding by means of remote sale: 18 (a) Produces covered electronic devices under its own brand for sale in this state; (b) Sells in this state covered electronic devices produced by other suppliers under its 19 own brand; 20(c) Assembles covered electronic devices, with parts produced by others, for sale in this 2122state under the assembler's brand; 23(d) Imports or exports covered electronic devices to the United States for sale in this state, except that if a company from which an importer purchases the covered electronic 24 devices has a presence or assets in the United States, that company shall be deemed to be 25the manufacturer; or 2627(e) Manufactures or supplies covered electronic devices to any person within a distribution network that includes wholesalers or retailers in this state, for the sale in this state 28of those covered electronic devices through that distribution network. 2930 (6) "Manufacturer program" means a statewide program for collecting, transporting and 31 recycling covered electronic devices that is provided by a single manufacturer, or group of manufacturers, for the purposes of sections 2 to 11 of this 2007 Act. 32(7) "Obligation" means the quantity of covered electronic devices, by weight, that an in-33 34 dividual manufacturer is required to recycle in a year, calculated by adding the manufac-35 turer's annual return share by weight to the weight of a percentage of orphan product. (8) "Orphan product" means a covered electronic device whose manufacturer cannot be 36 37 identified or whose manufacturer is no longer in business and has no successor in interest. 38 (9) "Portable computer" means any of the following that has a viewable area greater than four inches measured diagonally and that can be carried as one unit by an individual: 39 (a) A laptop computer; 40 (b) A notebook computer; 41 (c) A notepad computer; or 42 (d) Any similar electronic device. 43 (10) "Premium service" means services such as at-location system upgrade services and 44 at-home pickup services, including curbside pickup service. 45

(11)(a) "Recycling" means: 1 2 (A) Separating, processing, transforming or remanufacturing covered electronic devices, components and by-products into usable or marketable raw materials or products; or 3 (B) Smelting materials from covered electronic devices to recover metals for reuse in 4 conformance with applicable laws and rules. 5 (b) "Recycling" does not include: 6 (A) Landfill disposal or incineration uses; or 7 (B) Energy recovery or energy generation by means of combusting covered electronic 8 9 devices, components and by-products with or without other waste. (12) "Retailer" means a person that owns or operates a business that sells covered elec-10 tronic devices to consumers. 11 12 (13) "Return share" means the percentage of covered electronic devices that an individual manufacturer is responsible for collecting, transporting and recycling. 13 (14) "Return share by weight" means the total weight of covered electronic devices that 14 15 an individual manufacturer is responsible for collecting, transporting and recycling. 16 (15) "Sell" or "sale" means: 17(a) Any transfer of title for consideration in this state that is not a lease; or 18 (b) Any transfer of title for consideration through remote sales conducted through sales outlets, catalogs or the Internet, or any similar electronic means, that is not a lease. 19 20**MANUFACTURERS** 21 22SECTION 3. A manufacturer of covered electronic devices sold in this state shall label 23each covered electronic device with the manufacturer's brand. The label shall be perma-24 nently affixed and readily visible. 25SECTION 4. (1) Before January 1 of each year, a manufacturer of covered electronic de-26vices sold in this state shall register with the Department of Environmental Quality, for a 27period to cover the upcoming calendar year, on a form provided by the department. 1 (c) For calendar years 2012 and beyond, the Environmental Quality Commission may 2 modify the registration fees collected by the department under this section so that the total 3 of registration fees collected approximately matches the department's costs, excluding costs 4 incurred under section 10 (6) of this 2007 Act, of implementing sections 2 to 11 of this 2007

5 Act.

6 (3) The department shall determine a manufacturer's registration fee category for pur-7 poses of subsection (2) of this section using data from national market research, prorated 8 for Oregon and based on statewide population.

Sec. 5. (1) A manufacturer choosing to implement a manufacturer program shall submit a plan at the time of payment of the annual registration fee required under section 4 of this 2007 Act. The plan must describe how the manufacturer will finance, manage and conduct a statewide program that uses environmentally sound management practices to collect, transport and recycle covered electronic devices.

(2) The Department of Environmental Quality shall accept or reject a plan submitted by a
 manufacturer under this section.

 $\mathbf{5}$ (5) By July 1 of each year, a manufacturer that does not meet its obligation for the previous calendar year shall pay the department for the amount not achieved at a rate de-6 termined by the department to be equivalent to the amount the manufacturer would have 7 paid to be part of the contractor program under section 6 of this 2007 Act. 8

9 [(5)] (6) A manufacturer with \_\_\_\_\_\_ percent or less return share is required to choose the contractor program under section 6 of this 2007 Act. 10

SECTION 6. (1) By July 1 of each year, a manufacturer who is part of the contractor 11 12program shall pay a recycling fee to the Department of Environmental Quality in an amount 13 determined by the department to cover the costs of collecting, transporting and recycling the manufacturer's annual return share of covered electronic devices. 14

15(2) The department shall base the recycling fee required under this section on the cost 16of implementing the contractor program and the manufacturer's annual return share of covered electronic devices. The department shall: 17

18 (a) Determine the manufacturer's annual return share for calendar years 2008 and 2009, utilizing data compiled by counties and from other states; and 19

(b) Determine the manufacturer's annual return share for calendar years 2010 and 20thereafter utilizing data reported to the department by manufacturers. 21

22(3) For calendar years 2008 through 2011, the recycling fee may not exceed \$\_\_\_\_\_ per pound. 23

SECTION 7. (1) Except as authorized in subsection (2) of this section, a manufacturer 24program, the contractor program or a collector participating in a manufacturer program or 25a contractor program may not charge a fee to consumers for the collection, transportation 2627or recycling of covered electronic devices.

(2) A collector who provides a premium service to a consumer may charge the consumer 28for the additional cost of providing the premium service. 29

30 SECTION 8. (1) A manufacturer program shall provide convenient and available collection 31 sites for covered electronic devices in both rural and urban areas. A manufacturer program shall provide at least one collection site in every county in this state. A program may provide 32a collection site jointly with another manufacturer program. 33

34 (2) A manufacturer program shall provide at least one collection site for any city with a population of at least 10,000. A collection site for a county may be the same as a collection 35 site for a city in the county. 36

37 (3) Collection sites may include electronics recyclers, repair shops, recyclers of other 38 commodities, reuse organizations, charities or thrifts, retailers, disposal sites, recycling sites, transfer stations or other suitable locations. 39

(4)(a) Collection sites shall be staffed and open to the public at a frequency adequate to 40 meet the needs of the area being served, but at least one day each week between the hours 41 of 8:00 a.m. and 5:00 p.m. 42

(b) Collection sites may accept up to \_\_\_\_\_ covered electronic devices per person per 43 day. 44

(1) A retailer may not sell or offer for sale a covered electronic device from a manufacturer who is not on the list posted by the Department of Environmental Quality 4 pursuant to section 10 of this 2007 Act. $\mathbf{5}$ (2) A retailer shall post, in a location visible to the consumer, information provided by 6 the department and the manufacturer that describes where and how a consumer can recycle 7 covered electronic devices. 8 9 (3) A retailer shall provide in printed form the information described in subsection (2) of this section to the consumer at the time of the sale of a covered electronic device. 10 11 12DEPARTMENT OF ENVIRONMENTAL QUALITY AND ENVIRONMENTAL QUALITY COMMISSION 13 14 15SECTION 10. SECTION 11. The Environmental Quality Commission may adopt rules necessary to im-36 plement a convenient and comprehensive statewide system for the collection, transportation 37 38 and recycling of covered electronic devices. SECTION 12. (1) The Department of Environmental Quality shall evaluate any federal law 39 40 that establishes a national program for the collection and recycling of electronic devices. (2) If the department determines that the federal law substantially meets or exceeds the 41 requirements and intent of sections 2 to 11 of this 2007 Act, the department shall include 42information on the federal law in the next biennial report to the Legislative Assembly pur-43 suant to section 10 of this 2007 Act. 44 45

11	by a retailer on or after January 1, 2009.
12	(2) The amendments to ORS 459.995 by section 14 of this 2007 Act apply to violations of
13	section 9 (1) of this 2007 Act occurring on or after January 1, 2009.
