

# House Bill 2901

Sponsored by Representative BUTLER (at the request of Oregon Bankers Association and Oregon Association of County Treasurers)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Changes collateralization procedures and requirements for deposits of public funds.  
Continuously appropriates certain moneys to State Treasurer for purposes of carrying out regulatory functions.

## A BILL FOR AN ACT

2 Relating to public funds; creating new provisions; amending ORS 182.470, 284.365, 294.847, 295.005,  
3 295.008, 295.015, 295.018, 295.025, 295.027, 295.035, 295.055, 295.115, 295.205, 377.840, 576.375,  
4 706.720 and 708A.535; repealing ORS 295.045, 295.065, 295.085, 295.105, 295.125, 295.175 and  
5 295.185; and appropriating money.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. ORS 295.027 and sections 2 to 14 of this 2007 Act are added to and made a**  
8 **part of ORS 295.005 to 295.165.**

9 **SECTION 2. (1) Within five business days after the State Treasurer receives notice from**  
10 **a custodian pursuant to ORS 295.035 (2)(e) indicating that a bank depository has failed to**  
11 **pledge adequate collateral with its custodian, the treasurer shall send written notice of the**  
12 **failure to each public official who has public funds on deposit in the bank depository with**  
13 **respect to which the notice under ORS 295.035 (2)(e) was given.**

14 **(2) Within five business days after the State Treasurer receives notice from a custodian**  
15 **pursuant to ORS 295.035 (2)(f) indicating that a bank depository has once again pledged ade-**  
16 **quate collateral with its custodian, the treasurer shall send written notice to each public**  
17 **official who was notified under subsection (1) of this section stating that the bank depository**  
18 **once again has adequate collateral.**

19 **SECTION 3. (1) Within 20 business days after a public official receives a notice from the**  
20 **State Treasurer pursuant to ORS 295.018 (5)(a) or section 2 (1) of this 2007 Act, the public**  
21 **official shall withdraw from the bank depository to which the notice applies all public funds**  
22 **deposits except those deposits that are insured by the Federal Deposit Insurance Corpo-**  
23 **ration.**

24 **(2) If a public official receives a notice from the State Treasurer pursuant to ORS 295.018**  
25 **(5)(a) or section 2 (1) of this 2007 Act, beginning 20 business days after the public official**  
26 **receives the notice, the public official may not deposit into the bank depository to which the**  
27 **notice applies any public funds deposits if, as a result of such a deposit, the total public funds**  
28 **of the public official on deposit with the bank depository exceed the deposit insurance limit**  
29 **of the Federal Deposit Insurance Corporation. The prohibition on deposits continues until the**  
30 **public official receives notice under ORS 295.018 (5)(b) or section 2 (2) of this 2007 Act indi-**

1 cating that the bank depository is in compliance with ORS 295.018 or 295.035, as applicable.

2 (3) Except as required by any applicable law or regulation, a bank depository may not  
 3 impose any early withdrawal penalty or any forfeiture of interest with respect to a with-  
 4 drawal made by a public official pursuant to this section.

5 **SECTION 4.** (1) The deposit of securities by a bank depository with its custodian pursuant  
 6 to ORS 295.005 to 295.165 constitutes consent by the bank depository to the disposition of the  
 7 securities in accordance with this section.

8 (2) When a loss has occurred in a bank depository, the bank depository shall as soon as  
 9 possible make payment to the proper public officials of all funds subject to the loss, pursuant  
 10 to the following procedures:

11 (a) The Director of the Department of Consumer and Business Services or the receiver  
 12 shall, within 20 days after the issuance of a restraining order or taking possession of any  
 13 bank depository, ascertain the amount of public funds on deposit in the bank depository as  
 14 disclosed by its records and the amount of the public funds covered by deposit insurance and  
 15 certify the amounts to the State Treasurer and to each public official who has public funds  
 16 on deposit in the bank depository.

17 (b) Each public official who has public funds on deposit in the bank depository shall,  
 18 within 10 days after receipt of the certification from the Director of the Department of  
 19 Consumer and Business Services or the receiver, furnish to the State Treasurer verified  
 20 statements of the public funds that the public official has on deposit in the bank depository.

21 (3) Upon receipt of the certification from the Director of the Department of Consumer  
 22 and Business Services or the receiver and the verified statements from the public officials  
 23 who have public funds on deposit in the bank depository, the State Treasurer shall ascertain  
 24 and fix the amount of public funds on deposit in the bank depository, plus interest to the date  
 25 the funds are distributed to the public official at the rate the bank depository agreed to pay  
 26 on the funds, minus any amount covered by deposit insurance.

27 (4) After making the calculation described in subsection (3) of this section, the State  
 28 Treasurer shall assess the net amount of public funds against all bank depositories, as fol-  
 29 lows:

30 (a) First, against the bank depository that suffered the loss, to the extent of the full  
 31 value of its collateral deposited with its custodian pursuant to ORS 295.005 to 295.165; and

32 (b) Second, against the collateral of all other bank depositories, on a proportionate basis  
 33 determined as provided in subsection (5) of this section.

34 (5) For purposes of subsection (4) of this section, the proportionate share of each of the  
 35 other bank depositories shall be determined by:

36 (a) Averaging the amounts of the total public funds deposits reported on the bank de-  
 37 pository's last four treasurer reports;

38 (b) Averaging the total amounts of the total public funds deposits reported on the last  
 39 four treasurer reports of all of the bank depositories; and

40 (c) Dividing the result of the calculation performed under paragraph (a) of this sub-  
 41 section by the result of the calculation performed under paragraph (b) of this subsection.

42 (6) Notwithstanding the assessment provisions of subsection (4) of this section, the State  
 43 Treasurer shall assess the net amount of public funds deposits of a public official only  
 44 against the bank depository that suffered the loss, and not against the collateral of other  
 45 bank depositories, if the public official:

1 (a) Was given appropriate notice about the bank depository by the State Treasurer under  
 2 section 2 (1) of this 2007 Act or ORS 295.018 (5)(a); and

3 (b) The public official did not comply with section 3 of this 2007 Act.

4 (7) Assessments made by the State Treasurer are payable on the fifth business day fol-  
 5 lowing demand. If any bank depository fails to pay its assessment, the State Treasurer shall  
 6 take possession of the securities segregated as collateral by the bank depository and liquidate  
 7 the securities for the purpose of paying the assessment.

8 (8) The State Treasurer shall distribute the net proceeds of the assessments and of any  
 9 liquidated collateral, to the extent that they do not exceed the total net amount of public  
 10 funds deposits and accrued interest claimed by the public officials, among the public officials  
 11 entitled to the proceeds in proportion to the public officials' respective claims.

12 (9) If the net proceeds of the assessments and of any liquidated collateral are inadequate,  
 13 after all other available sources are applied, to meet the total claims of the public officials  
 14 entitled to the proceeds, the public officials may make claims against the closed bank de-  
 15 pository as general creditors.

16 **SECTION 5.** The State Treasurer may charge bank depositories for the reasonable ex-  
 17 penses of the State Treasurer in connection with the services, duties and activities of the  
 18 State Treasurer related to ORS 295.005 to 295.165. The State Treasurer shall deposit all  
 19 moneys received under this section in the Miscellaneous Receipts Account established in the  
 20 General Fund for the State Treasurer. Moneys received under this section are continuously  
 21 appropriated to the State Treasurer for the payment of the reasonable expenses of the State  
 22 Treasurer in connection with the services, duties and activities of the State Treasurer re-  
 23 lated to ORS 295.005 to 295.165. A bank depository shall pay to the State Treasurer all fees  
 24 and other amounts charged under this section or under rules adopted to implement this  
 25 section.

26 **SECTION 6.** Upon the distribution of the proceeds of assessments and liquidated collat-  
 27 eral pursuant to section 4 of this 2007 Act by the State Treasurer to any public official, the  
 28 State Treasurer shall be subrogated to all of the right, title and interest of the public official  
 29 against the closed bank depository, and shall share in any distribution of its assets ratably  
 30 with other depositors. Any sums received from any distribution shall be paid to the public  
 31 officials to the extent of any unpaid net deposit liability and the balance remaining shall be  
 32 paid to the bank depositories against which the assessments were made, pro rata in propor-  
 33 tion to the assessments actually paid by each bank depository. However, the closed bank  
 34 depository may not share in any distribution of the balance remaining. If the State Treasurer  
 35 incurs expenses in enforcing the treasurer's rights under this section, the expenses may be  
 36 charged as provided in section 5 of this 2007 Act. The State Treasurer shall submit a claim  
 37 for expenses to the bank depository, and if the charges are thereafter paid to the treasurer,  
 38 they shall be treated as a liquidation expense of the closed bank depository.

39 **SECTION 7.** (1) On or before each treasurer report due date, each bank depository that  
 40 has in its possession public funds deposits shall file its treasurer report with the State  
 41 Treasurer.

42 (2) Each bank depository that files reports with the State Treasurer under subsection (1)  
 43 of this section shall notify the State Treasurer in writing or by electronic means within 10  
 44 business days of:

45 (a) The date on which the bank depository's net worth is reduced by an amount greater

1 than 10 percent of the amount shown as its net worth on the most recent report submitted  
 2 pursuant to subsection (1) of this section; or

3 (b) The date on which the bank depository ceases to be well capitalized and becomes ad-  
 4 equately capitalized or undercapitalized, or ceases to be adequately capitalized and becomes  
 5 undercapitalized.

6 **SECTION 8.** (1) The State Treasurer may request that the Director of the Department  
 7 of Consumer and Business Services or another state or federal agency with primary regula-  
 8 tory authority over any financial institution that is a bank depository or that applies to be-  
 9 come a bank depository investigate and report to the State Treasurer concerning the  
 10 condition of the financial institution.

11 (2) The financial institution examined under this section shall pay the expenses of the  
 12 investigation and report.

13 (3) In lieu of an investigation and report, the State Treasurer may rely upon information  
 14 made available to the State Treasurer or the Director of the Department of Consumer and  
 15 Business Services by the Office of the Comptroller of the Currency, the Office of Thrift  
 16 Supervision, the Federal Deposit Insurance Corporation, the Board of Governors of the  
 17 Federal Reserve System or any state bank or thrift regulatory agency.

18 **SECTION 9.** The Director of the Department of Consumer and Business Services shall  
 19 advise the State Treasurer of any action the director takes or directs any bank depository  
 20 to take that will result in a reduction of greater than 10 percent of the net worth of the bank  
 21 depository as shown on the most recent treasurer report submitted pursuant to section 7  
 22 of this 2007 Act.

23 **SECTION 10.** (1) A bank depository may not accept a deposit of public funds if the deposit  
 24 would cause the aggregate of public funds deposits made by any one public official in the  
 25 bank depository to exceed at any time the net worth of the bank depository. If a bank de-  
 26 pository's net worth is reduced, the bank depository may allow public funds on deposit in  
 27 excess of the reduced net worth to remain if the bank depository deposits with its custodian  
 28 eligible securities valued at market value in an amount at least equal to the amount of the  
 29 excess public funds deposits. If the additional securities required by this section are not de-  
 30 posited with the custodian, the bank depository shall permit the public official to withdraw  
 31 deposits prior to maturity, including accrued interest, in accordance with applicable statutes  
 32 and governmental regulations.

33 (2) The limitations of subsection (1) of this section do not apply to public funds deposits  
 34 held by a bank depository in a program described in ORS 295.027.

35 **SECTION 11.** (1) Notwithstanding section 10 of this 2007 Act, a bank depository may not  
 36 permit the aggregate of public funds deposits on deposit with the bank depository from all  
 37 public officials to exceed at any time:

38 (a) 100 percent of the value of the bank depository's net worth, if the bank depository is  
 39 an undercapitalized bank depository;

40 (b) 150 percent of the value of the bank depository's net worth, if the bank depository is  
 41 an adequately capitalized bank depository;

42 (c) 200 percent of the value of the bank depository's net worth, if the bank depository is  
 43 a well capitalized bank depository; or

44 (d) 30 percent of the total aggregate public funds deposits of all public officials in all bank  
 45 depositories as reported in the most recent notice received by the bank depository from the

1 **State Treasurer.**

2 (2) If a bank depository's aggregate of public funds deposits exceeds the amount set forth  
 3 in subsection (1) of this section, the bank depository shall, not later than 20 business days  
 4 after receipt of notice from the State Treasurer, cease accepting deposits of public funds.

5 (3) Notwithstanding subsections (1) and (2) of this section:

6 (a) A bank depository may accept and hold public funds deposits in excess of the limits  
 7 provided in subsection (1) of this section if the State Treasurer, upon good cause shown,  
 8 approves the request of the bank depository to hold public funds in excess of the limits pro-  
 9 vided in subsection (1) of this section for a period not exceeding 90 days.

10 (b) The limitations of subsection (1) of this section do not apply to public funds deposits  
 11 held by a bank depository in a program described in ORS 295.027.

12 (c) A bank depository may accept and hold public funds deposits in excess of the limit  
 13 provided in subsection (1)(d) of this section if eligible securities are deposited with the bank  
 14 depository's custodian as collateral in an amount at least equal to the amount of the public  
 15 funds deposits in excess of the limitation prescribed in subsection (1)(d) of this section.

16 **SECTION 12.** When public funds deposits are made in accordance with ORS 295.005 to  
 17 295.165, a public official may not be held liable for any loss of public funds that results from  
 18 the failure or default of any depository without fault or neglect on the public official's part  
 19 or on the part of the public official's officers or employees.

20 **SECTION 13.** (1) If a bank depository ceases holding public funds deposits, the bank de-  
 21 pository's custodian shall continue to hold the pledged securities of the bank depository as  
 22 collateral pursuant to ORS 295.005 to 295.165. Unless the State Treasurer directs that the  
 23 bank depository's securities be held for a longer period, the custodian shall hold the bank  
 24 depository's pledged securities for a period of:

25 (a) 30 days, in the case of a bank depository that was well capitalized as of the date the  
 26 bank depository ceased holding any public funds deposits;

27 (b) 90 days, in the case of a bank depository that was adequately capitalized as of the date  
 28 the bank depository ceased holding any public funds deposits; or

29 (c) One year, in the case of a bank depository that was undercapitalized as of the date  
 30 the bank depository ceased holding any public funds deposits.

31 (2) At the end of the applicable holding period, if the bank depository has not, during that  
 32 period, had on deposit any public funds deposits, the custodian shall tender the bank deposi-  
 33 tory's securities to the bank depository.

34 (3) Notwithstanding the release of a bank depository's securities pursuant to subsection  
 35 (2) of this section, the bank depository shall continue to be treated as a bank depository and  
 36 shall be subject to assessment under section 4 of this 2007 Act until one year after the bank  
 37 depository ceased holding any public funds deposits.

38 **SECTION 14.** (1) The State Treasurer shall adopt rules implementing the provisions of  
 39 ORS 295.005 to 295.165.

40 (2) The State Treasurer shall design the treasurer report required by section 7 of this  
 41 2007 Act. The report shall be designed to minimize the regulatory burden of completing and  
 42 submitting the report and, to the greatest extent practicable, the form of the report and the  
 43 content required in the report shall be consistent with the information required by the bank  
 44 depository's report of condition and income.

45 **SECTION 15.** ORS 295.005 is amended to read:

295.005. As used in ORS 295.005 to 295.165, unless the context requires otherwise:

[(1) “Certificate of participation” or “certificate” means a nonnegotiable document issued by a pool manager to a public official.]

(1) “Adequately capitalized” means a bank depository that is classified as adequately capitalized by its primary federal regulatory authority.

(2) “Bank depository” means an insured institution or trust company that:

(a) Maintains a head office or branch in this state in the capacity of an insured institution or trust company; and

(b) Complies with ORS 295.008.

(3) “Business day” means any day other than a federal or State of Oregon legal holiday or a day on which offices of the State of Oregon are otherwise authorized by law to remain closed.

(4) “Credit union depository” means a credit union as defined in ORS 723.006 or a federal credit union if:

(a) The shares and deposits of the credit union or federal credit union are insured by the National Credit Union Share Insurance Fund; and

(b) The credit union or federal credit union maintains a head office or branch in this state in the capacity of a credit union or federal credit union.

[(2)] (5) “Custodian bank” or “custodian” means the following institutions designated by the bank depository [*bank*] for its own account:

[(a) *The Federal Reserve Bank designated to serve this state, or any branch of that bank;*]

[(b)] (a) The Federal Home Loan Bank designated to serve this state, or any branch of that bank; and

[(c)] (b) Any insured institution or trust company[, *as those terms are defined in ORS 706.008,*] that:

(A) Is authorized to accept deposits or transact trust business in this state; [*and that*]

(B) Complies with ORS 295.008; and

(C) Has been appointed as an approved custodian by the State Treasurer if the State Treasurer has appointed approved custodians under ORS 295.008.

[(d) *The fiscal agency of the State of Oregon, duly appointed and acting as such agency pursuant to ORS 288.010 to 288.110.*]

[(3)] (6) “Custodian’s receipt” or “receipt” means a document issued by a custodian bank [*to a pool manager*] describing the securities deposited with it by a bank depository [*bank*] to secure public fund deposits.

[(4)] (7) “Depository bank” or “depository” means a bank depository or a credit union depository. [*an insured institution or trust company, as those terms are defined in ORS 706.008, a credit union, as defined in ORS 723.006, the shares and deposits of which are insured by the National Credit Union Share Insurance Fund, or a federal credit union, if the institution, trust company or credit union:*]

[(a) *Maintains a head office or a branch in this state in the capacity of an insured institution, trust company, credit union or federal credit union; and*]

[(b) *In the case of an insured institution or trust company, complies with ORS 295.008.*]

[(5) “Pool manager” means:]

[(a) *The State Treasurer;*]

[(b) *Any insured institution or trust company, as those terms are defined in ORS 706.008, a credit*

1 union, as defined in ORS 723.006, the shares and deposits of which are insured by the National Credit  
 2 Union Share Insurance Fund, or a federal credit union, if the institution, trust company or credit un-  
 3 ion:]

4 [(A) Is authorized to accept deposits or transact trust business in this state; and]

5 [(B) In the case of an insured institution or trust company, complies with ORS 295.008;]

6 [(c) The Federal Reserve Bank designated to serve this state, or any branch of that bank; or]

7 [(d) The Federal Home Loan Bank designated to serve this state, or any branch of that bank.]

8 **(8) “Financial institution outside this state” means a financial institution, as defined in**  
 9 **ORS 706.008, that is not an extranational institution, as defined in ORS 706.008, and is not a**  
 10 **bank depository or credit union depository, as defined in this section.**

11 **(9) “Insured institution” means an insured institution as defined in ORS 706.008.**

12 **(10) “Loss” means the issuance of an order by a regulatory or supervisory authority or**  
 13 **a court of competent jurisdiction:**

14 **(a) Restraining a bank depository from making payments of deposit liabilities; or**

15 **(b) Appointing a receiver for a public depository.**

16 **(11) “Maximum liability” of a bank depository on any given date means a sum equal to:**

17 **(a) For a well capitalized bank depository, 10 percent of the greater of:**

18 **(A) All public funds held by the bank depository, as shown on the most recent treasurer**  
 19 **report; or**

20 **(B) The average of the balances of public funds held by the bank depository, as shown**  
 21 **on the last four immediately preceding treasurer reports.**

22 **(b) For an adequately capitalized bank depository, 25 percent of the greater of:**

23 **(A) All public funds held by the bank depository, as shown on the most recent treasurer**  
 24 **report; or**

25 **(B) The average of the balances of public funds held by the bank depository, as shown**  
 26 **on the last four immediately preceding treasurer reports.**

27 **(c) For an undercapitalized bank depository, 110 percent of the greater of:**

28 **(A) All public funds held by the bank depository, as shown on the most recent treasurer**  
 29 **report; or**

30 **(B) The average of the balances of public funds held by the bank depository, as shown**  
 31 **on the last four immediately preceding treasurer reports.**

32 **(12) “Net worth” of a bank depository means:**

33 **(a) The equity capital of the bank depository, as shown on the immediately preceding**  
 34 **report of condition and income, and may include capital notes and debentures that are sub-**  
 35 **ordinate to the interests of depositors; or**

36 **(b) An amount of equity capital designated by the State Treasurer.**

37 **(13) “Pledge agreement” means a written agreement among an insured institution or**  
 38 **trust company, the State Treasurer and a custodian that pledges the securities deposited by**  
 39 **the insured institution or trust company with the custodian as collateral for deposits of**  
 40 **public funds held by the insured institution or trust company. The agreement must be ap-**  
 41 **proved by the board of directors or loan committee of the insured institution or trust com-**  
 42 **pany and must be continuously maintained as a written record of the insured institution or**  
 43 **trust company.**

44 **[(6)] (14) “Public funds” or “funds” means funds under the control or in the custody of a public**  
 45 **official by virtue of office.**

1       **(15) “Public official” means each officer or employee of this state or any agency, political**  
 2 **subdivision or public or municipal corporation thereof, or any housing authority, who by law**  
 3 **is made the custodian of or has control of any public funds.**

4       **(16) “Report of condition and income” means the quarterly report submitted to a bank**  
 5 **depository’s primary federal regulatory authority.**

6       [(7)] **(17) “Security” or “securities” means:**

7       (a) Obligations of the United States, including those of its agencies and instrumentalities **and**  
 8 **of government sponsored enterprises;**

9       (b) Obligations of the International Bank for Reconstruction and Development;

10      (c) Bonds of any state of the United States:

11      (A) That are rated in one of the four highest grades by a recognized investment service organ-  
 12 ization that has been engaged regularly and continuously for a period of not less than 10 years in  
 13 rating state and municipal bonds; or

14      (B) Having once been so rated are ruled to be eligible securities for the purposes of ORS 295.005  
 15 to 295.165, notwithstanding the loss of such rating;

16      (d) Bonds of any county, city, school district, port district or other public body in the United  
 17 States payable from **or secured by** ad valorem taxes [*levied generally on substantially all property*  
 18 *within the issuing body*] and that meet the rating requirement or are ruled to be eligible securities  
 19 as provided in paragraph (c) of this subsection;

20      (e) Bonds of any county, city, school district, port district or other public body issued pursuant  
 21 to the Constitution or statutes of the State of Oregon or the charter or ordinances of any county  
 22 or city within the State of Oregon, if the issuing body has not been in default with respect to the  
 23 payment of principal or interest on any of its bonds within the preceding 10 years or during the  
 24 period of its existence if that is less than 10 years;

25      **(f) With the permission of the State Treasurer and in accordance with rules adopted by**  
 26 **the State Treasurer, loans made to any county, city, school district, port district or other**  
 27 **public body in the State of Oregon, if the borrower has not been in default with respect to**  
 28 **the payment of principal or interest on any of its loans within the preceding 10 years or**  
 29 **during the period of its existence if that is less than 10 years;**

30      [(f)] **(g) With the permission of the State Treasurer and in accordance with rules adopted**  
 31 **by the State Treasurer, bond anticipation notes issued, sold or assumed by an authority under**  
 32 **ORS 441.560;**

33      [(g)] *One-family to four-family housing mortgage loan notes related to property situated in the State*  
 34 *of Oregon, which are owned by a depository bank, no payment on which is more than 90 days past*  
 35 *due, and which are eligible collateral for loans from the Federal Reserve Bank of San Francisco under*  
 36 *section 10(b) of the Federal Reserve Act and regulations thereunder;]*

37      (h) Bonds, notes, letters of credit or other securities or evidence of indebtedness constituting the  
 38 direct and general obligation of a federal home loan bank or Federal Reserve bank;

39      (i) Debt obligations of domestic corporations that are rated in one of the three highest grades  
 40 by a recognized investment service organization that has been engaged regularly and continuously  
 41 for a period of not less than 10 years in rating corporate debt obligations; **and**

42      (j) Collateralized mortgage obligations and real estate mortgage investment conduits that are  
 43 rated in one of the two highest grades by a recognized investment service organization that has been  
 44 engaged regularly and continuously for a period of not less than 10 years in rating corporate debt  
 45 obligations[; *and*].



1        *[(k) One-family to four-family housing mortgages that have been secured by means of a guarantee*  
 2 *as to full repayment of principal and interest by an agency of the United States Government, including*  
 3 *the Government National Mortgage Association, the Federal National Mortgage Association and the*  
 4 *Federal Home Loan Mortgage Corporation.]*

5        *[(8) "Public official" means each officer or employee of this state or any agency, political subdivi-*

22        **(23) "Well capitalized" means a bank depository that is classified as well capitalized by**  
 23 **its primary federal regulatory authority.**

25        295.008. (1)(a) An insured institution or trust company *[described in ORS 295.005 (2)(c)]* may not

32 294.847. In making investments pursuant to ORS 294.805 to 294.895, the investment officer shall

34 (1) Make a commitment to invest funds or sell securities more than 14 business days prior to  
 35 the anticipated date of settlement of the purchase or sale transaction;

36 (2) Enter into any agreement to invest funds or sell securities for future delivery for a fee other  
 37 than interest;

38 (3) Lend securities to any person or institution, except on a fully collateralized basis;

39 (4) Pay for any securities purchased by the investment officer until the investment officer has  
 40 received physical possession, or other sufficient evidence, as determined under ORS 293.751 (1), of

 31 authority of ORS 576.325 and all other moneys received by a commodity commission must be paid  
 32 to the authorized agent of the commission and promptly deposited into an account established by the  
 33 commission in a depository [*bank*], as defined in ORS 295.005, that is insured by the Federal Deposit  
 34 Insurance Corporation. In a manner consistent with the requirements of [*ORS chapter 295*] **ORS**  
 35 **295.005 to 295.165**, the chairperson and vice chairperson for a commission shall ensure that suffi-  
 36 cient collateral secures any amount of funds on deposit that exceeds the limits of the Federal De-  
 37 posit Insurance Corporation’s coverage. All moneys in the account are continuously appropriated to  
 38 the commission making the deposit for the purpose of carrying out the duties, functions and powers  
 39 of the commission.

40 (2) Moneys may not be withdrawn from or paid out of the account except upon order of the  
 41 commission, and upon checks or other orders upon such accounts signed by the secretary-treasurer

30 (4) Notwithstanding subsection (3) of this section, the director may disclose any record of the  
 31 department specified in this subsection pertaining to an Oregon operating institution that has been  
 32 liquidated under ORS 711.400 to 711.615 if the director determines in the particular instance that  
 33 the public interest in disclosure of the record outweighs the interests of the Oregon operating in-  
 34 stitution or its directors, stockholders, officers, employees or customers in keeping the record con-  
 35 fidential. Under no circumstances, however, shall the director disclose any such record or portion  
 36 thereof that contains any proprietary information or any information relating to the individual fi-  
 37 nancial activities or affairs of persons unless the director concludes that those activities or affairs  
 38 were a direct and substantial contributing factor in the failure of the Oregon operating institution.

 32 of the assets pledged shall not be more than 50 percent greater than the amount borrowed. If the  
 33 value of the assets pledged is more than 25 percent greater than the amount borrowed or if the  
 34 amount borrowed is greater than the stockholders' equity of the bank, the transaction shall first be  
 35 approved in writing by the Director of the Department of Consumer and Business Services.

36 (c) To secure its deposits that are not insured by the Federal Deposit Insurance Corporation  
 37 provided:

38 (A) The value of aggregate assets pledged does not exceed 20 percent of its stockholders' equity;  
 39 and

40 (B) The prior written approval of the director is obtained.

41 (d) To secure public funds **pursuant to ORS 295.005 to 295.165**, trust funds awaiting investment  
 42 or distribution, or trust funds deposited with it by an institution.

43 (2) Notwithstanding any other provision of state law, when an institution grants a security in-  
 44 terest in assets to secure public funds, the depositor of the public funds and any bailee of pledged  
 45 securities or other assets shall be entitled to the status of a lien creditor as defined in ORS 79.0102.

1 (3) An institution shall grant a security interest in its assets only when authorized by a general  
 2 or specific prior resolution [*or*] of its board of directors.

3 (4) As used in this section, “public funds” means deposits belonging to:

4 (a) The State of Oregon that may be deposited to the official credit of the State Treasurer, and  
 5 funds that may be deposited in an official capacity by any state officer, board or commission.

6 (b) Any county within this state deposited to the official credit of the county treasurer, including  
 7 the funds of any irrigation or drainage district organized under the laws of this state, or any school  
 8 district within this state where funds of the school district are deposited with the county treasurer,  
 9 and funds that may be deposited in an official capacity by any county officer.

10 (c) Any port, port commission, dock or dock commission within this state that may be deposited  
 11 to the credit of the port, port commission, dock or dock commission, or the treasurer thereof.

12 (d) Any city within this state deposited to the official credit of the city treasurer, and funds that  
 13 may be deposited in an official capacity by any officer of any municipal corporation.

14 (e) Any school district within this state.

15 (f) Any district organized under the laws of this state with the power to levy taxes.

16 (g) Any housing authority organized and operating pursuant to ORS 456.055 to 456.235.

17 (h) The United States and any of its agencies and instrumentalities to be deposited in the man-  
 18 ner and under the rules prescribed by the United States Government.

19 **SECTION 32. On or before the operative date of this 2007 Act, each insured institution**  
 20 **and trust company that wishes to act as a bank depository under ORS 295.005 to 295.165 from**  
 21 **and after the operative date of this 2007 Act shall file with the State Treasurer an initial**
