## HOUSE AMENDMENTS TO HOUSE BILL 3338

On page 1 of the printed bill, delete lines 4 through 30 and delete page 2 and insert: 1 2 "SECTION 1. (1) There is created an Education System Design Team, consisting of the 3 following members: "(a) The President of the Senate shall appoint five members from among members of the 4 Senate. The members appointed under this paragraph may not all be from the same political  $\mathbf{5}$ 6 party. 7 "(b) The Speaker of the House of Representatives shall appoint five members from among members of the House of Representatives. The members appointed under this paragraph may 8 9 not all be from the same political party. 10 "(c) The Governor shall appoint one member to represent the office of the Governor. 11 "(2) The purpose of the design team is to design a new legislative process for review of 12 and decision-making regarding state agency budgets relating to prekindergarten through 13 higher education. The process shall use a holistic or enterprise approach to prekindergarten 14 through higher education. The design team shall: "(a) Work with the Quality Education Commission, with the Post-Secondary Quality Ed-1516 ucation Commission established by the Governor and with workgroups created by the Joint 17 **Boards of Education:** 18 "(b) Design a legislative system to review a comprehensive prekindergarten through 19 higher education budget and policy presentation; and 20 "(c) In collaboration with the office of the Governor and workgroups created by the Joint 21Boards of Education, design and recommend methods of financially supporting an education 22system that has the following goals: 23 "(A) All students graduate from high school; 24 "(B) Forty percent of high school graduates each year go on to earn an associate degree 25or acquire equivalent level work skills; 26"(C) Forty percent of high school graduates each year go on to earn a bachelor's degree; 27and 28 "(D) Ensure that Oregon has world-class education institutions. 29 "(3) A majority of the members of the design team constitutes a quorum for the trans-30 action of business. "(4) Official action by the design team requires the approval of a majority of the members 31 32of the design team. 33 "(5) The design team shall elect one of its members to serve as chairperson. "(6) If there is a vacancy for any cause, the appointing authority shall make an appoint-34 35ment to become immediately effective.

1 "(7) The design team shall meet at times and places specified by the call of the chair-2 person or of a majority of the members of the design team.

3 "(8) The design team may adopt rules necessary for the operation of the design team.

4 "(9) The design team shall submit a report, and may include recommendations for legis-5 lation, to the interim legislative committees on education on or before February 1, 2008.

"(10) The design team may presession file legislation in the manner provided in ORS
171.130 for interim committees. All legislation recommended by official action of the design
team must indicate that it is introduced at the request of the design team.

9 "(11) The office of the Governor shall provide staff support to the design team. The office
 10 of the Governor may also contract for staff support for the design team.

"(12) Members of the design team who are not members of the Legislative Assembly are not entitled to compensation, but may be reimbursed for actual and necessary travel and other expenses incurred by them in the performance of their official duties in the manner and amounts provided for in ORS 292.495. Claims for expenses shall be paid out of funds appropriated to the office of the Governor for that purpose.

16 "(13) All agencies of state government, as defined in ORS 174.111, and all school districts 17 are directed to assist the design team in the performance of its duties and, to the extent 18 permitted by laws relating to confidentiality, to furnish such information and advice as the 19 members of the design team consider necessary to perform their duties.

20 "<u>SECTION 2.</u> Section 1 of this 2007 Act is repealed on the date of the convening of the 21 next regular biennial legislative session.

<u>"SECTION 3.</u> There is appropriated to the office of the Governor, for the biennium beginning July 1, 2007, out of the General Fund, the amount of \$\_\_\_\_\_\_ for the purposes of the
Education System Design Team.

25 "<u>SECTION 4.</u> This 2007 Act being necessary for the immediate preservation of the public
26 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
27 July 1, 2007.".
