# **House Joint Resolution 52**

Sponsored by Representative WHISNANT

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Proposes amendment to Oregon Constitution related to preventing disturbances at or disruptions to funeral, memorial service, burial or other ceremony held at cemetery or other place ordinarily used for or dedicated to remembering or honoring deceased persons.

Refers proposed amendment to people for their approval or rejection at special election held on same date as next primary election.

### JOINT RESOLUTION

2 Whereas the President of the United States in 2006 signed the Respect for America's Fallen Heroes Act (P.L. 109-228), which prohibits certain demonstrations at military cemeteries; and

4 Whereas families have a substantial interest in organizing and attending funerals, memorial services, wakes, visitations, processions, burials, cremations and similar functions and ceremonies 5 6 for deceased relatives; and

7 Whereas Oregonians have tremendous gratitude for the courage of members of the Armed 8 Forces and first responders; and

Whereas the thoughts and prayers of a grateful state are with the families of the deceased; and 9 10 Whereas the interests of families in private and public functions and ceremonies to honor and remember deceased relatives are violated when funerals and memorial services are targeted for 11 12 picketing and demonstrations; and

13 Whereas picketing and demonstrations at such functions and ceremonies cause emotional distress to grieving families; and 14

Whereas the Seventy-fourth Legislative Assembly finds that it is imperative that grieving fami-15 lies, friends and loved ones have an adequate opportunity, free from protests and picketing, to mourn 16 at such functions and ceremonies; and 17

Whereas restricting picketing and demonstrations immediately before, during and immediately 18 after funerals, memorial services, wakes, visitations, burials and cremations strikes a proper balance 19 20 between the privacy rights of families, friends and loved ones and the exercise of freedom of speech 21and other constitutional rights; now, therefore,

#### 22Be It Resolved by the Legislative Assembly of the State of Oregon:

**PARAGRAPH 1.** The Constitution of the State of Oregon is amended by creating a new section 2324 12 to be added to and made a part of Article XV, such section to read:

SECTION 12. The Legislative Assembly or the people by initiative may enact laws to 25prevent disturbances at or disruptions to a funeral, memorial service, wake, burial, 26 27cremation or other ceremony held at a cemetery or other place ordinarily used for or dedi-28 cated to remembering or honoring a deceased person.
