Senate Bill 1058

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates crime of vehicular homicide. Punishes by maximum of five years' imprisonment, \$125,000 fine, or both.

5 Be It Enacted by the People of the State of Oregon:

6 <u>SECTION 1.</u> (1) Criminal homicide constitutes vehicular homicide when a person 7 negligently operates a motor vehicle or a boat in a manner that causes the death of another 8 human being.

9 (2) As used in this section, "negligence" means that a person fails to be aware of a risk 10 that death will occur. The risk must be of such a nature and degree that the failure to be 11 aware of it constitutes a deviation from the standard of care that a reasonable person would 12 observe in the situation.

(3) The commission of acts constituting an offense are admissible to prove negligence
 under this section if the acts are a cause of the homicide.

15 (4) Vehicular homicide is a Class C felony.

16 **SECTION 2.** ORS 163.005 is amended to read:

17 163.005. (1) A person commits criminal homicide if, without justification or excuse, the person:

(a) Intentionally, knowingly, recklessly or with criminal negligence causes the death of another
 human being[.]; or

(b) Negligently causes the death of another human being while operating a motor vehicle
 or a boat under section 1 of this 2007 Act.

- 22 (2) "Criminal homicide" is murder, manslaughter, [or] criminally negligent homicide or vehicu-

(3) "Human being" means a person who has been born and was alive at the time of the criminalact.

27 181.085. (1) The Department of State Police is authorized to:

(a) Store blood and buccal samples received under authority of this section, ORS 137.076, 161.325

and 419C.473 (1) and section 2, chapter 852, Oregon Laws 2001, and other physical evidence obtained

30 from analysis of such samples;

(b) Analyze such samples for the purpose of establishing the genetic profile of the donor or

2 otherwise determining the identity of persons or contract with other qualified public or private laboratories to conduct that analysis; 3 (c) Maintain a criminal identification database containing information derived from blood and 4 buccal analyses; 5 (d) Utilize such samples to create statistical population frequency databases, provided that ge-6 netic profiles or other such information in a population frequency database shall not be identified 7 with specific individuals; and 8 9 (e) Adopt rules establishing procedures for obtaining, transmitting and analyzing blood and buccal samples and for storing and destroying blood and buccal samples and other physical evidence 10

and criminal identification information obtained from such analysis. Procedures for blood and buccal analyses may include all techniques which the department determines are accurate and reliable in establishing identity, including but not limited to, analysis of DNA (deoxyribonucleic acid), antigen antibodies, polymorphic enzymes or polymorphic proteins.

(2) If the department is unable to analyze all samples due to lack of funds, the department shallanalyze samples in the following order:

(3) Notwithstanding subsection (2) of this section, the department may analyze a sample from a
lower priority before all samples in higher priorities are analyzed if required in a particular case
for law enforcement purposes.

42 (4) The department may not transfer or disclose any sample, physical evidence or criminal
43 identification information obtained, stored or maintained under authority of this section, ORS
44 137.076, 161.325 or 419C.473 (1) except:

45 (a) To a law enforcement agency as defined in ORS 181.010, a district attorney or the Criminal

1 Justice Division of the Department of Justice for the purpose of establishing the identity of a person

(b) Upon receipt of a written request for destruction pursuant to this section and a certified 2930 copy of the court order reversing the conviction, judgment or order, the department shall destroy 31 any sample received from the person, any physical evidence obtained from that sample and any 32criminal identification records pertaining to the person, unless the department determines that the person has otherwise become obligated to submit a blood or buccal sample as a result of a separate 33 34 conviction, juvenile adjudication or finding of guilty except for insanity for an offense listed in ORS 137.076 (1). (c) The department is not required to destroy an item of physical evidence obtained from a blood

161.325, 181.085, 419A.260 and 419C.473 (1) would thereby be destroyed. Notwithstanding this subsection, no sample, physical evidence or criminal identification record is affected by an order to set
aside a conviction under ORS 137.225.
