SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies qualifications for certain members of Council on Naturopathic Physicians Formulary.

A BILL FOR AN ACT

Relating to qualifications for members of Council on Naturopathic Physicians Formulary; creating
 new provisions; and amending ORS 685.145.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 685.145 is amended to read:

6 685.145. (1) The Council on Naturopathic Physicians Formulary is established and shall consist 7 of seven members appointed as follows:

8 (a) One member of the Board of Naturopathic Examiners appointed by the Board of 9 Naturopathic Examiners;

(b) One physician licensed by the Board of Naturopathic Examiners appointed by the Board of
 Naturopathic Examiners;

(c) Two pharmacists licensed by the State Board of Pharmacy appointed by the State Board ofPharmacy;

(d) One physician licensed by the Board of Medical Examiners for the State of Oregon appointed
 by the Board of Medical Examiners for the State of Oregon; and

(e) Two additional members appointed by the council who hold an advanced degree in [either
 pharmacology or pharmacognosy] a medical or pharmaceutical science.

(2) The chair of the council shall be elected by a majority of the members.

19 (3) The council established under subsection (1) of this section shall determine the substances 20 to be included in the formulary that may be prescribed by a naturopathic physician acting under 21ORS 685.010 (3). The council shall review the formulary periodically. Immediately upon adoption or 22revision of the formulary, the council shall transmit the approved formulary to the board which must 23adopt the formulary by rule. When determined to be appropriate to the scope of practice of 24 naturopathic physicians, the Council on Naturopathic Physicians Formulary may also consider syn-25thetically produced substances and their salts having an identical or substantially identical molec-26 ular structure to a plant or animal substance as found in nature to be plant or animal substances.

(4) The term of each member of the council shall be two years. A member shall serve until a
successor is appointed. If a vacancy occurs, it shall be filled for the unexpired term by a person with
the same qualifications as a retiring member.

30 (5) Any member of the council who fails to attend two consecutive meetings of the council 31 whether regular or special shall forfeit office unless a member is prevented from attending by seri-

1 ous illness of the council member or a member of the council member's family.

2 (6) Members of the council shall be entitled to compensation and expenses under ORS 292.495 3 payable from funds available to the Board of Naturopathic Examiners.

<u>SECTION 2.</u> Nothing in the amendments to ORS 685.145 by section 1 of this 2007 Act affects the term of office of any member of the Council on Naturopathic Physicians Formulary appointed prior to and serving on the effective date of this 2007 Act. However, as vacancies occur, appointments shall be made in accordance with the qualifications specified in ORS 685.145, as amended by section 1 of this 2007 Act.
