SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies administrative provisions for economic and community development. Revises economic and community development programs.

[Establishes Community Investment Fund. Continuously appropriates moneys from fund to Economic and Community Development Department. Establishes Innovation Acceleration Fund. Continuously appropriates moneys from fund to department for specified purposes.]

Eliminates statutory references to Ports Division and International Trade Commission. Establishes Industry Outreach Fund. Continuously appropriates moneys in fund to Economic and Community Development Department for specified purposes.

Declares emergency, effective on passage.

17 **Be It Enacted by the People of the State of Oregon:**

18 **SECTION 1.** ORS 285A.010 is amended to read:

19 285A.010. As used in ORS chapters 285A, 285B and 285C, unless the context requires otherwise:

20 (1) "Commission" means the Oregon Economic and Community Development Commission.

21 (2) "Community" means an area or locality in which the body of inhabitants has common eco-
22 nomic or employment interests. The term is not limited to a city, county or other political subdivi-
23 sion and need not, but may be, limited by political boundaries.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (3) "Department" means the Economic and Community Development Department.

2 (4) "Director" means the Director of the Economic and Community Development Department.

3 (5) "Distressed area" means a county, city, community or other geographic area that is desig-
4 nated as a distressed area by the department, based on indicators of economic distress or dislo-
5 cation, including but not limited to unemployment, poverty and job loss.

6 (6) "International trade" means the export and import of products and services and the move-
7 ment of capital for the purpose of investment.

8 (7) "Rural area" means an area located entirely outside of the acknowledged Portland Metro-
9 politan Area Regional Urban Growth Boundary and the acknowledged urban growth boundaries of
10 [the] cities **with populations** of 30,000 or more [*in population, including Albany, Bend, Corvallis,*
11 *Eugene, Springfield, Salem, Keizer or Medford*].

12 [(8) "Rural community" means a community located in a rural area.]

13 [(9)] (8) "Traded sector" means industries in which member firms sell their goods or services
14 into markets for which national or international competition exists.

15 (9) "Small business" means a business having 100 or fewer employees.

16 **SECTION 2.** ORS 285A.020 is amended to read:

17 285A.020. (1) The Legislative Assembly finds that:

18 [(a) *Oregon's economy continues to experience change and adjustment that greatly affect the well-*
19 *being of its citizens.*]

20 [(b) *The state has a need for continuing economic development to help provide the jobs for its citi-*
21 *zens that lead to community vitality and a high quality of life.*]

22 [(2) *The Legislative Assembly further finds that:*]

23 [(a) *Oregon's human resources constitute a major asset in the state's effort to promote economic*
24 *expansion and improvement.*]

25 [(b) *Oregon's natural resources provide ample opportunities for productive and beneficial economic*
26 *enterprise.*]

27 [(c) *Oregon's location on the growing economy of the Pacific Rim provides substantial opportunities*
28 *and challenges in international trade.*]

29 [(d) *Oregon's special heritage, its respect for and cultivation of its environment and its quality of*
30 *life are a unique and sustaining virtue that will both guide and assist in maintaining the state's eco-*
31 *nomical health.*]

32 (a) **Oregon possesses many unique and sustaining virtues that will guide and assist in**
33 **maintaining the state's economic health, including but not limited to Oregon's:**

34 (A) **Special heritage;**

35 (B) **Respect for and cultivation of the environment; and**

36 (C) **Attention to quality of life issues that are important to the state's economic devel-**
37 **opment, including but not limited to access to quality, affordable child care for all children**
38 **in Oregon.**

39 (b) **Oregon is strategically placed to compete and succeed in the global community.**

40 (c) **All regions of the state should share in Oregon's economic recovery.**

41 (d) **Creating and retaining quality jobs is vital to the state's continued economic devel-**
42 **opment.**

43 (e) **Oregon's agriculture and natural resource industries provide opportunities for bene-**
44 **ficial economic enterprise, including sustainable economic development activities.**

45 (f) **A well educated and trained workforce is necessary to advance in today's global**

1 **economy.**

2 (g) **The ability of existing businesses to grow and prosper is critical to Oregon's economy.**

3 (h) **Utilizing the state's competitive advantages is essential to retain existing businesses**
4 **and attract new companies and investment into the state.**

5 (i) **Continued economic development depends on strengthening traded sector industries.**

6 (j) **International trade development and promotion is invaluable for future economic de-**
7 **velopment opportunities.**

8 (k) **Small businesses remain a critical element of the state's economic development,**
9 **comprising more than 90 percent of Oregon's businesses.**

10 (L) **Capacity building in rural and distressed areas is a key component of economic de-**
11 **velopment and revitalization efforts.**

12 (m) **Oregon's ports are important partners in the state's economic development efforts**
13 **and are key components of local and state economic development strategies.**

14 (n) **Improving and enhancing infrastructure is necessary to the state's future economic**
15 **development.**

16 (o) **Federal, state and local agencies working together will continue to enhance industrial**
17 **site development and other economic development activities.**

18 (p) **The Economic and Community Development Department should be encouraged to**
19 **convene community development partners to explore the prospect of making loans to private**
20 **industrial landowners from the Brownfields Redevelopment Fund for future development**
21 **opportunities.**

22 [(3)] (2) *It is the purpose of ORS chapters 285A, 285B and 285C to [promote the improvement of*
23 *Oregon's economy to better provide for the well-being of its citizens]* **advance Oregon's economy.**

24 (3) **The Legislative Assembly declares that it is the immediate economic strategy of the**
25 **state to:**

26 (a) **Promote a favorable investment climate to strengthen businesses, create jobs and**
27 **raise real wages;**

28 (b) **Improve the national and global competitiveness of Oregon companies; and**

29 (c) **Assist Oregon communities in building capacity to retain, expand and attract busi-**
30 **nesses.**

31 (4) To [*that end*] **promote the advancement of the Oregon economy and implement the**
32 **immediate economic strategy of the state**, the Economic and Community Development Depart-
33 ment shall invest resources in accordance with the following principles:

34 (a) [*Structures and processes for making public investments and dealing with local and regional*]
35 **Processes for making public investments and working with local and regional** issues must be
36 designed [*flexibly*] **for flexibility** so that actions can adapt to the constantly changing conditions and
37 demands under which communities and businesses operate.

38 [(b) *Partnerships among local, state and federal, public and private players should be used to set*
39 *direction, develop projects and set priorities.*]

40 (b) **Partnerships among local, state and federal governments and public and private or-**
41 **ganizations and entities should be strengthened to further the economic strategy of the**
42 **state.**

43 (c) The expected impact of public [*investments at all levels should be explicitly*] **investment and**
44 **assistance shall be identified**, in terms of measurable outcomes, whenever possible.

45 (d) State, federal and community goals, constraints and obligations should be identified at the

1 beginning of the [*public investment*] planning process, and the state should work actively with [*com-*
2 *munities and regions to*] **community partners, regions and state and local agencies to address**
3 **and** accomplish their mutual objectives.

4 [(4) *The Legislative Assembly declares that it is the immediate economic strategy of the state to:*]

5 [(a) *Focus on Oregonians in communities that are rural, economically distressed or lack diverse*
6 *employment opportunities, including providing assistance in recruiting jobs from outside the community*
7 *or state and financing necessary infrastructure;*]

8 [(b) *Assist Oregonians who are underemployed or in low income jobs;*]

9 [(c) *Assist start-up companies and companies already doing business in Oregon;*]

10 [(d) *Help regions that are committed to making strong progress toward an integrated structure and*
11 *process for strategic planning and project development; and*]

12 [(e) *Focus on strategies and investments that maximize the economic benefit to the state of the*
13 *global shift to an information, science and technology driven economy and on industries and companies*
14 *that make significant use of the high-capacity telecommunications, science and technology-related man-*
15 *ufacturing processes or knowledge transfer typical of these emerging economic sectors.*]

16 **(5) When the department provides funds or assistance for projects, programs, technical**
17 **support or other authorized activities pursuant to ORS 329.905 to 329.975 and ORS chapters**
18 **285A, 285B and 285C, the department shall give priority to projects, programs and activities**
19 **that:**

20 **(a) Retain and create jobs and raise real wages;**

21 **(b) Promote capacity building, emphasizing rural and distressed areas;**

22 **(c) Assist small business creation and expansion;**

23 **(d) Invest and engage in training a skilled workforce;**

24 **(e) Retain and expand existing companies and recruit new investment to Oregon;**

25 **(f) Capitalize on Oregon's competitive advantages and strategically invest resources to**
26 **offset competitive disadvantages;**

27 **(g) Support innovation and research;**

28 **(h) Assist industry clusters to succeed;**

29 **(i) Market Oregon's advantages;**

30 **(j) Promote international trade and attract foreign direct investment;**

31 **(k) Support the development of industrial and commercial lands;**

32 **(L) Advance the efforts of ports to promote economic development activities; and**

33 **(m) Build capacity in Oregon's arts and cultural organizations, creative businesses and**
34 **individual artists.**

35 **SECTION 3.** ORS 285A.040 is amended to read:

36 285A.040. (1) There is established the Oregon Economic and Community Development Commis-
37 sion consisting of [*seven*] **nine** members appointed as follows:

38 (a) One nonvoting, ex officio member appointed from among the members of the Senate by the
39 President of the Senate;

40 (b) One nonvoting, ex officio member appointed from among the members of the House of Rep-
41 resentatives by the Speaker of the House of Representatives; and

42 (c) [*Five*] **Seven** members appointed by the Governor, subject to confirmation by the Senate in
43 the manner prescribed in ORS 171.562 and 171.565. The Governor shall appoint members of the
44 commission in compliance with all of the following:

45 (A) Members shall be appointed with [*due*] consideration given to representation of the different

1 geographic regions of the state, and at least one member shall be a resident of the area east of the
2 Cascade Range.

3 (B) Not more than *[three]* **five** members *[shall]* **may** belong to one political party. Party affil-
4 iation shall be determined by the appropriate entry on official election registration cards.

5 (C) *[At least one member shall be an individual with substantial experience or training in inter-*
6 *national trade or an individual who, at the time of appointment, is involved in international trade. The*
7 *member's experience or involvement in international trade may include importing or exporting goods*
8 *into or from the State of Oregon.]* **Members shall be appointed with consideration given to rep-**
9 **resentation of the following areas of expertise or training:**

10 (i) **International trade;**

11 (ii) **Small business needs and issues;**

12 (iii) **Local government needs and issues;**

13 (iv) **Marketing and branding;**

14 (v) **Arts and culture;**

15 (vi) **Finance;**

16 (vii) **Innovation;**

17 (viii) **Telecommunications; or**

18 (ix) **Other areas of training or expertise identified by the commission.**

19 (2)(a) The term of office of each member appointed by the Governor is four years, but a member
20 serves at the pleasure of the Governor. Before the expiration of the term of a member appointed by
21 the Governor, the Governor shall appoint a successor whose term begins on July 1 *[next following]*
22 **of the following year.** A member appointed by the Governor is eligible for reappointment. In case
23 of a vacancy among the members appointed by the Governor for any cause, the Governor shall ap-
24 point a person to fill the office for the unexpired term.

25 (b) The term of office of the member appointed by the President of the Senate is four years. In
26 case of a vacancy for any cause, the President of the Senate shall appoint a Senator to fill the office
27 for the unexpired term.

28 (c) The term of office of the member appointed by the Speaker of the House of Representatives
29 is two years. In case of a vacancy for any cause, the Speaker of the House of Representatives shall
30 appoint a Representative to fill the office for the unexpired term.

31 (3) A member of the commission who is appointed by the Governor is entitled to compensation
32 and expenses as provided by ORS 292.495. **Ex officio members of the commission are prohibited**
33 **from receiving compensation and reimbursement for expenses.**

34 (4) **Subject to confirmation by the Senate,** the Governor shall appoint one of the voting
35 commissioners as presiding officer of the commission. The presiding officer shall have duties and
36 powers as the commission determines are necessary for the office.

37 (5) *[Three]* **Five** voting members of the commission constitute a quorum for the transaction of
38 business.

39 (6) The commission shall meet at least quarterly at a time and place determined by the com-
40 mission. The commission shall also meet at *[such]* other times and places as are specified by the call
41 of the presiding officer or **by the call** of a majority of the voting members of the commission.

42 (7) A vacancy among the voting members of the commission does not impair the right of the
43 remaining voting commissioners to exercise all the powers of the commission. If the remaining vot-
44 ing commissioners are unable to agree, the Governor shall have the right to vote as a member of
45 the commission.

SECTION 4. ORS 285A.045 is amended to read:

285A.045. (1) As its primary duty, the Oregon Economic and Community Development Commission shall develop and maintain an economic and community development policy for this state that implements the strategy declared in ORS 285A.020 [(4)] **(3)**. *[and that includes policies that:]*

[(a) Maintain and create jobs that raise real wage levels of Oregon workers.]

[(b) Increase the skill levels of the Oregon workforce.]

[(c) Improve the competitiveness of this state's traded sector industries, including industries characterized by significant use of high-capacity telecommunications, science and technology-related manufacturing processes or knowledge transfer, and achieve benchmarks for those industries established by the Oregon Progress Board.]

[(d) Invest public moneys in a manner that produces the greatest possible return on investment.]

[(e) Support statewide and regional strategies to develop and maintain the infrastructure necessary to support and strengthen the economy of this state.]

[(f) Identify and eliminate barriers that impede the competitiveness of Oregon businesses.]

[(g) Encourage expansion of existing Oregon businesses and the attraction of new business and industry to those communities that desire such development, with particular attention to industries characterized by significant use of high-capacity telecommunications, science and technology-related manufacturing processes or knowledge transfer.]

[(h) Encourage investment in infrastructure projects, including electronic, communications and financial resource projects, that benefit Internet-based entities and employees and encourage the entities and employees to relocate to or remain in Oregon.]

[(i) Assist in the development of microenterprise businesses in Oregon, including increasing the availability of training and technical assistance available to serve microenterprises.]

[(2) It is the function of the Oregon Economic and Community Development Commission to establish the policies for economic and community development in this state in a manner consistent with the policies and purposes set forth in this section and ORS 285A.050. In addition, the commission shall perform any other duty vested in it by law.]

(2) The commission shall provide oversight and direction to the Economic and Community Development Department in carrying out the duties and creating policies to further the economic strategy set forth in ORS 285A.020. In addition, the commission may perform any other duty vested in the commission by law.

(3) The commission shall keep complete and accurate records of all the meetings, transactions and business of the commission at the office of the Economic and Community Development Department.

(4) When a power, duty or function is vested in the commission, the commission may designate department officers, agents, employees or committee members to exercise the power, duty or function of the commission. When the commission designates a person in writing to exercise a power, duty or function of the commission, the person may exercise the power, duty or function.

[(4) The commission shall set policy for and monitor programs relating to economic development and rural and community development and such other programs related to economic and community development that may be assigned by law to the department.]

(5) In carrying out its duties under subsection (1) of this section, the commission shall[:]

[(a) Place priority on those policies that achieve benchmarks established by the Oregon Progress Board; and]

1 *[(b) Coordinate its activities with the policies of the Education and Workforce Policy Advisor and*
2 *the policymaking bodies of the Housing and Community Services Department, the Department of*
3 *Transportation, the Department of Environmental Quality, the Department of Land Conservation and*
4 *Development and the Employment Department, as well as other appropriate state and federal*
5 *agencies.]* **coordinate its activities with federal, state and local agencies, community partners**
6 **and regions, when appropriate.**

7 **SECTION 5.** ORS 285A.050 is amended to read:

8 285A.050. (1) The Oregon Economic and Community Development Commission shall report [*an-*
9 *nually*] **biennially** to the Governor and the Legislative Assembly on the success of economic devel-
10 opment efforts. The report[,] **shall include the progress toward achievement of performance**
11 **measures for the Economic and Community Development Department as adopted by the**
12 **Legislative Assembly.** At a minimum, **the report** shall include the following:

13 (a) For the overall Economic and Community Development Department [*effort*] and for each
14 identifiable program and [*significant project or service*] **funding source:**

15 [(A) *The impact of that program on the competitiveness of traded sector industries and the skill*
16 *levels of the Oregon workforce;*]

17 [(B)] (A) The [*impact on the*] number of jobs[, *including jobs*] created and retained;

18 [(C)] (B) The [*impact on the*] **average** wage levels of [*Oregon workers, including increases in*
19 *wage levels*] **jobs created and retained; and**

20 [(D)] (C) [*The actual or anticipated impact of public investments at all levels, in terms of measur-*
21 *able outcomes wherever possible; and*] **Other measures identified by the commission.**

22 [(E) *The impact of that program on the Internet-based entities and employees in Oregon.*]

23 (b) The status of the Oregon economy [*related to:*] **as it relates to the economic strategy**
24 **outlined in ORS 285A.020.**

25 [(A) *Changes in employment and wage levels in Oregon industries;*]

26 [(B) *Changes in employment, wage levels and competitiveness of traded sector industries; and*]

27 [(C) *Barriers that have been identified as impeding business competitiveness and productivity in*
28 *this state.*]

29 [(c) *Progress made toward achievement of the Oregon Benchmarks.*]

30 [(d) *Recommendations for removing identified barriers and additional suggestions for improving*
31 *the performance of Oregon's economy.*]

32 [(e) *Recommendations on this state's investment in its public ports, on this state's response to policy*
33 *issues that affect ports and for the strategic development of port facilities that promote maritime com-*
34 *merce, recreational opportunities and the economy of Oregon.*]

35 [(f) *Progress made toward elimination of economically distressed areas of this state.*]

36 [(g) *Recommendations regarding improving the international competitiveness of Oregon.*]

37 [(h) *Progress made in serving microenterprise businesses and recommendations for increasing the*
38 *success of microenterprises.*]

39 **(c) Other issues identified by the commission.**

40 [(2) *Whenever a power is granted to the commission, the power may be exercised by such officers,*
41 *employees or commission-appointed committees as are designated in writing by the commission.*]

42 [(3)] (2) Reports to the Legislative Assembly required under this section shall be made in ac-
43 cordance with ORS 192.245.

44 **SECTION 6.** ORS 285A.055 is amended to read:

45 285A.055. Prior to the approval of bond financing of economic development projects under ORS

1 285B.320 to 285B.371, the making of a loan under ORS 285A.666 to 285A.732 or the making of any
2 loan or the granting of any moneys from any source, the Oregon Economic and Community Devel-
3 opment Commission, **or the Economic and Community Development Department as the**
4 **designee of the commission**, shall:

5 (1) Determine that the action is cost effective, considering both major public expenses and major
6 public benefits;

7 (2) Find that the project will produce goods or services which are sold in markets for which
8 national or international competition exists or, if the project is to be constructed and operated by
9 a nonprofit organization, that the project will not compete with local for-profit businesses;

10 (3) Determine that the action is the best use of the moneys involved, considering other pending
11 applications for those moneys;

12 (4) Find that the project involved is consistent with the Economic and Community Development
13 Department's comprehensive policy and programs; **and**

14 (5) Find that the project involved is consistent with applicable adopted local economic develop-
15 ment plans[; *and*].

16 [(6) *Provide for public notice of, and public comment on, the action.*]

17 **SECTION 7.** ORS 285A.070 is amended to read:

18 285A.070. (1) The Economic and Community Development Department is [*continued, but reor-*
19 *ganized as provided in this section*] **established.**

20 [(2) *The Economic and Community Development Department shall be organized by the Director of*
21 *the Economic and Community Development Department in whatever manner the director considers*
22 *necessary to conduct the work of the department efficiently and effectively, subject to approval by the*
23 *Oregon Economic and Community Development Commission.*]

24 [(3)] (2) The department shall be under the supervision of the Director **of the Economic and**
25 **Community Development Department**, who shall be appointed by and shall hold office at the
26 pleasure of the Governor.

27 [(4)] (3) The appointment of the director shall be subject to confirmation by the Senate in the
28 manner provided by ORS 171.562 and 171.565.

29 (4) **Subject to policy direction by the Oregon Economic and Community Development**
30 **Commission, the director shall:**

31 (a) **Be the administrative head of the department;**

32 (b) **Administer the laws of the state relating to economic development; and**

33 (c) **Intervene, as authorized by the commission, pursuant to the rules of practice and**
34 **procedure, in the proceedings of state and federal agencies that may substantially affect**
35 **economic development within Oregon.**

36 (5) **In addition to duties otherwise required by law, and subject to policy direction by the**
37 **commission, the director shall prescribe rules for the government of the department, the**
38 **conduct of its employees, the assignment and performance of its business and the custody,**
39 **use and preservation of its records, papers and property, based on best managerial practices**
40 **as determined by the director and in a manner consistent with applicable law.**

41 (6) **The director shall organize the department in whatever manner the director considers**
42 **necessary to conduct the work of the department efficiently and effectively, subject to ap-**
43 **proval by the commission.**

44 [(5)] (7) The director may appoint all subordinate officers and employees of the department and
45 may prescribe their duties, assignments and reassignments and fix their compensation, subject to

1 any applicable provisions of the State Personnel Relations Law. Subject to any other applicable law
2 regulating travel expenses, the officers and employees of the department shall be allowed such rea-
3 sonable and necessary travel and other expenses as may be incurred in the performance of their
4 duties.

5 **(8) The director may delegate the exercise or discharge of any power, duty or function**
6 **that is vested in or imposed by law upon the director to any department employee for the**
7 **purpose of conducting an official act in the name of the director. The official act of any**
8 **person acting in the name of the director by the authority of the director is an official act**
9 **of the director.**

10 **(9) The director may require a fidelity bond of any officer or employee of the department**
11 **who has charge of, handles or has access to any state money or property, and who is not**
12 **otherwise required by law to give a bond. The director shall fix the amount of the bond, ex-**
13 **cept as otherwise provided by law, and approve the sureties. The department shall pay the**
14 **premiums on the bond.**

15 [(6)] **(10) The Oregon Economic and Community Development Commission shall report period-**
16 **ically to the Governor on the director's performance and make appropriate recommendations.**

17 **SECTION 8.** ORS 285A.075 is amended to read:

18 285A.075. *[(1) The Economic and Community Development Department, through research, pro-*
19 *motion and coordination of activities in this state, shall foster the most desirable growth and ge-*
20 *ographical distribution of agriculture, industry and commerce in the state. The department shall serve*

35 **(e) Actively recruit domestic and international business firms to those communities de-**
36 **siring business recruitment.**

37 **(f) Consult with local governments to establish regions for the purpose of job develop-**
38 **ment and community assistance to facilitate economic activities in the region. Regions es-**
39 **tablished for this purpose need not be of the same size in geographic area or population.**

40 **(g) Establish and operate foreign trade offices in foreign countries in which the depart-**
41 **ment considers a foreign trade office necessary. The department shall use department em-**
42 **ployees, contracts with public or private persons or a combination of employees and**
43 **contractors to establish and operate foreign trade offices. Department employees, including**
44 **managers, who are assigned to work in a foreign trade office shall be in the unclassified**

7 (i) Budget moneys for travel and various other expenses of industrial or commercial site
8 location agents, film or video production location agents, business journal writers, elected
9 state officials or other state personnel to accomplish the purposes of ORS 329.905 to 329.975
10 and ORS chapters 285A, 285B and 285C. The department may expend moneys duly budgeted
11 to pay the travel and other expenses of such persons if the director determines the expense
12 may promote the purposes of this subsection.

13 (j) Promulgate rules to govern contracts.

14 (k) Develop strategies to address issues that are necessary and appropriate to Oregon's
15 future and adopt goals that include measurable indicators of success (Oregon benchmarks)
16 that show the extent to which each goal is being achieved.

17 (L) Use practices and procedures that the department determines are the best practices
18 for carrying out the duties of the department.

19 (2) The department shall have no regulatory power over the activities of private persons. Its
20 functions shall be solely advisory, coordinative and promotional.

34 [(7)] (3) Notwithstanding ORS 279A.140, the department may **award grants or** enter into con-
35 tracts [*for personal services*] as necessary or appropriate to carry out the duties, functions and
36 powers vested in the department by law.

37 [(8)(a) *The department may contract directly with the Oregon Downtown Development Association,*
38 *or its successor entity, to provide downtown development and redevelopment assistance and similar*
39 *services to municipalities in Oregon.*]

40 [(b) *The department may contract directly with Rural Development Initiatives, or its successor en-*
41 *tity, to provide training, technical assistance, planning assistance and other support and services to*
42 *municipalities in Oregon to build economic and community development capacity.*]

43 [(c) *Contracts entered into under this subsection are exempt from the requirements of ORS 279.835*
44 *to 279.855 and ORS chapters 279A, 279B and 279C.*]

45 [(9) *If the director determines that moneys are available, the department may transfer funds from*

1 *the Special Public Works Fund created under ORS 285B.455 or from the Water Fund established un-*
2 *der ORS 285B.563 to a state agency to provide financial assistance in the delivery of technical assist-*
3 *ance or other services to one or more water systems for evaluation of water quality or services or for*
4 *planning the improvement of water quality or services. The department may structure the financial as-*
5 *sistance under this subsection in the form of an interagency grant or loan or in any other manner the*
6 *director considers necessary or appropriate.]*

2 fund. The moneys in the Oregon Community Development Fund are continuously appropriated to the
3 Economic and Community Development Department to promote economic and community develop-
4 ment.

5 (2) The Oregon Economic and Community Development Commission, by rule, shall adopt stan-
6 dards, objectives and criteria for use of the moneys in the Oregon Community Development Fund.

10 **SECTION 11.** ORS 285A.188 is amended to read:

11 285A.188. (1) As used in this section:

12 (a) "Environmental action" means activities undertaken to:

13 (A) Determine if a release has occurred[,], **or may occur**, if the release **or potential release**
14 poses a significant threat to human health or the environment or if additional remedial actions may
15 be required at the site;

16 (B) Conduct a **remedial investigation and a** feasibility study;

17 (C) Plan for remedial action or removal **action**; or

18 (D) Conduct a remedial action or removal **action** at a site.

20 meanings given those terms in ORS 465.200.

21 (c) "Substantial public benefit" includes, but is not limited to:

24 (B) A commitment to perform substantial remedial action at a facility in accordance with this
25 section;

26 (C) Productive reuse of a vacant or abandoned industrial or commercial facility; or

27 (D) Development of a facility by a municipality or a nonprofit organization to address an im-
28 portant public purpose.

29 (2) There is created within the State Treasury a revolving fund known as the Brownfields Re-
30 development Fund, separate and distinct from the General Fund. Interest earned by the fund shall
31 be credited to the fund. Moneys in the Brownfields Redevelopment Fund shall be used to fund loans
32 and grants for environmental actions on properties that are brownfields, as defined in ORS 285A.185.

33 (3)(a) Subject to paragraph (b) of this subsection, when making a loan or grant for an environ-
34 mental action, the Economic and Community Development Department shall give priority to persons
35 who, at the time of applying for the loan or grant, are not liable under ORS 465.255 for a release

41 ingly violated or failed to comply with an order of the Department of Environmental Quality, if such

43 (A) Contribution to or exacerbation of existing contamination at the facility;

44 (B) Release of a hazardous substance at the facility; or

45 (C) Interference with necessary investigation or remedial actions at the facility.

1 (b) Notwithstanding paragraph (a) of this subsection:

2 (A) When making a grant to a municipality, the department shall give priority to municipalities
3 that provide matching funds from a loan under this section, from another source or from both.

4 (B) When making a grant to an entity that is not a municipality, the department shall require
5 that:

6 (i) The recipient is not liable for the subject property under ORS 465.255;

7 (ii) The environmental action provides a substantial public benefit; and

8 (iii) The recipient provides matching funds from a loan under this section, from another source
9 or from both.

10 (c) The department may establish by rule circumstances in which the department may waive or
11 subsidize the interest on a short-term loan.

12 (4) When making a loan or grant for an environmental action, the Economic and Community
13 Development Department shall consider:

14 (a) The extent to which actual or perceived contamination prevents the property from being
15 fully utilized;

16 (b) The need for providing public assistance, after considering the difficulty of obtaining fi-
17 nancing from other sources or of obtaining financing at reasonable rates and terms;

18 (c) The degree to which redevelopment of the property provides opportunity for achieving pro-
19 tection of human health or the environment by reducing or eliminating the contamination of the
20 property and for contributing to the economic health and diversity of the area;

21 (d) The probability of the success of the intended use or the degree to which redevelopment of
22 the property provides a public purpose following remediation of the property;

23 (e) Compliance with the land use plan of the local government with jurisdiction over the prop-
24 erty; and

25 (f) Endorsement from the local government with jurisdiction over the property.

26 (5) Before making a loan or grant decision pursuant to this section, the Economic and Commu-
27 nity Development Department shall consult with the Department of Environmental Quality.

28 (6) The Economic and Community Development Department may use a portion of the
29 Brownfields Redevelopment Fund to:

30 (a) Pay for administrative costs of environmental actions; and

31 (b) Satisfy contracts entered into as required to ensure that environmental reviews are con-

43 *economic consequences for many communities and workers.] It is the purpose of the [*Economic Sta-*
44 *bilization and Conversion*] **Business Retention** Fund to assist **businesses**, communities and workers

3 (2) The [*Economic Stabilization and Conversion*] **Business Retention** Fund is created separate

5 Development Department. The fund may be credited with contributions of moneys from public and
6 private sources and with repayments as provided in this section. Interest earned by the fund shall
7 be credited to the fund.

8 (3)(a) The [*Economic and Community Development*] department may allocate moneys in the fund
9 for the following purposes:

- 10 (A) Business retention service;
- 11 (B) Employee ownership;
- 12 (C) Community response to plant closures or community distress, or both; and
- 13 (D) Feasibility studies, **transition plans or restructuring plans.**

14 (b) The department shall establish the maximum percentage of the fund that may be allocated
15 for the purposes described in paragraph (a) of this subsection and a minimum match requirement,
16 if any.

17 (4) The [*Economic and Community Development*] department may grant, expend or loan moneys
18 in the fund for financial assistance, feasibility studies, **transition plans, restructuring plans,**
19 technical assistance and management consulting services for **business firms in transition,** troubled
20 firms that may close without assistance, for troubled firms that are experiencing major layoffs or
21 firms that have actually closed or announced closure, and for communities that are experiencing
22 distress due to the business closures [*and for the purpose of encouraging employee ownership*], under
23 such terms and conditions as the department may determine.

25 assistance repay to the [*Economic Stabilization and Conversion*] **Business Retention** Fund any as-

27 **department sets repayment terms for a firm receiving assistance, the department** shall con-
28 sider the financial ability of the firm to repay assistance.

29 (6) In providing assistance from the [*Economic Stabilization and Conversion*] **Business Re-**
30 **tenion** Fund, the department [*shall*] **may** give preference to Oregon's **rural and** distressed areas
31 and its traditional agriculture, forestry and fishing industries[, *and*]. **The department may also**
32 **give priority to areas including but not limited to emerging industries and industry clusters**
33 **with high potential for job retention and creation and market growth, as well as traded sec-**
34 **tor** firms competing in markets for which **regional,** national or international competition exists.

36 expenditure of funds from the [*Economic Stabilization and Conversion*] **Business Retention** Fund

30 expansion of small businesses in Oregon.

33 assistance services from public or private organizations for delivery to small businesses in this state
34 or may provide grants to public or private organizations to support, aid, stimulate or otherwise af-

29 [(a) *It is in the state’s interest to help small businesses develop and improve skills in such areas*
30 *as marketing, management and capital formation through a network of small business development*
31 *centers;*]

32 [(b) *Small business employers create most of the new jobs in Oregon and are vital to Oregon’s long*

17 (d) Other costs related to providing training, counseling and business resources to small busi-

20 to provide funds, in-kind contributions or some combination of funds and contributions, in accord-

24 under this paragraph shall be payable solely from moneys in the Special Public Works Fund, and

38 each region, including but not limited to:

4 or personal property, including contracts for rental, long term leases under an optional contract for
5 purchase, financing agreements with vendors, financial institutions or others or for purchase of any

38 annexation or change of employment or April 8, 1953, the member shall by written notice to the
39 Public Employees Retirement Board and to the administrative body of the new public employer elect
40 to relinquish membership in the Public Employees Retirement System and become a member of the
41 separate retirement system of the employer, if eligible for membership in that retirement system, and
42 the member shall be so carried by the new employer. Immediately upon such annexation of any
43 political subdivision or such change of employment, the new public employer shall inform such em-
44 ployee in writing of the right of the employee to exercise an election as in this section provided.

45 (3) A political subdivision (other than a school district) not participating in the retirement sys-

1 tem established by chapter 401, Oregon Laws 1945, as amended, which employs one or more em-
2 ployees, each of whose position requires 600 hours of service per year, or an agency created by two

9 completion of the study and estimate the employer may apply for admission to the system, where-
10 upon it shall begin to participate therein and its eligible employees other than volunteer firefighters
11 shall become members of the system. If the employer is an agency created by two or more political
12 subdivisions to provide themselves governmental services and ceases thereafter to transmit to the
13 board contributions for any of its eligible employees, the benefits based upon employer contributions
14 to which such employees would otherwise be entitled shall be reduced accordingly.

15 (4) No inmate of a state institution or an alien on a training or educational visa working for
16 any participating employer, even though the inmate or alien received compensation from a partic-
17 ipating employer, shall be eligible to become a member of the system. No person employed by a
18 participating employer and defined by such employer as a student employee is eligible to become a

39 Public Employees Retirement Fund, and, if no public funds are being used to purchase the annuity
40 or a corresponding pension, the employer, in lieu of the contributions which it otherwise would
41 make to the fund on account of the employee, may make contributions toward the cost of purchasing
42 the annuity. Such employee otherwise shall be subject to the provisions of this chapter, except that
43 neither the employee nor any person claiming under the employee shall receive any payments from
44 the retirement fund as service or disability allowance.

45 (b) An employee who enters into an agreement under paragraph (a) of this subsection may elect

1 at any time thereafter to start to participate in the system by giving written notice of desire to
 2 participate to the board and to the employer. The employee shall receive no retirement credit for
 3 the period during which the employee was exempted from contributing to the fund under the
 4 agreement, but the employee shall be considered to have completed the six months' service required
 5 for membership in the system. When the employee starts to participate in the system the employer
 6 shall start to contribute to the fund on account of the employee in the same manner as the employer
 7 contributes on account of other employees who are active members of the system and the employer
 8 shall stop making contributions toward the cost of purchasing the retirement annuity.

18 (i) Any employee who belongs to a class of employees that was not eligible on August 28, 2003,
19 for membership in the system under the provisions of ORS chapter 238 or other law;

20 (j) Any person who belongs to a class of employees who are not eligible to become members of
21 the Oregon Public Service Retirement Plan under the provisions of ORS 238A.070 (2);

37 (b) To fund Oregon's share of the costs of the Columbia River channel deepening project.

38 (c) To fund Oregon's share of the costs of studies and ecosystem restoration projects in the
39 lower Columbia River estuary designed to improve habitat for listed endangered or threatened spe-
40 cies of Columbia River anadromous salmonids.

41 (2) The use of lottery bond proceeds is authorized based on the following findings:

42 (a) The financial and other assistance to municipalities, ports and other persons and entities
43 will assist in the establishment and expansion of businesses in Oregon and in the construction, im-
44 provement and expansion of infrastructure, community and port facilities and other facilities that
45 comprise the physical foundation for industrial and commercial activity and provide the basic

34 Oregon's ports in planning and implementing transportation programs. To that end, the Department
35 of Transportation and the Oregon Department of Aviation may work to:

36 (a) Coordinate with the Economic and Community Development Department [*and the Ports Di-*
37 *vision*] to facilitate port planning and development;

38 (b) Promote local cooperation in statewide planning and development of the ports;

39 (c) Promote long-term economic self-sufficiency of the ports;

40 (d) Encourage cost-effective investments with prudent financial consideration of port develop-
41 ment projects; and

42 (e) Facilitate the efforts of the ports to expand and respond to greater domestic and interna-
43 tional market opportunities.

44 **SECTION 84.** ORS 284.540 is amended to read:

45 284.540. (1) There is established the Governor's Council on Oregon's Economy.

1 (2) The members of the council are:

2 (a) The presiding officer of the Oregon Economic and Community Development Commission;

3 (b) The chairperson of the Oregon Transportation Commission;

4 (c) The chairperson of the State Board of Agriculture;

5 [(d) *The chairperson of the International Trade Commission;*]

6 [(e)] (d) The president of the State Board of Higher Education; and

7 [(f)] (e) Other persons designated by the Governor.

8 (3) The council shall meet quarterly to:

9 (a) Discuss and coordinate the activities of each entity described in subsection (2) of this section
10 that relate to economic development and improving the economy in Oregon; and

11 (b) Discuss and recommend to the Legislative Assembly methods for creating certainty for the
12 development process.

13 **SECTION 85.** ORS 284.706 is amended to read:

14 284.706. (1) There is created the Oregon Innovation Council consisting of the following voting
15 members:

16 (a) The Governor or the Governor's designated representative, who shall be chairperson of the
17 council.

18 (b) Five members appointed by the Governor who are engaged in the operations of Oregon
19 traded sector industries.

20 (c) One member appointed by the Governor who is a representative of an Oregon-based, gener-
21 ally accredited, not-for-profit private institution of higher education.

22 (d) A member of the Oregon Growth Account Board, appointed by the board, who has experience
23 in the field of venture capital.

24 (e) A member of the Engineering and Technology Industry Council, appointed by the Engineer-
25 ing and Technology Industry Council.

26 (f) The Director of the Economic and Community Development Department.

27 (g) The Chancellor of the Oregon University System.

28 (h) The Commissioner for Community College Services.

29 (i) The State Treasurer.

30 (2)(a) The Speaker of the House of Representatives shall appoint two members to the council
31 who are members of the House of Representatives.

32 (b) The President of the Senate shall appoint two members to the council who are members of
33 the Senate.

34 (c) Members of the Legislative Assembly appointed to the council are nonvoting members and
35 may act in an advisory capacity only.

36 (3) The following persons, or their representatives, shall serve as ex officio, nonvoting members
37 of the council:

38 (a) The chairperson of the Oregon Economic and Community Development Commission.

39 [(b) *The chairperson of the International Trade Commission.*]

40 [(c)] (b) The president of the State Board of Higher Education.

41 [(d)] (c) The chairperson of the State Board of Education.

42 [(e)] (d) An executive officer of an association representing Oregon-based, generally accredited,
43 not-for-profit private institutions of higher education, appointed by the Governor.

44 (4) The term of office of each appointed voting member of the council is three years, but an
45 appointed member serves at the pleasure of the appointing authority. Before the expiration of the

1 term of an appointed voting member, the appointing authority shall appoint a successor whose term
2 begins on July 1 next following. An appointed member is eligible for reappointment. If there is a
3 vacancy for any cause, the appointing authority shall make an appointment to become immediately
4 effective for the remainder of the unexpired term.

5 (5) A majority of the voting members of the council constitutes a quorum for the transaction
6 of business.

7 (6) Official action by the council requires the approval of a majority of the voting members of
8 the council.

9 (7) The council shall meet at least twice per fiscal year at a place, day and time determined by
10 the chairperson. The council may also meet at other times and places specified by a call of the
11 chairperson or by written request of a majority of the voting members of the council.

12 (8) The council may adopt rules necessary for the operation of the council.

13 (9) The council may establish committees and delegate to the committees duties as the council
14 considers desirable.

15 (10) The Economic and Community Development Department shall provide staff support to the
16 council.

17 (11) Members of the council who are not members of the Legislative Assembly are entitled to
18 compensation and expenses incurred by them in the performance of their official duties in the man-
19 ner and amounts provided for in ORS 292.495. Claims for compensation and expenses of members
20 of the council who are public officers shall be paid out of funds appropriated to the public agency
21 that employs the member. Claims for compensation and expenses of members of the council who are
22 not public officers shall be paid out of funds appropriated to the Economic and Community Devel-
23 opment Department for that purpose.

24 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist the
25 council in the performance of its duties and, to the extent permitted by laws relating to
26 confidentiality, to furnish such information and advice as the members of the council consider nec-
27 essary to perform their duties.
