30	"353.606. (1) There is created the Oregon Nursing Shortage Coalition Committee.
31	"(2) The committee consists of 10 members, as follows:
32	"(a) Two members who represent the Oregon State Board of Nursing appointed by the board.
33	"(b) Two members who represent the Northwest Organization of Nurse Executives appointed by
34	the Oregon State Board of Nursing from a list of persons submitted to the board by the Northwest
35	Organization of Nurse Executives.

1 "(c) Two members who represent the Oregon Nurses Association appointed by the Oregon State 2 Board of Nursing from a list of persons submitted to the board by the Oregon Nurses Association.

"(d) One member appointed by the Oregon State Board of Nursing who represents a nursing program in an Oregon-based, generally accredited, not-for-profit private [institutions] institution of higher education from a list of persons submitted to the board by the [Oregon Independent Colleges Association] Oregon Council of Deans.

"(e) Two members appointed by the Commissioner for Community College Services from a list
of persons submitted to the commissioner by the Oregon Community College Association. One
member appointed in accordance with this paragraph must be a nursing faculty member
from a community college nursing program.

"(f) One member **appointed by and** who represents Oregon Health and Science University [appointed by the university] who is a registered nurse and a member of the faculty of the School of Nursing at the university.

"(3) When appointing members to the committee, the Oregon State Board of Nursing, the Commissioner for Community College Services and Oregon Health and Science University shall ensure that there is at least one member from each of the following areas of the state:

17 "(a) Rural western Oregon.

18 "(b) Coastal Oregon.

19 "(c) Eastern Oregon.

20 "(d) Urban areas.

"(4) The term of office of each member is four years, but a member serves at the pleasure of the appointing authority. Before the expiration of the term of a member, the appointing authority shall appoint a successor whose term begins on July 1 next following. A member is eligible for reappointment. If there is a vacancy for any cause, the appointing authority shall make an appointment to become immediately effective for the unexpired term.

26 "(5) The committee shall elect one of its members to serve as chairperson and another to serve 27 as vice chairperson, for the terms and with the duties and powers necessary for the performance 28 of the functions of such offices as the committee determines.

29 "(6) The committee shall meet at times and places specified by the call of the chairperson or 30 of a majority of the members of the committee.

31 "(7) A majority of the members of the committee constitutes a quorum for the transaction of 32 business.

33 "(8) Members of the committee are entitled to actual and necessary travel expenses in the 34 manner and amounts provided for in ORS 292.495. Claims for expenses incurred in performing func-35 tions of the committee shall be paid out of funds received by Oregon Health and Science University 36 for that purpose.

"(9) Oregon Health and Science University shall provide staff support to the committee.".
