SENATE MINORITY REPORT AMENDMENTS TO SENATE BILL 424

May 11

President Courtney:

A minority of your Committee on Business, Transportation and Workforce Development, to whom was referred Senate Bill 424, having had the same under consideration, respectfully reports it back with the recommendation that it do pass with the following amendments:

1 On page 1 of the printed bill, line 2, delete "802.195,". In line 3, delete "807.024," and delete "807.050," and delete "807.115,". 2 3 Delete lines 5 through 32 and delete pages 2 through 17 and insert: "SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Oregon Vehicle 4 Code. 5 6 "SECTION 2. (1) Prior to issuing, renewing or replacing any driver license, driver permit 7 or identification card, the Department of Transportation shall require a person to provide proof of legal presence and a Social Security number or, if the person is not eligible for a 8 Social Security number, proof that the person is not eligible for a Social Security number. 9 "(2) For the purposes of subsection (1) of this section: 10 "(a) A person provides proof of legal presence by submitting valid documentation, as de-11 12 fined by rule, that the person is a citizen or permanent legal resident of the United States or is otherwise legally present in the United States in accordance with federal immigration 13 14 laws. (b) A person satisfies the requirement of providing proof of a Social Security number 15

by submitting a valid Social Security number that has been assigned to the person by the United States Social Security Administration.

18 "(c) If a person is not eligible to have a Social Security number, the person shall provide 19 proof, as defined by rule, that the person is not eligible for a Social Security number.

20 "(3)(a) The Department of Transportation may issue a temporary driver license, tempo-21 rary driver permit or temporary identification card only to a person who provides proof, as 22 determined by rule, that the person is legally present in the United States on a temporary 23 basis.

24 "(b) A temporary driver license, temporary driver permit or temporary identification 25 card shall be valid only during the period of time of the applicant's authorized stay in the 26 United States or, if there is no definite end to the period of authorized stay, for a period of 27 one year.

(c) A temporary driver license, temporary driver permit or temporary identification card may be renewed only upon presentation of acceptable documentation, as determined by rule, that the status by which the applicant qualified for the temporary driver license, temporary driver permit or temporary identification card has been extended.

32 "(d) A temporary driver license or temporary driver permit grants the same privileges

1 as a driver license or driver permit.

2 "(e) A temporary identification card shall bear a statement to the effect that the tem-3 porary identification card is not a license or any other grant of driving privileges and is to 4 be used for identification purposes only.

5 "(f) The fees for issuance, renewal and replacement of temporary driver licenses and 6 temporary driver permits under this section are as provided under ORS 807.370 for the cor-7 responding nontemporary license or permit. The fees for issuance, renewal and replacement 8 of temporary identification cards under this section are as provided under ORS 807.410 for 9 the corresponding nontemporary identification card.

"(4) The Department of Transportation may issue, renew or replace a driver license,
 driver permit or identification card only after the Department of Transportation verifies the
 Social Security number with the United States Social Security Administration.

13 "(5) Subsections (1) and (4) of this section do not apply if the Department of Transpor-14 tation previously verified information as required by subsection (4) of this section and the 15 person applying for the driver license, driver permit or identification card is a citizen or 16 permanent legal resident of the United States.

17 "<u>SECTION 3.</u> Section 2 of this 2007 Act applies to driver licenses, driver permits and
18 identification cards that are issued, renewed or replaced on or after the effective date of this
19 2007 Act.

20 "<u>SECTION 4.</u> Sections 5 and 6 of this 2007 Act are added to and made a part of the 21 Oregon Vehicle Code.

<u>SECTION 5.</u> 'Identity source documents' means documents required for the issuance,
 renewal and replacement of driver licenses, driver permits and identification cards by the
 Department of Transportation.

25 "<u>SECTION 6.</u> Before issuing or renewing a driver license, driver permit or identification 26 card for a person, the Department of Transportation shall verify with the issuing agency the 27 issuance, validity and completeness of each identity source document presented by the per-28 son.

"<u>SECTION 7.</u> ORS 802.200 is amended to read:

30 "802.200. In addition to any other records the Department of Transportation may establish, the 31 department is subject to the following provisions concerning records:

"(1) The department shall maintain records concerning the titling of vehicles in this state. The records under this subsection shall include the following:

36 "(A) The name of the vehicle owner and any security interest holders in order of priority, except 37 that a security interest holder need not be identified if the debtor who granted the interest is in the 38 business of selling vehicles and the vehicles constitute inventory held for sale;

40 "(C) The vehicle description; and

41 "(D) Whether a certificate of title was issued for the vehicle.

44 "(c) If the vehicle is a replica, the records shall indicate that the vehicle is a replica.

45 "(d) Any other information concerning the titling of vehicles that the department considers

1 convenient or appropriate.

2 "(e) All odometer readings for a vehicle that are reported to the department under provisions 3 of the vehicle code.

"(f) If the vehicle has been reported to the department as a totaled vehicle under the provisions
of ORS 819.012 or 819.014, the records shall indicate that the vehicle is a totaled vehicle unless the
reason for the report was theft and the vehicle has been recovered.

"(2) If a vehicle that has been registered or titled in another jurisdiction is registered or titled
in this state, the department shall retain a record of any odometer readings shown on the title or
registration documents submitted to the department at the time of registration or title.

"(3) Except as otherwise provided in ORS 826.003, the department shall maintain records concerning the registration of vehicles required to be registered by the department. The records concerning the registration of vehicles may be stored along with records concerning the titling of vehicles. The records under this subsection shall include the following:

14 "(a) For vehicles registered by the department, the records shall identify the vehicle and contain 15 the following:

16 "(A) The registration plate number assigned by the department to the vehicle;

17 "(B) The name of the vehicle owner;

18 "(C) The vehicle description and vehicle identification number; and

"(a) The person's application for a vehicle dealer certificate.

"(D) An indication that the vehicle is a totaled vehicle if it has been reported to the department as a totaled vehicle under the provisions of ORS 819.012 or 819.014, unless the reason for the report was theft and the vehicle has been recovered.

"(b) Any other information concerning the registration of vehicles that the department considers convenient or appropriate.

24 "(4) The department shall maintain separate records for the regulation of vehicle dealers. The 25 records required under this subsection shall include the following information about persons issued 26 dealer certificates:

28 "(b) An alphabetical index of the name of each person applying for a vehicle dealer certificate.

29 "(c) A numerical index according to the distinctive number assigned to each vehicle dealer.

30 "(5) The department shall maintain a file on vehicles for which the title record is canceled under 31 ORS 819.030. The records required under this subsection shall disclose the last registered owner of 32 each vehicle, any security interest holder or holders and lessors of each vehicle as shown by the 33 canceled title record for each vehicle and the make and year model for each vehicle.

"(6) The department shall maintain a record of each agreement or declaration under ORS
 802.500 and 802.520.

36 "(7) The department shall maintain separate and comprehensive records of all transactions affecting the Revolving Account for Emergency Cash Advances described under ORS 802.100.

"(8) The department shall maintain suitable records of driver licenses, [and] driver permits and
 identification cards. The records required under this subsection shall include all of the following:

"(e) When a person from another jurisdiction applies for a driver license or **driver** permit issued by this state, the department shall request a copy of the person's driving record from the other jurisdiction. At the time the person is issued a license in Oregon, the record from the other jurisdiction shall become part of the driver's record in this state with the same force and effect as though entered on the driver's record in this state in the original instance. The department by rule may specify methods for converting entries from out-of-state records for use in Oregon.

"(f) When a suspension of a driver permit, driver license or other driving privilege is placed on the driving record under ORS 809.280 for failure to appear in court on a traffic crime, the department shall note on the record that the suspension was for failure to appear in court and shall also note the offense charged against the person on which the person failed to appear.

"(g) The department, in consultation with the Department of State Police, shall devise and im-14 15 plement a method of noting suspensions and revocations of driving privileges on the record in such 16 a way that police agencies can determine directly from the record what class of offense, as provided 17by law, is committed by a person who drives in violation of the suspension or revocation. If the 18 Department of Transportation and the Department of State Police devise a mutually agreeable al-19 ternative method of informing police agencies of the nature of a suspension or revocation and the 20 consequences of its violation, the implementation of that method shall satisfy the duty of the De-21partment of Transportation under this paragraph.
