Senate Bill 549

Sponsored by COMMITTEE ON FINANCE AND REVENUE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Sets procedure for statewide special election on Senate Joint Resolution 3 (2007) and Senate Joint Resolution 8 (2007).

Appropriates moneys from General Fund to Secretary of State for expenses of submitting measures to people at special election to be held on May 15, 2007.

Declares emergency, effective on passage.

A BILL FOR AN ACT 1 Relating to elections; appropriating money; and declaring an emergency. 2 Be It Enacted by the People of the State of Oregon: 3 SECTION 1. Except as otherwise provided in this 2007 Act, ORS chapters 250, 251 and 254 4 apply to the special election held on the measures submitted under Senate Joint Resolution 5 3 (2007) and Senate Joint Resolution 8 (2007). 6 SECTION 2. A special election shall be held throughout this state on May 15, 2007. The 7 measures referred to in section 1 of this 2007 Act and that are otherwise referred to the 8 people by the Legislative Assembly shall be submitted to the electors for their approval or 9 10 rejection at the special election. SECTION 3. 2 <u>SECTION 6.</u> (1) Arguments relating to the measures referred to in section 1 of this 2007 3 Act may be filed with the Secretary of State under ORS 251.245 and 251.255, except that an 4 argument shall be filed not later than the date set by the Secretary of State by rule.

5 (2) Notwithstanding ORS 192.410 to 192.505 relating to public records, an argument filed 6 under this section is exempt from public inspection until the fourth business day after the 7 deadline for filing the argument.

SECTION 7. (1) The Secretary of State shall cause to be printed in the voters' pamphlet 8 9 the number, ballot title and text of each measure referred to in section 1 of this 2007 Act and the financial estimates, explanatory statements and arguments relating to the measures. 10 The Secretary of State shall also cause to be printed in the voters' pamphlet any other ma-11 12 terial required by law. Notwithstanding ORS 251.026, the Secretary of State shall include in the voters' pamphlet the information or statements described in ORS 251.026 that the Sec-13 retary of State considers applicable to the election on the measures referred to in section 1 14 15 of this 2007 Act.

(2) Not later than the 10th day before the election, the Secretary of State shall cause the
 voters' pamphlet to be mailed to each post-office mailing address in Oregon and may use any
 additional means of distribution necessary to make the pamphlet available to electors.

(3) In preparing the voters' pamphlet under this section, the Secretary of State is not
 required to comply with ORS chapter 279B relating to competitive bidding.

(4) For purposes of sections 1 to 10 of this 2007 Act, the election referred to in ORS
251.295 is the special election held on the date specified in section 2 of this 2007 Act.

23 <u>SECTION 8.</u> (1) Notwithstanding the deadline in ORS 254.085, the Secretary of State shall 24 prepare and deliver to each county clerk by the most expeditious means practicable a certi-25 fied statement of each measure referred to in section 1 of this 2007 Act. The Secretary of 26 State shall include with each statement the number, financial estimate and full ballot title 27 of the measure, and any other information required by law. The Secretary of State shall keep 28 a copy of each statement.

(2) The county clerks shall print on the ballot the number, financial estimate and full
ballot title of each measure, along with any other material required by law. In lieu of printing
the financial estimate, the summary portion of the ballot title or other material required by
law on the ballot, a county clerk may include with the ballot the complete text of the ballot
title, the financial estimate and any other material required by law.

34 <u>SECTION 9.</u> (1) The Secretary of State may adopt rules governing the procedures for 35 conducting the election on the measures referred to in section 1 of this 2007 Act as may be 36 necessary to implement sections 1 to 9 of this 2007 Act.

(2) Notwithstanding ORS 254.465, the election on the measures referred to in section 1
of this 2007 Act shall be conducted by mail in all counties in this state as provided under ORS
254.470.

40 <u>SECTION 10.</u> (1) In addition to and not in lieu of any other appropriation or money made 41 available by law or from other sources, there is appropriated to the Secretary of State, for 42 the biennium ending June 30, 2007, out of the General Fund, the amount of \$_____ for the 43 payment of direct expenses of this state incurred in submitting, by action of the Legislative 44 Assembly, any measure to the people at a special election held throughout this state on May 45 15, 2007.

1 (2) Any part of the appropriation under subsection (1) of this section that is unexpended 2 and unobligated on January 1, 2008, shall revert to the General Fund.

3 <u>SECTION 11.</u> This 2007 Act being necessary for the immediate preservation of the public

4 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
 5 on its passage.
