## **Summary of Revenue Changes**

The measure is funded with a special purpose General Fund appropriation to the Emergency Board.

## Summary of Capital Construction and Information Technology Subcommittee Action

The measure establishes criteria for referendum petition referrals to voters and contains ballot measure titles and explanations for House Joint Resolution 7 [expanding availability of Home Ownership Loans for Oregon Veterans] and House Joint Resolution 13 [Allows state bonding to match voter approved school district bonds for school capital costs]. With the except for HB 2649 and HB 3405, any 75<sup>th</sup> Legislative act referred to the people by petition shall go to the May 2010 primary election. The measure sets, January 26, 2010, as the date for a possible special election. A Joint legislative committee would be established for the purposes of preparing ballot titles, explanations, and financial estimates. The measure provides for an expedited review process with the Supreme Court for certain contested ballot amendment titles and explanatory statements. It outlines a process whereby the Supreme Court can certify a modified explanatory statement to the Secretary of State, if the Supreme Court determines that the explanatory statement does not substantially comply with legal requirements. The measure also outlines a process whereby the Supreme to the Secretary of State, if the Supreme Court determines that the explanatory statement does not substantially comply with legal requirements. The measure vests original jurisdiction with the Oregon Supreme Court to review and determine the constitutionality of the measure's amendments to ballot measure statutes.

The measure provides for a special purpose appropriation of \$2 million to the Emergency Board that the Secretary of State may access for election costs if a January 26, 2010 statewide special election is held. The special purpose appropriation or balance thereof, if not allocated by the Emergency Board by December 2010, will become available for general use by the Emergency Board.
