1	On page 1 of the printed bill, line 2, after "ORS" delete the rest of the line and delete lines 3
2	and 4 and insert "675.775, 678.140, 679.230, 683.250, 687.470, 688.160, 688.545 and 688.820; and de-
3	claring an emergency.".
4	Delete lines 6 through 31 and delete pages 2 through 10 and insert:
5	" <u>SECTION 1.</u> ORS 675.775 is amended to read:
6	"675.775. (1) The Oregon Board of Licensed Professional Counselors and Therapists is estab-
7	lished.
8	"(2) The board [shall consist] consists of [seven] eight members who shall be appointed by the
9	Governor.
10	"(3) In selecting the members of the board, the Governor shall strive to balance the represen-
11	tation according to geographic areas of this state, gender, age and ethnic group.
12	"(4) The board shall consist of:
13	"(a) Three members who are persons licensed as professional counselors under ORS 675.715;
14	"(b) Two members who are persons licensed as marriage and family therapists under ORS
15	675.715;
16	"(c) One member from the faculty of a school within this state that has programs to train per-
17	sons to become professional counselors or marriage and family therapists; and
18	"(d) [One member] Two members from the public who [has] have demonstrated an interest in
19	the fields of professional counseling and marriage and family therapy.
20	"(5) Statewide counselor and marriage and family therapist organizations may recommend names
21	of qualified persons to the Governor at the time for filling vacancies on the board.
22	"(6) The term of office of each member is three years, but a member serves at the pleasure of
23	the Governor. By October 1 of each year, the Governor shall appoint persons to fill positions on the
24	board that are due to become vacant on October 1 of that year. A member is eligible for one con-
25	secutive reappointment. If there is a vacancy for any cause, the Governor shall make an appoint-
26	ment to become immediately effective for the unexpired term.
27	"SECTION 2. ORS 678.140 is amended to read:
28	"678.140. (1) There is created an Oregon State Board of Nursing composed of nine members[, five
29	of whom shall be registered nurses, two of whom shall be licensed practical nurses and]. The board
30	consists of:
31	"(a) Five members who are registered nurses;
32	"(b) One member who is a licensed practical nurse;
33	"(c) One member who is a certified nursing assistant; and
34	"(d) Two [of whom shall be] members of the public who are otherwise not eligible for appoint-
35	ment to the board.

1 "(2) In making appointments of registered nurses, the Governor shall consider geographic bal-2 ance in making the appointments and shall ensure that the following areas of practice are repres-3 ented on the board:

4 "(a) One nursing educator;

5 "(b) One nursing administrator;

6 "(c) Two nonsupervisory nurses involved in direct patient care; and

7 "(d) One nurse practitioner.

8 "(3) The members of the board shall be appointed by the Governor for terms of three years, 9 beginning on January 1. No member shall be eligible to appointment for more than two consecutive 10 terms. An unexpired term of a board member shall be filled in the same manner as an original ap-11 pointment is made. The appointment shall be for the remainder of the unexpired term. All appoint-12 ments of members of the board by the Governor are subject to confirmation by the Senate pursuant 13 to section 4, Article III of the Oregon Constitution.

"(4) Two months before the expiration of the term of office of a nurse member of the board, or 14 15when a vacancy occurs in the office of a nurse member, the Oregon Nurses Association or any other 16 organization representing registered nurses, if the vacancy is in a registered nurse position, [or] the Oregon Licensed Practical Nurses Association or any other organization representing licensed 1718 practical nurses, if the vacancy is in a licensed practical nurse position, or an organization rep-19 resenting certified nursing assistants, if the vacancy is in a certified nursing assistant posi-20tion, may submit a list of three names of persons qualified for the appointment. The appointment 21of nurse members, [or] practical nurse members or certified nursing assistant members may be 22made from the respective lists.

"(5) At the time of appointment, each member of the board must be a citizen of the United States and a resident of Oregon. Each nurse member must be currently licensed and not under disciplinary status with the board in the category for which appointed with at least five years' experience therein, three of which were immediately prior to appointment. The public members and any person in the immediate family of the public members [*shall*] **may** not be employed as a health professional or in any health-related industry.

29 "(6) The Governor may remove a member of the board for cause.

30 "SECTION 3. ORS 679.230 is amended to read:

"679.230. (1) The Oregon Board of Dentistry [shall consist] consists of [nine] 10 members. [A 3132member shall be appointed to the board by the Governor upon the expiration of the term of office of 33 each of the preceding board members. Appointments to the board by the Governor are subject to con-34firmation by the Senate in the manner provided in ORS 171.562 and 171.565. Each member shall hold 35 the office for four years and until the member's successor is appointed and qualified. Terms of office begin on the first Monday of April after the time of appointment. No person is eligible to membership 36 37 on the board who is not a citizen of the United States or a resident of the State of Oregon.] Of the 38 members of the board:

"(a) Six members shall be Oregon active licensed dentists, of which at least one shall be a
dentist practicing in a dental specialty recognized by the American Dental Association[, one member
shall be a public member and];

42 "(b) Two members must be public members; and

43 "(c) Two members shall be Oregon active licensed dental hygienists.

44 "(2) Appointments of dentists made by the Governor to the Oregon Board of Dentistry may be 45 selected by the Governor from a list of five names for each appointment suggested by the Oregon 1 Dental Association. Appointments of dental hygienists made by the Governor to the Oregon Board 2 of Dentistry may be selected by the Governor from a list of five names suggested by the Oregon 3 Dental Hygienists' Association. Appointments of dental specialists by the Governor to the Oregon 4 Board of Dentistry may be selected by the Governor from one name suggested by each of the or-5 ganizations representing a dental specialty.

"(3) The Governor shall appoint a member to the board upon the expiration of the term
of office of each of the preceding board members. Appointments to the board by the Governor are subject to confirmation by the Senate in the manner provided in ORS 171.562 and
171.565.

"(4) Each member shall hold the office for four years and until the member's successor
is appointed and qualified. Terms of office begin on the first Monday of April after the time
of appointment.

"(5) Members of the board must be citizens of the United States and residents of Oregon."(6) Members are entitled to compensation and expenses as provided in ORS 292.495.

"<u>SECTION 4.</u> ORS 683.250 is amended to read:

16 "683.250. (1) The Oregon Board of Optometry shall operate as a semi-independent state agency 17 subject to ORS 182.456 to 182.472, for the purpose of carrying out this chapter.

"(2) The board [shall consist] consists of [five] six members appointed by the Governor. Each member of the board shall qualify by taking and subscribing the oath of office required by the Constitution, which shall be filed in the office of the Secretary of State.

"(3) Of the members of the board:

"(a) Four of the members [of this board shall] must be Doctors of Optometry licensed and in practice in Oregon; and [and the fifth member shall be a public member representing health consumers.]

"(b) Two members must be public members representing health consumers.

26 "(4) Each of the members shall hold office for a term of three years or until a successor is ap-27 pointed and qualified and shall be so classified that at least one optometrist member of the board 28 retires each year.

"(5) A majority of the members constitute a quorum for the transaction of business.

30 "SECTION 5. ORS 687.470 is amended to read:

31 "687.470. There is established within the Oregon Health Licensing Agency the State Board of 32 Direct Entry Midwifery consisting of [seven] **nine** members appointed by the Governor. Each mem-33 ber of the board shall serve a term of three years and until a successor is appointed and qualified. 34 If there is a vacancy for any cause, the Governor shall make an appointment to become immediately 35 effective for the unexpired term. All appointments of members of the board are subject to confir-36 mation by the Senate in the manner provided in ORS 171.562 and 171.565. The membership of the 37 board shall include:

38 "(1) Four licensed direct entry midwives.

39 "(2) Two certified nurse midwives.

40 "(3) One physician licensed under ORS chapter 677 involved at the time of appointment in 41 obstetrical care or education.

42 "(4) Two members of the public.

43 "SECTION 6. ORS 688.160 is amended to read:

"688.160. (1) The Physical Therapist Licensing Board shall operate as a semi-independent state
 agency subject to ORS 182.456 to 182.472, for purposes of carrying out the provisions of ORS 688.010

to 688.201 and 688.990 (1). The Physical Therapist Licensing Board [shall consist] consists of 1 2 [seven] eight members appointed by the Governor who may be appointed from a list of not fewer than nine names, submitted by the Oregon Physical Therapy Association. All members have equal 3

4 voting privileges. Of the members of the board:

"(a) Five members [shall] must be physical therapists who are Oregon residents, possess unre-5 stricted licenses to practice physical therapy in this state, have been practicing in this state for at 6 7 least two years immediately preceding their appointments and have been practicing in the field of 8 physical therapy for at least five years.

9

"(b) One member shall be a licensed physical therapist assistant.

"(c) [One member shall be a public member who has] Two members must be members of the 10 11 public who have an interest in consumer rights. [All members shall have equal voting privileges.]

12"(2) Upon the expiration of the term of a member of the board, the Governor shall appoint a 13successor who may be appointed from a list of three names submitted to the Governor by the Oregon Physical Therapy Association to serve a term of four years. A member may not serve for more than 14 15 two consecutive four-year terms.

16 "(3) In the event of a vacancy in the office of a member of the board other than by reason of the expiration of a term, the Governor, not later than 90 days after the occurrence of the vacancy, 1718 shall appoint a person to fill the vacancy for the unexpired term. The person may be appointed from 19 a list of three names submitted as provided in subsection (2) of this section. If requested by the 20 board, the Governor may remove any member of the board for misconduct, incompetence or neglect 21of duty.

22"(4) Each member of the board is entitled to compensation and expenses as provided in ORS 292.495. 23

24 "(5) A board member who acts within the scope of board duties, without malice and in reason-25able belief that the member's action is warranted by law, is immune from civil liability.

"(6) The board [shall have] has the power to:

27"(a) Establish matters of policy affecting administration of ORS 688.010 to 688.201;

28 (b) Provide for examinations for physical therapists and physical therapist assistants and adopt 29 passing scores for the examinations;

"(c) Adopt rules necessary to carry out and enforce the provisions of ORS 688.010 to 688.201; 30

"(d) Establish standards and tests to determine the qualifications of applicants for licenses to 3132practice physical therapy in this state;

33 "(e) Issue licenses to persons who meet the requirements of ORS 688.010 to 688.201;

"(f) Adopt rules relating to the supervision and the duties of physical therapist aides who assist 3435 in performing routine work under supervision;

36 "(g) Adopt rules establishing minimum continuing education requirements for all licensees;

"(h) Exercise general supervision over the practice of physical therapy within this state;

38 "(i) Establish and collect fees for the application or examination for, or the renewal, reinstatement or duplication of, a license under ORS 688.040, 688.080 or 688.100 or for the issuance of 39 40 a temporary permit under ORS 688.110; and

41 (j) Establish and collect fees to carry out and enforce the provisions of ORS 688.010 to 688.201.

42"(7) The board shall meet as determined by the board and at any other time at the call of the board chairperson, who shall be elected by the members of the board. 43

44 "(8) The board may appoint and fix the compensation of an executive director and other staff 45 as necessary to carry out the operations of the board.

1 "(9) The board shall:

2 "(a) Maintain a current list of all persons regulated under ORS 688.010 to 688.201, including the 3 persons' names, current business and residential addresses, telephone numbers, electronic mail ad-4 dresses and license numbers.

5 "(b) Provide information to the public regarding the procedure for filing a complaint against a 6 physical therapist or physical therapist assistant.

"(c) Publish at least annually, and in a format or place determined by the board, final disciplinary actions taken against physical therapists and physical therapist assistants and other information, including rules, in order to guide physical therapists and physical therapist assistants regulated
pursuant to ORS 688.010 to 688.201.

"SECTION 7. ORS 688.545 is amended to read:

12 "688.545. (1)(a) There is created in the Department of Human Services a Board of Radiologic 13 Technology consisting of nine members who shall be appointed by the Governor. Each member of 14 the board shall be a citizen of the United States and a resident of the State of Oregon. Each ap-15 pointed member is entitled to vote.

16 "(b) Of the members of the board:

17 "(A) One [shall] **must** be a radiologist;

18 "[(B) At least one shall be a lay person;]

19 "(B) Two must be lay persons;

20 "(C) [At least one shall] One must be a limited permit holder; and

"(D) [At least five shall] Five must be licensed practicing radiologic technologists, one of whom
 [shall] must be a radiation therapist.

"(2) The section manager of the Radiation Protection Services Section of the Department of Human Services, or a person appointed by the section manager, [*shall be*] is an advisory member of the board for the purpose of providing counsel and [*shall not be*] is not entitled to vote.

"(3) The term of office of the members of the board [shall be] is three years and a member may
be reappointed to serve not more than two full terms.

"(4) Members of the board [shall be] are entitled to compensation and expenses as provided in
 ORS 292.495.

30 "(5) The board shall annually elect a board chairperson and a vice chairperson from the mem-31 bers of the board.

"(6) For the purpose of transacting its business, the board shall meet at least once every three months at times and places designated by resolution. Special meetings may also be held at such times as the board may elect or at the call of the chairperson. Notification of the time, place and purpose of any special meeting [*shall*] **must** be sent to all members of the board at least 15 days before the date of the meeting. All meetings are subject to ORS 192.610 to 192.690.

"(7) Five members of the board [shall] constitute a quorum for the transaction of business at any meeting. Five affirmative votes [shall be] are required to take action.

39 "SECTION 8. ORS 688.820 is amended to read:

"688.820. (1) There is established within the Oregon Health Licensing Agency the Respiratory
 Therapist Licensing Board, consisting of five members appointed by the Governor. The board consists of:

43 "(a) Three respiratory therapists; and

44 "(b) Two members of the general public.

45 "(2) The term of office of each member of the board is four years. A member is eligible for re-

1 appointment, but no member shall serve more than two full terms. If there is a vacancy for any 2 cause, the Governor shall make an appointment to become immediately effective for the unexpired 3 term.

4 "(3) The members of the board must be [*citizens*] **residents** of this state [*who*]. Members of the 5 **board who are respiratory therapists must** have engaged in the practice of respiratory care for 6 a period of five or more years immediately preceding appointment to the board. In making appoint-7 ments of respiratory therapists to the board, the Governor shall take into consideration any 8 nominations received from the Oregon Society for Respiratory Care, or its successor.

9 "(4) A member of the board may be removed by the Governor for neglect of duty, incompetency
10 or unethical or dishonorable conduct.

"(5) A member of the board is entitled to compensation and expenses as provided in ORS 292.495.

13 "<u>SECTION 9.</u> (1) A member serving on the Oregon Board of Nursing created in ORS 14 678.140 on the effective date of this 2009 Act continues to serve until the term of office for 15 which the member was appointed terminates by expiration of time, resignation from the 16 board by the member or removal of the member from office.

"(2) When a member's term of service on the board terminates, a member who is otherwise eligible for reappointment to the board may be reappointed, unless the appointment exceeds the total appointments authorized for members within the member's classification.

20 "SECTION 10. Section 9 of this 2009 Act is repealed on June 30, 2014.

<u>"SECTION 11.</u> The amendments to ORS 675.775, 678.140, 679.230, 683.250, 687.470, 688.160,
688.545 and 688.820 by sections 1 to 8 of this 2009 Act apply to appointments to health professional regulatory boards, as defined in ORS 676.160, and to boards, advisory councils and
programs listed in ORS 676.606 made on or after the effective date of this 2009 Act.

"<u>SECTION 12.</u> This 2009 Act being necessary for the immediate preservation of the public
 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect
 on its passage.".

28
