SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands criminal homicide to include causing death of unborn child. Provides exception for lawful abortions and acts committed by pregnant woman. Creates crime of assault of unborn child. Punishes by maximum of 10 years' imprisonment,

\$250,000 fine, or both.
