SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Creates Health System Fund [to fund medical assistance and private health option and to pay refunds of hospital assessment] for specified purposes, including funding of Health Care for All Oregon Children program. Modifies hospital assessment. [Repeals] Extends sunset on hospital assessment. [Directs hospital assessment to be paid into Health System Fund after October 1, 2009.] Transfers moneys in Medical Care Quality Assurance Fund to Health System Fund on

specified date.

Creates assessment on insurance premiums to be administered by Department of Consumer and Business Services. Directs assessments minus specified amounts to be paid into Health System Fund. Creates assessment on capitation payments to Medicaid managed care plans to be administered

by Department of Human Services. Directs assessments to be deposited in Health System Fund. Imposes penalties for failure to timely pay assessments.

Directs Department of Human Services to establish adjustment to capitation rate paid to certain Medicaid managed care organizations. Requires contracts between department and organizations to distribute adjustment to specified hospitals.

Directs Department of Human Services to establish fee-for-service reimbursement rates for inpatient hospital services provided by certain hospitals that receive Medicare reimbursement.

Establishes Health Care for All Oregon Children program for purpose of providing affordable,

accessible health care to all Oregon children. Specifies [qualifications] who is eligible for program. [Directs Department of Human Services to provide medical assistance to specified persons for whom a public agency assumed financial responsibility.] Directs Office of Private Health Partnerships to administer private health option for purposes of expanding private health insurance [coverage of] for Oregon's children.

Directs Department of Human Services to seek federal financial participation for programs re-lating to health care of Oregon's children. Specifies other duties of department relating to programs. [Establishes Private Health Option Program Fund. Continuously appropriates moneys in fund to

Office of Private Health Partnerships for purposes of administering programs relating to health care of Oregon's children.]

Takes effect on 91st day following adjournment sine die.

SECTION 1. (1) The Health System Fund is established in the State Treasury, separate 8

9 and distinct from the General Fund. Interest earned by the Health System Fund shall be

(C) In the case of a joint program of two or more public bodies, the number of covered employees and dependents and retired employees and dependents aggregates at least 1,000 individuals;
(b) The individual or jointly self-insured health insurance program includes all coverages and

benefits required of group health insurance policies under ORS chapters 743 and 743A;

(c) The individual or jointly self-insured program must have program documents that defineprogram benefits and administration;

(d) Enrollees must be provided copies of summary plan descriptions including:

(A) Written general information about services provided, access to services, charges and sched uling applicable to each enrollee's coverage;

32 (B) The program's grievance and appeal process; and

(C) Other group health plan enrollee rights, disclosure or written procedure requirements es tablished under ORS chapters 743 and 743A;

(e) The financial administration of an individual or jointly self-insured program must include the
 following requirements:

(A) Program contributions and reserves must be held in separate accounts and used for the ex clusive benefit of the program;

(B) The program must maintain adequate reserves. Reserves may be invested in accordance with
the provisions of ORS chapter 293. Reserve adequacy must be calculated annually with proper
actuarial calculations including the following:

42 (i) Known claims, paid and outstanding;

43 (ii) A history of incurred but not reported claims;

44 (iii) Claims handling expenses;

45 (iv) Unearned contributions; and

1 (v) A claims trend factor; and

2 (C) The program must maintain adequate reinsurance against the risk of economic loss in ac-3 cordance with the provisions of ORS 742.065 unless the program has received written approval for 4 an alternative arrangement for protection against economic loss from the Director of the Depart-5 ment of Consumer and Business Services;

6 (f) The individual or jointly self-insured program must have sufficient personnel to service the 7 employee benefit program or must contract with a third party administrator licensed under ORS 8 chapter 744 as a third party administrator to provide such services;

9 (g) The individual or jointly self-insured program shall be subject to assessment in accordance 10 with ORS 735.614 **and section 3 of this 2009 Act** and former enrollees shall be eligible for porta-11 bility coverage in accordance with ORS 735.616;

(h) The public body, or the program administrator in the case of a joint insurance program of
two or more public bodies, files with the Director of the Department of Consumer and Business
Services copies of all documents creating and governing the program, all forms used to communicate
the coverage to beneficiaries, the schedule of payments established to support the program and,
annually, a financial report showing the total incurred cost of the program for the preceding year.
A copy of the annual audit required by ORS 297.425 may be used to satisfy the financial report filing
requirement; and

(i) Each public body in a joint insurance program is liable only to its own employees and no
others for benefits under the program in the event, and to the extent, that no further funds, including funds from insurance policies obtained by the pool, are available in the joint insurance pool.
(7) All ambulance services.

(8) A person providing any of the services described in this subsection. The exemption under this
subsection does not apply to an authorized insurer providing such services under an insurance policy. This subsection applies to the following services:

26 (a) Towing service.

(b) Emergency road service, which means adjustment, repair or replacement of the equipment,
tires or mechanical parts of a motor vehicle in order to permit the motor vehicle to be operated
under its own power.

(c) Transportation and arrangements for the transportation of human remains, including all
 necessary and appropriate preparations for and actual transportation provided to return a
 decedent's remains from the decedent's place of death to a location designated by a person with
 valid legal authority under ORS 97.130.

(9)(a) A person described in this subsection who, in an agreement to lease or to finance the purchase of a motor vehicle, agrees to waive for no additional charge the amount specified in paragraph (b) of this subsection upon total loss of the motor vehicle because of physical damage, theft or other occurrence, as specified in the agreement. The exemption established in this subsection applies to the following persons:

(A) The seller of the motor vehicle, if the sale is made pursuant to a motor vehicle retail in-stallment contract.

41 (B) The lessor of the motor vehicle.

42 (C) The lender who finances the purchase of the motor vehicle.

43 (D) The assignee of a person described in this paragraph.

(b) The amount waived pursuant to the agreement shall be the difference, or portion thereof,
 between the amount received by the seller, lessor, lender or assignee, as applicable, which repres-

ents the actual cash value of the motor vehicle at the date of loss, and the amount owed under the
 agreement.

7 <u>SECTION 50.</u> Notwithstanding section 9 (3), chapter 736, Oregon Laws 2003, moneys in 8 the Hospital Quality Assurance Fund established under section 9, chapter 736, Oregon Laws 9 2003, that were received by the Department of Human Services prior to January 1, 2010, or 10 if received on or after January 1, 2010, were derived from an assessment liability incurred 11 prior to October 1, 2009, may be used by the department:

(1) During the biennium beginning July 1, 2009, to supplant, directly or indirectly, moneys
 appropriated to fund health services by the Seventy-fifth Legislative Assembly during the
 regular legislative session;

(2) To fund increased fee-for-service reimbursement rates for inpatient and outpatient
 hospital services provided prior to October 1, 2009; and

(3) To fund Medicaid cost settlements owed to hospitals due to the increase in fee-for service rates under subsection (2) of this section.
