SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Oregon Economic and Community Development Commission to Oregon Business Development Commission. Changes name of Economic and Community Development Department to Oregon Business Development Department.

Creates Oregon Infrastructure Finance Authority and Oregon Infrastructure Finance Authority Board within Oregon Business Development Department.

Establishes Oregon Infrastructure Finance Fund. Continuously appropriates moneys in fund to

Oregon Business Development Department to promote infrastructure development. Transfers responsibilities of Oregon Economic and Community Development Commission and Economic and Community Development Department to and among Oregon Business Development Commission, Oregon Business Development Department and Oregon Infrastructure Finance Authority.

Declares emergency, effective on passage.

4	OREGON INFRASTRUCTURE FINANCE AUTHORITY
5	CREATION AND ADMINISTRATIVE PROVISIONS
6	
7	SECTION 1. Sections 1a to 7 of this 2009 Act are added to and made a part of ORS
8	chapter 285A.
9	SECTION 1a. (1) The Oregon Infrastructure Finance Authority Board is created as a
10	policy-making and advisory body within the Oregon Business Development Department. The
11	board consists of nine members as follows:
12	(a) One nonvoting member appointed from members of the Senate by the President of
13	the Senate;
14	(b) One nonvoting member appointed from members of the House of Representatives by
15	the Speaker of the House of Representatives;
16	(c) One member appointed by the State Treasurer; and
17	(d) Six members appointed by the Governor.
18	(2) Persons appointed members of the board must be Oregon residents, well qualified by
19	experience to make policy and recommendations in areas of concern to the Oregon
20	Infrastructure Finance Authority and to perform the duties of office. Members shall be ap-
21	pointed with consideration given to knowledge and experience:
22	(a) In the field of state and municipal finance;
23	(b) Of the infrastructure and public works needs in Oregon cities;
24	(c) Of the infrastructure and public works needs in Oregon counties;
25	(d) Of issues related to ports that affect the state;
26	(e) Of issues related to special service district services furnished across the state; and
27	(f) Of infrastructure and public works necessary to further Oregon's long term economic
28	growth.
29	(3) The office of the State Treasurer may recommend persons with expertise in the field
30	of state and municipal finance for membership on the board.
31	(4) The term of a member of the board appointed by the Governor, the State Treasurer
32	or the President of the Senate is four years. The term of a member appointed by the Speaker
33	of the House of Representatives is two years.
34	(5) In case of a vacancy on the board for any cause, the appointing authority shall ap-
35	point a successor to serve for the unexpired term.
36	(6) A member of the board may be appointed to serve two consecutive terms. A member
37	who serves two consecutive terms is not eligible for reappointment within one year following
38	the expiration of the second term.
39	(7) The board shall select one of its members to chair the board for such term and with
40	duties and powers necessary to perform the functions of the office as the board determines.
41	(8) A majority of the voting members of the board constitutes a quorum for the trans-
42	action of business.
43	SECTION 2. The Oregon Infrastructure Finance Authority Board shall:
44	(1) Serve as a body to advise municipalities, state agencies and private persons on the
45	development and implementation of state policies and programs relating to the

infrastructure needs of this state and its communities. 1

2 (2) Advise the Governor, the Director of the Oregon Business Development Department and the Oregon Business Development Department on all matters relating to infrastructure 3 and public works programs and activities administered by the Oregon Infrastructure Finance 4 Authority. 5

(3) Develop a recommended biennial budget for the operation of the authority and submit 6 the budget to the director and the Governor. 7

(4) Seek and receive the views of all levels of government and the private sector with 8 9 respect to state policies and programs to address the infrastructure needs of this state.

(5) Prepare and submit to the Director of the Oregon Business Development Department 10 suggested administrative rules that the board determines are necessary for the operation of 11 12the programs under the direction of the authority.

13 (6) Establish policies and procedures for loan and grant programs administered by the authority. 14

15 SECTION 3. (1) The Oregon Infrastructure Finance Authority is established as an administrative section within the Oregon Business Development Department, subject to the 16 supervision of the administrator of the authority. The authority consists of the administra-17 18 tor and all personnel employed by the authority.

19 (2) The authority shall develop and administer programs and funds of the department that address the infrastructure needs of this state pursuant to the policies of, and as may 20be recommended by, the Oregon Infrastructure Finance Authority Board. 21

22(3) The authority shall provide the Oregon Infrastructure Finance Authority Board with 23staff and other assistance as necessary for the board to perform its duties.

(4) The authority shall employ, in accordance with the State Personnel Relations Law, 24 the staff necessary to allow the authority to carry out its responsibilities. 25

SECTION 3a. (1) The Oregon Infrastructure Finance Authority may: 26

(a) Conduct hearings and conferences to develop facts, explain programs and activities, 27and obtain advice; 28

(b) Enter into agreements with other public bodies, as defined in ORS 174.109, or associ-2930 ations or private persons for services to assist the authority and the Oregon Infrastructure 31 **Finance Authority Board;**

(c) Enter into agreements with other public bodies, as defined in ORS 174.109, the federal 32government, associations or private persons for cooperative endeavors that further pro-33 34 grams administered by the authority;

35 (d) Subject to applicable policies and procedures, enter into agreements for loans, grants or other assistance, including, but not limited to, direct purchase of goods or services, with 36 37 local governments, as defined in ORS 174.116, special government bodies, as defined in ORS 38 174.117, or other eligible applicants for infrastructure development;

(e) Appoint committees, consultants or other persons with expertise in infrastructure-39 related matters to advise the Oregon Infrastructure Finance Authority Board or the au-40 thority; 41

42

(f) Obtain assistance or data from any state agency; or

(g) Perform any other act necessary to carry out the duties of the authority. 43

(2) The authority shall administer the state's participation in the federal Community 44 Development Block Grant funding program authorized by 42 U.S.C. 5301 et seq. 45

<u>SECTION 4.</u> (1) The Director of the Oregon Business Development Department, upon consultation with and the approval of the Oregon Infrastructure Finance Authority Board, shall appoint an administrator of the Oregon Infrastructure Finance Authority who shall serve at the pleasure of the director.

5 (2) The administrator shall receive such salary as may be provided by law or as fixed by 6 the director.

(3) The administrator shall be the administrative head of the authority.

8 (4) The administrator may suggest rules to the director for the government of the au-9 thority, the conduct of its employees, the assignment and performance of its business and 10 the custody, use and preservation of its records, papers and property.

(5) The administrator shall hire the staff necessary to allow the authority to carry out
 its duties. In accordance with the State Personnel Relations Law, the administrator and any
 manager hired by the administrator shall be in the unclassified service.

SECTION 5. (1) The Oregon Infrastructure Finance Fund is established in the State 14 15 Treasury, separate and distinct from the General Fund. Interest earned by the Oregon Infrastructure Finance Fund shall be credited to the fund. The Oregon Infrastructure Fi-16 nance Fund consists of all moneys credited to the fund, including moneys from the Admin-17 18 istrative Services Economic Development Fund, federal funds collected or received and fees, moneys or other revenues, including miscellaneous receipts, collected or received by the 19 20Oregon Infrastructure Finance Authority. The moneys in the Oregon Infrastructure Finance Fund are continuously appropriated to the Oregon Business Development Department for the 2122authority for the purposes of sections 1a to 7 of this 2009 Act.

(2) The authority may finance programs and projects determined to further
 infrastructure development within this state by making grants or loans using moneys in the
 fund.

(3) The Oregon Infrastructure Finance Authority Board may suggest to the Director of
 the Oregon Business Development Department administrative rules for establishing stan dards, objectives and criteria for use of moneys in the fund. The department shall adopt rules
 to establish standards, objectives and criteria for use of moneys in the fund.

30 <u>SECTION 6.</u> The Oregon Infrastructure Finance Authority may not direct, supervise or 31 control the policy, programs, personnel or administration of any program or entity unless 32 specifically authorized by statute.

33 <u>SECTION 7.</u> The Director of the Oregon Business Development Department, in accord-34 ance with ORS chapter 183, may adopt rules for the operation of the Oregon Infrastructure 35 Finance Authority as the director determines necessary or convenient for the authority to 36 perform its duties and functions and as are consistent with and necessary to carry out the 37 policies established by the Oregon Infrastructure Finance Authority Board.

285A.010. As used in ORS 284.101 to 284.146 and ORS chapters 285A, 285B and 285C, unless the
 context requires otherwise:

45 (1) "Administrator" means the administrator of the Oregon Infrastructure Finance Au-

2	(2) "Association" means a nonprofit, private, incorporated or unincorporated institution,

4	operating or doing business in Oregon.

17	designated as a distressed area by the department, based on indicators of economic distress or dis-
18	location, including but not limited to unemployment, poverty and job loss.
19	[(6)] (10) "International trade" means the export and import of products and services and the
20	movement of capital for the purpose of investment.
21	(11) "Local government" has the meaning given that term in ORS 174.116.
22	(12) "Municipality" means an Oregon city or county, the Port of Portland created by ORS
23	778.010, a county service district organized under ORS chapter 451, a district as defined in
24	ORS 198.010, a tribal council of a federally recognized Indian tribe in this state or an airport
25	district organized under ORS chapter 838.
26	(13) "Public body" has the meaning given that term in ORS 174.109.
27	[(7)] (14) "Rural area" means an area located entirely outside of the acknowledged Portland
28	Metropolitan Area Regional Urban Growth Boundary and the acknowledged urban growth bounda-
29	ries of cities with populations of 30,000 or more.
30	[(8) "Traded sector" means industries in which member firms sell their goods or services into
31	markets for which national or international competition exists.]
32	[(9)] (15) "Small business" means a business having 100 or fewer employees.
33	(16) "State agency" includes state officers, departments, boards and commissions.
34	(17) "Traded sector" means industries in which member firms sell their goods or services
35	into markets for which national or international competition exists.
36	SECTION 9. ORS 285A.020 is amended to read:

10 (2)(a) The term of office of each member appointed by the Governor is four years, but a member 11 serves at the pleasure of the Governor. Before the expiration of the term of a member appointed by 12 the Governor, the Governor shall appoint a successor whose term begins on July 1 of the following 13 year. A member appointed by the Governor is eligible for reappointment. In case of a vacancy among 14 the members appointed by the Governor for any cause, the Governor shall appoint a person to fill 15 the office for the unexpired term.

(b) The term of office of the member appointed by the President of the Senate is four years. In
case of a vacancy for any cause, the President of the Senate shall appoint a Senator to fill the office
for the unexpired term.

(c) The term of office of the member appointed by the Speaker of the House of Representatives
is two years. In case of a vacancy for any cause, the Speaker of the House of Representatives shall
appoint a Representative to fill the office for the unexpired term.

(3) A member of the commission who is appointed by the Governor is entitled to compensation
and expenses as provided by ORS 292.495. [*Ex officio*] Legislative members of the commission are
prohibited from receiving compensation and reimbursement for expenses.

(4) Subject to confirmation by the Senate, the Governor shall appoint one of the voting commissioners as presiding officer of the commission. The presiding officer shall have duties and powers
as the commission determines are necessary for the office.

(5) Five voting members of the commission constitute a quorum for the transaction of business.

(6) The commission shall meet at least quarterly at a time and place determined by the commission. The commission shall also meet at other times and places as are specified by the call of the presiding officer or by the call of a majority of the voting members of the commission.

(7) A vacancy among the voting members of the commission does not impair the right of the remaining voting commissioners to exercise all the powers of the commission. If the remaining voting commissioners are unable to agree, the Governor shall have the right to vote as a member of the commission.

(8) A member of the commission appointed due to expertise or training in local economic
 development described in subsection (1)(c)(C)(iv) of this section shall also be an elected local
 government official with experience in economic development matters.

Commission shall develop and maintain [*an*] the economic [*and community*] development policy and
strategy for this state [*that implements the strategy declared*] outlined in ORS 285A.020 [(3)].
