# House Bill 2169

### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Modifies crime of failure to report as sex offender and procedures related to sex offender reporting.

#### A BILL FOR AN ACT

Relating to sex offender reporting; creating new provisions; and amending ORS 181.595, 181.596,
 181.597 and 181.599.

4 Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 181.595 is amended to read:

6 181.595. (1)(a) Except as otherwise provided in paragraph (b) of this subsection, the agency or 7 official to whom a person reports under subsection (3) of this section shall complete a sex offender 8 registration form concerning the person when the person reports under subsection (3) of this section.

9 (b) When a person who is under supervision reports to the agency supervising the person, the 10 supervising agency may require the person to report instead to the Department of State Police, a 11 chief of police or a county sheriff and provide the supervising agency with proof of the completed 12 registration.

13 (2) Subsection (3) of this section applies to a person who:

(a) Is discharged, paroled or released on any form of supervised or conditional release from a
 jail, prison or other correctional facility or detention facility in this state at which the person was
 confined as a result of:

18 (B) Having been found guilty except for insanity of a sex crime; or

19 (C) Having been found to be within the jurisdiction of the juvenile court for having committed 20 an act that if committed by an adult would constitute a sex crime;

(b) Is paroled to this state under ORS 144.610 after being convicted in another jurisdiction of a
 crime that would constitute a sex crime if committed in this state;

(c) Is paroled to or otherwise placed in this state after having been found by a court in another
jurisdiction to have committed an act while the person was under 18 years of age that would constitute a sex crime if committed in this state by an adult;

(d) Is discharged or placed on conditional release by the juvenile panel of the Psychiatric Security Review Board after having been found to be responsible except for insanity under ORS
419C.411 for an act that would constitute a sex crime if committed by an adult; or

(e) Is discharged by the court under ORS 161.329 after having been found guilty except for in sanity of a sex crime.

15	changed residence.

8	181.599. (1) A person who is required to report as a sex offender and who has knowledge of the
9	reporting requirement commits the crime of failure to report as a sex offender if the person fails,
10	as required by ORS 181.595, 181.596 or 181.597, to:
11	(a) Make the initial report to the appropriate agency or official;
12	(b) Report when the person works at, carries on a vocation at or attends an institution of higher
13	education;
14	(c) Report following a change of residence, school enrollment or employment status, including
15	enrollment, employment or vocation status at an institution of higher education;
16	(d) Make an annual report; [or]
17	(e) Provide complete and accurate information;
18	(f) Sign the sex offender registration form as required; or
19	(g) Submit to fingerprinting or to having a photograph taken of the person's face, iden-
20	tifying scars, marks or tattoos.
21	(2) Except as otherwise provided in subsection (3) of this section, failure to report as a sex
22	offender is a Class A misdemeanor.
23	(3) Failure to report as a sex offender is a Class C felony if the person violates:
24	(a) Subsection (1)(a) of this section; or
25	(b) Subsection (1)(b), [or] (c) or (f) of this section and the crime for which the person is required
26	to report is a felony.
27	(4) A person who fails to sign and return an address verification form as required by ORS
28	181.598 (2) commits a violation.
29	SECTION 5. The amendments to ORS 181.595, 181.596, 181.597 and 181.599 by sections 1
30	to 4 of this 2009 Act apply to persons required to report on or after the effective date of this
31	2009 Act.
