9 "SECTION 3. (1) The Oregon University System Fund is established in the State Treasury, separate and distinct from the General Fund. Any interest or other investment income derived from 10 11 moneys in the Oregon University System Fund is credited to the fund. Except when otherwise 12 specified by a statute establishing an account, the interest or other investment income credited to 13 the Oregon University System Fund that was derived from tuition and fees, facility and administra-14 tive cost recoveries, sales and services revenues, housing fees, food service fees, parking fees and 15 General Fund appropriations shall be transferred to the General Fund by the State Board of Higher Education. 16

17 "(2) Except for moneys otherwise designated by statute or federal law, all moneys received by 18 the State Board of Higher Education or the Oregon University System shall be paid into the State 19 Treasury and credited to the Oregon University System Fund. All moneys in the fund are contin-

20 uously appropriated to the State Board of Higher Education for purposes authorized by law.".

Interest earned on moneys in the account shall be cred-35 ited to the account. The account may not be credited with more than \$4,000,000 in interest, do1 nations and federal and local government funds for purposes of this subsection.

"(3) Moneys in the account shall be considered to be General Fund moneys for purposes of section 1 (3), Article XI-G of the Oregon Constitution, are continuously appropriated to the [Department of Higher Education] **Oregon University System** and may be transferred to the [Department of Higher Education Capital Construction Fund] account designated by ORS 351.626 for the animal sciences pavilion project described in subsection (1) of this section.

8 "351.508. (1) There is established in the General Fund an account to be known as the Oregon 9 State University Steam Plant Account. Funds in the account shall be used for the construction, re-10 modeling, expansion and renovation of facilities for a steam plant at Oregon State University.

"(2) The account shall consist of grant funds, loan funds, business energy tax credit proceeds and federal and local government funds made available to and funds donated to the Oregon University System for the purpose of the steam plant project described in subsection (1) of this section. Interest earned on moneys in the account shall be credited to the account. The account may not be credited with more than \$12,000,000 in interest, donations, grant funds, loan funds, tax credit proceeds and federal and local government funds for purposes of this subsection.

"(3) Moneys in the account shall be considered to be General Fund moneys for purposes of section 1 (3), Article XI-G of the Oregon Constitution, are continuously appropriated to the [Department of Higher Education] Oregon University System and may be transferred to the [Department of Higher Education Capital Construction Fund] account designated by ORS 351.626 for the steam plant project described in subsection (1) of this section.
