ORS 477.755, as amended by section 9, chapter 685, Oregon Laws 2003, and sec-2122tion 12, chapter 802, Oregon Laws 2005, is amended to read: "477.755. (1) Notwithstanding ORS 291.238, the moneys in the Oregon Forest Land Protection 23Fund are appropriated continuously to the Emergency Fire Cost Committee and shall be used for 24 equalizing emergency fire suppression costs for safeguarding forestland in any forest protection 2526 district, and for necessary administrative expenses. "Sec. 11. The amendments to ORS 477.755 by section 9, chapter 685, Oregon Laws 2003, and
section 12, chapter 802, Oregon Laws 2005, become operative July 1, [2009] 2011.

9 "SECTION 4. This 2009 Act being necessary for the immediate preservation of the public
10 peace, health and safety, an emergency is declared to exist, and this 2009 Act takes effect
11 July 1, 2009.".
