House Bill 2646

Sponsored by COMMITTEE ON REVENUE

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Expands eligibility for certain forestland special assessments to include certain lands used for intensively managed hardwood timber production. Lengthens rotation cycle for harvesting intensively managed hardwood timber on lands eligible for farm use special assessment from 12 years to 20 years.

Applies to property tax years beginning on or after July 1, 2010.

6 **SECTION 1.** ORS 308A.056 is amended to read:

7 308A.056. (1) As used in ORS 308A.050 to 308A.128, "farm use" means the current employment

8 of land for the primary purpose of obtaining a profit in money by:

9 (a) Raising, harvesting and selling crops;

10 (b) Feeding, breeding, managing or selling livestock, poultry, fur-bearing animals or honeybees

ORS chapter 321, except land used exclusively for growing cultured Christmas trees or land [described in ORS 321.267 (3) or 321.824 (3) (relating to land used to grow certain hardwood timber, including hybrid cottonwood).] used exclusively to grow certain intensively managed hardwood

28 (3) For purposes of this section, land is currently employed for farm use if the land is:

- 29 (a) Farmland, the operation or use of which is subject to any farm-related government program;
- 30 (b) Land lying fallow for one year as a normal and regular requirement of good agricultural

2 (c) Land planted in orchards or other perennials, other than land specified in paragraph (d) of this subsection, prior to maturity; 3

(d) Land not in an exclusive farm use zone that has not been eligible for assessment at special 4 farm use value in the year prior to planting the current crop and has been planted in orchards, 5 cultured Christmas trees or vineyards for at least three years; 6

(e) Wasteland, in an exclusive farm use zone, dry or covered with water, neither economically 7 tillable nor grazeable, lying in or adjacent to and in common ownership with farm use land and that 8 9 is not currently being used for any economic farm use;

(j) Land [described under ORS 321.267 (3) or 321.824 (3) (relating to land] used to grow certain 2122intensively managed hardwood timber, including hybrid cottonwood[)];

23(k) Land used for the primary purpose of obtaining a profit in money by breeding, raising, kenneling or training greyhounds for racing; or 24

25(L) Land used for the processing of farm crops into biofuel, as defined in ORS 315.141, if:

(i) Only the crops of the landowner are being processed; 26

27(ii) The biofuel from all of the crops purchased for processing into biofuel is used on the farm of the landowner; or 28

(2) Whether farmland qualifies for special assessment under this section shall be determined as of January 1 of the assessment year.
