

# House Bill 2714

Sponsored by Representative ROBLAN

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Shipping Transport of Aquatic Invasive Species Task Force.  
Sunsets January 2, 2012.

## A BILL FOR AN ACT

1  
2 Relating to aquatic invasive species.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1)(a) There is created the Shipping Transport of Aquatic Invasive Species**  
5 **Task Force.**

6 **(b) The President of the Senate and the Speaker of the House of Representatives shall**  
7 **each appoint two members from among members of the Legislative Assembly to serve in an**  
8 **advisory capacity to the task force.**

9 **(c) The Director of the Department of Environmental Quality may appoint members to**  
10 **the task force who represent the interests of this state and federal, State of Washington,**  
11 **maritime, environmental and academic interests.**

12 **(2) The purpose of the task force is to study and make recommendations:**

13 **(a) For combating the introduction of aquatic nonindigenous species associated with**  
14 **shipping-related transport into the waters of this state; and**

15 **(b) On changes to the ballast water program established in ORS 783.625 to 783.640, in-**  
16 **cluding but not limited to the following considerations:**

17 **(A) Shipping industry compliance with ORS 783.625 to 783.640;**

18 **(B) Practicable and cost-effective ballast water treatment technologies;**

19 **(C) Appropriate standards for discharge of treated ballast water into the waters of this**  
20 **state;**

21 **(D) The compatibility of ORS 783.625 to 783.640 with new laws enacted by the United**  
22 **States Congress, regulations promulgated by the United States Coast Guard and ballast wa-**  
23 **ter management programs established by the States of Alaska, California and Washington**  
24 **and the Province of British Columbia;**

25 **(E) Practicable and cost-effective techniques to combat the introduction of aquatic**  
26 **nonindigenous species associated with shipping-related transport into the waters of this**  
27 **state; and**

28 **(F) Appropriate regulations and standards to combat the introduction of aquatic**  
29 **nonindigenous species associated with shipping-related transport into the waters of this**  
30 **state.**

31 **(3) Portland State University may provide staff support or coordination assistance to the**

1 task force, subject to available funding from gifts, grants or donations.

2 (4) All agencies of state government, as defined in ORS 174.111, are directed to assist the  
3 task force in the performance of its duties and, to the extent permitted by laws relating to  
4 confidentiality, to furnish such information and advice as the members of the task force  
5 consider necessary to perform their duties.

6 (5) A majority of the members of the task force constitutes a quorum for the transaction  
7 of business.

8 (6) Official action by the task force requires the approval of a majority of the members  
9 of the task force.

10 (7) The task force shall elect one of its members to serve as chairperson.

11 (8) The task force, in consultation with the Invasive Species Council established pursuant  
12 to ORS 561.687, shall submit a report, including recommendations for legislation, to an in-  
13 terim committee of the Legislative Assembly related to natural resources no later than Oc-  
14 tober 1, 2010.

15 (9) Notwithstanding ORS 171.072, members of the task force who are members of the  
16 Legislative Assembly are not entitled to mileage expenses or a per diem and serve as volun-  
17 teers on the task force. Other members of the task force are not entitled to compensation  
18 or reimbursement for expenses and serve as volunteers on the task force.

19 (10) As used in this section:

20 (a) "Aquatic nonindigenous species" means any species or other viable biological material  
21 that enters an ecosystem beyond its historic range.

22 (b) "Waters of this state" has the meaning given that term in ORS 783.625.

23 **SECTION 2.** Section 1 of this 2009 Act is repealed on January 2, 2012.
