## House Bill 2913

Sponsored by COMMITTEE ON REVENUE

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases rate of corporate excise tax using income brackets for tax years beginning on or after January 1, 2009, and before January 1, 2013. Adjusts income brackets annually based on U.S. City Average Consumer Price Index.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

2 Relating to corporate taxation; prescribing an effective date; and providing for revenue raising that

3 requires approval by a three-fifths majority.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> The Legislative Assembly finds that it is necessary for Oregon to restore

6 corporate taxation to a level that ensures that corporations doing business in Oregon are

7 contributing to the infrastructure of this state in the same way as families that also enjoy

8 the privileges, benefits and security of being in Oregon. The revenue generated from corpo-

9 rate taxation via a tax increase combined with a corporate minimum tax should ensure that

10 corporations doing business in Oregon provide an average of 10 to 13 percent of all Oregon

11 income tax revenue.

12 SECTION 2. Section 3 of this 2009 Act is added to and made a part of ORS chapter 317.

13 <u>SECTION 3.</u> (1) Notwithstanding ORS 317.061, for tax years beginning on or after January

1, 2009, and before January 1, 2013, the amount of the tax due under this chapter shall be
determined in accordance with the following table:
