House Bill 3428

Sponsored by Representative THATCHER (at the request of Craig Cox in memory of Judy Cox)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires driver license or identification card issued by Department of Transportation to indicate that person may not purchase alcoholic liquor if person is convicted at least two times of driving while under influence of intoxicants.

Requires licensees and permittees of Oregon Liquor Control Commission to check identification of all persons before selling or serving alcoholic liquor.

Directs commission to cancel or suspend license of licensee who knowingly sells alcoholic liquor to person prohibited from purchasing alcoholic liquor.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Sections 2 and 3 of this 2009 Act are added to and made a part of the Oregon 6 Vehicle Code.

7 <u>SECTION 2.</u> (1) If a person is convicted at least two times of driving while under the in-8 fluence of intoxicants in violation of ORS 813.010 or the statutory counterpart to ORS 813.010 9 in another jurisdiction, the trial judge shall order that the Department of Transportation 10 place an alcohol restriction on the person's driver license or identification card to indicate 11 that the person may not purchase alcoholic liquor.

(2) When a court orders the Department of Transportation to place an alcohol restriction
on a person's driver license or identification card, the court shall send a copy of the order
to the department.

SECTION 3. (1) Upon receiving an order of the court under section 2 of this 2009 Act, the
 Department of Transportation shall cancel the person's driver license or identification card.
 The person shall surrender to the department any driver license or identification card can-

18 celed under this subsection.

(2) The department may reissue a driver license or identification card canceled under
 subsection (1) of this section when the applicant has satisfied all requirements for the driver
 license or identification card.

(3) The fee for reissuance of a driver license under this section shall be the same as the
 fee for replacement of a driver license under ORS 807.370.

(4) The fee for reissuance of an identification card under this section shall be the same
 as the fee for replacement of an identification card under ORS 807.410.

(5) The reissued driver license or identification card must include the words "alcohol re striction" and the date the alcohol restriction expires.

41	counterfeit, duplicate or modify the license without ready detection. The security features used in

43	(a) The authentication of a genuine document in a reasonable time; and
44	(b) The production of the license only by equipment that requires verification of the identity of
45	the operator of the equipment before a license may be produced.

SECTION 5. ORS 807.400, as amended by section 22, chapter 1, Oregon Laws 2008, is amended 1 $\mathbf{2}$ to read: 3 807.400. (1) The Department of Transportation shall issue an identification card to any person who: 4 $\mathbf{5}$ (a) Is domiciled in or is a resident of this state, as described in ORS 807.062; (b) As required by sections 2 and 4, chapter 1, Oregon Laws 2008, furnishes proof of both legal 6 presence in the United States and a Social Security number, or, if the person is not eligible for a 7 Social Security number, proof of legal presence in the United States and proof that the person is 8 9 not eligible for a Social Security number; (c) Does not have a current, valid driver license; 10 (d) Furnishes evidence of the person's full legal name, age and identity as the department may 11 12 require; and 13 (e) Submits to collection of biometric data by the department that establish the identity of the person as provided in ORS 807.024. 14 15 (2) The department shall work with other agencies and organizations to attempt to improve the issuance system for identification cards. 16 17 (3) Every original application for an identification card must be signed by the applicant. 2 [(11)] (12) If a person to whom an identification card was issued and who changes the person's residence address appears in person at a department office that issues identification cards, the de-3 partment may do any of the following: 4

 $\mathbf{5}$ (a) Issue a replacement identification card containing the new address upon receipt of the old identification card and payment of the fee established for issuing a replacement identification card 6 with a changed address under ORS 807.410. Except as otherwise provided in subsection [(13)] (14) 7 of this section, the replacement identification card shall bear the same distinguishing number as the 8 9 card being replaced.

10 (b) Note the new address on the old identification card in a manner to be determined by the department by rule. 11

12 [(12)] (13) An identification card becomes invalid if the holder of the card changes the holder's 13 name from that shown on the card, including a change of name by marriage, without providing the department with notice of the change as required under ORS 807.420. Upon receiving such notice 14 15 and the old identification card, the department shall issue a replacement identification card upon 16 payment of the fee required under ORS 807.410.

[(13)] (14) In the event that, for a reason identified by the department by rule, a person needs 17 18 a replacement identification card that bears a distinguishing number different from the number on 19 the card being replaced, the person to whom the card was issued may obtain a replacement card 20from the department upon furnishing proof satisfactory to the department of the need for such replacement and payment of the replacement fee under ORS 807.410. 21

22[(14)] (15) The department may establish by rule reasons for issuing replacement identification 23cards that are in addition to the reasons identified in subsections [(11) to (13)] (12) to (14) of this section. The fee for a replacement identification card is provided under ORS 807.410. 24

25[(15)] (16) Upon cancellation of an identification card, the card is terminated and must be surrendered to the department. An identification card may be canceled for any of the reasons that 2627driving privileges or a driver license may be canceled under ORS 809.310. The department may reissue an identification card canceled under this subsection when the applicant has satisfied all re-28quirements for the identification card. 29

30 [(16)] (17) Notwithstanding any other provision of this section, the department may issue an 31 identification card to a person under this subsection without charge when the person surrenders the person's driver license or driver permit to the department for reasons described in this subsection. 32If the department issues an identification card under this subsection, the identification card shall 33 34 expire at the same time as the surrendered driver license or driver permit would have expired. An identification card issued under this subsection is subject to the same requirements and fees for 35 renewal or upon expiration as any other identification card issued under this section. The depart-36 37 ment may issue identification cards under this subsection for any of the following reasons:

38 (a) The person voluntarily surrenders the person's driver license or driver permit to the department based upon the person's recognition that the person is no longer competent to drive. 39

40 (b) The person's driving privileges are suspended under ORS 809.419 (1). This paragraph only applies if the person voluntarily surrenders the person's driver license or driver permit to the de-41 partment as provided under ORS 809.500. 42

471.105. Before being qualified to purchase alcoholic liquor from the Oregon Liquor Control 44 Commission, a person must be at least 21 years of age and must have identification as required 45

3	471.130. (1) All licensees and permittees of the Oregon Liquor Control Commission, before selling
4	or serving alcoholic liquor to any person [about whom there is any reasonable doubt of the person's
5	having reached 21 years of age], shall require such person to produce one of the following pieces of
6	identification:
7	(a) The person's passport.
8	(b) The person's motor vehicle operator's license, whether issued in this state or by any other
9	state, so long as the license has a picture of the person.
10	(c) An identification card issued under ORS 807.400.
11	(d) A United States military identification card.
12	(e) Any other identification card issued by a state that bears a picture of the person, the name
13	of the person, the person's date of birth and a physical description of the person.
14	(2) If a person does not have identification as described in subsection (1) of this section, the
15	permittee or licensee shall require such person to make a written statement of age and furnish ev-

2 (A) Has violated any provision of this chapter or ORS 474.115 or any rule of the commission 3 adopted pursuant thereto.

(H) Has misrepresented to a customer or the public any alcoholic liquor sold by the licensee.

(I) Since the granting of the license, has been convicted of a felony, of violating any of the liquor
laws of this state, general or local, or of any misdemeanor or violation of any municipal ordinance
committed on the licensed premises.

(b) That any person licensed to sell at retail for consumption on the premises is acting as an agent of, or is a manufacturer or wholesaler of alcoholic liquors, or has borrowed money or property, or has accepted gratuities or rebates, or has obtained the use of equipment from any manufacturer or wholesaler of alcoholic liquor or any agent thereof.

(c) That there is a history of serious and persistent problems involving disturbances, lewd or 2627unlawful activities or noise either in the premises or involving patrons of the establishment in the immediate vicinity of the premises if the activities in the immediate vicinity of the premises are 28related to the sale or service of alcohol under the exercise of the license privilege. Behavior which 2930 is grounds for cancellation or suspension of a license under this section, where so related to the sale 31 or service of alcohol, includes, but is not limited to obtrusive or excessive noise, music or sound vibrations; public drunkenness; fights; altercations; harassment or unlawful drug sales; alcohol or 32related litter; trespassing on private property; and public urination. Mitigating factors include a 33 34 showing by the licensee that the problems are not serious or persistent or that the licensee has 35 demonstrated a willingness and ability to control adequately the licensed premises and patrons' behavior in the immediate vicinity of the premises which is related to the licensee's sale or service 36 37 of alcohol under the licensee's exercise of the license privilege.

(d) That there is any other reason which, in the opinion of the commission, based on publicconvenience or necessity, warrants canceling or suspending such license.

(2) Civil penalties under this section shall be imposed as provided in ORS 183.745.

41 <u>SECTION 9.</u> Sections 2 and 3 of this 2009 Act and the amendments to ORS 471.105, 42 471.130, 471.315, 807.110 and 807.400 by sections 4 to 8 of this 2009 Act apply to persons who 43 have been convicted at least two times of violating ORS 813.010 or the statutory counterpart 44 to ORS 813.010 in another jurisdiction on or after the effective date of this 2009 Act.
