SENATE AMENDMENTS TO SENATE BILL 107

1 On page 1 of the printed bill, line 2, after "417.030;" insert "appropriating money;".

2 On page 16, after line 35, insert:

3 "E. The Interstate Compact for Juveniles Fund is established, separate and distinct from the 4 General Fund. All moneys in the fund are continuously appropriated to the Oregon Youth Authority 5 to be used for the purposes of meeting financial obligations imposed on the State of Oregon as a 6 result of the state's participation in this compact.

7 "F. An assessment levied or any other financial obligation imposed under this compact is effec-8 tive against the State of Oregon only to the extent that moneys to pay the assessment or meet the 9 financial obligation have been appropriated and deposited in the Interstate Compact for Juveniles 10 Fund.".

11 Delete lines 38 through 45 and insert:

"A. The Director of the Oregon Youth Authority, or the director's designee, shall serve as the
compact administrator for the State of Oregon and as Oregon's commissioner to the Interstate
Commission.

15 "B. The Oregon State Council for Interstate Juvenile Supervision is established, consisting of 16 seven members. The Director of the Oregon Youth Authority, or the director's designee, is a member 17 of the State Council and serves as chairperson of the State Council. Of the remaining members of 18 the State Council:

19 "1. The Governor shall appoint three members, one of whom must represent a crime victims' 20 organization; and

21 "2. The Chief Justice of the Supreme Court, the President of the Senate and the Speaker of the22 House of Representatives shall each appoint one member.

23 "C. The term of office of a member is four years.

²⁴ "D. The State Council shall meet at least once each calendar year.

25 "E. The State Council may advise the compact administrator on participation in the Interstate
26 Commission activities and administration of the compact.

27 "F. Members of the State Council are entitled to expenses as provided in ORS 292.495. Any
28 legislative members are entitled to payment of compensation and expense reimbursement under ORS
29 171.072, payable from funds appropriated to the Legislative Assembly.

30 "G. The State Council is subject to the provisions of ORS 291.201 to 291.222 and 291.232 to 31 291.260.

32 "H. The Oregon Youth Authority shall provide staff support for the State Council.".

33 On page 17, delete lines 1 and 2.

34 On page 19, line 14, delete "compacting states" and insert "State of Oregon unless contrary to 35 the Oregon Constitution". 1 After line 25, insert:

2 "5. The State of Oregon is bound by the bylaws and rules promulgated under this compact only 3 to the extent that the operation of the bylaws and rules does not impose an obligation exceeding 4 any limitation on state power or authority contained in the Oregon Constitution as interpreted by 5 the state courts of Oregon.".

6 Delete lines 28 through 34 and insert:

7 "<u>SECTION 2</u>. Notwithstanding the amendments to ORS 417.030 by section 1 of this 2009

8 Act, ORS 417.030 (2007 Edition) applies to non-compacting states as defined in Article II of

9 the Interstate Compact for Juveniles.".

- 10 In line 35, delete "4" and insert "3".
