## **HOUSE AMENDMENTS TO SENATE BILL 119**

On page 3 of the printed bill, after line 36, insert: 1

 $\mathbf{2}$ "SECTION 5. (1) The Teacher Standards and Practices Commission may issue a letter 3 of informal reproval to a person licensed, registered or certified by the commission if:

4 "(a) Following the completion of an investigation, the commission determines that the  $\mathbf{5}$ person has engaged in conduct that affects the person's ability to be professionally effective, 6 based on standards adopted by the commission by rule; and

"(b) Subject to subsection (5) of this section, the commission agrees not to pursue disci-7 plinary action against the person under ORS 342.175 and the person agrees to the terms of 8 9 the letter of informal reproval, including a monitoring period.

10 "(2) A letter of informal reproval issued as provided by subsection (1) of this section shall 11 establish the terms of a monitoring period for the person to whom the letter is issued.

12"(3) Upon the issuance of a letter of informal reproval, the commission shall notify the 13 employer of the person to whom the letter is issued, including any terms of the letter that 14 the employer may need to know to assist the person in complying with the terms of the 15letter.

"(4) A letter of informal reproval issued as provided by subsection (1) of this section:

17 "(a) Is confidential; and

18 "(b) Except when a disciplinary action is taken as provided in subsection (5) of this sec-19 tion, may not be posted on an interstate clearinghouse related to educator license sanctions.

20 "(5) If a person fails to comply with the terms of a letter of informal reproval, the com-21mission may take disciplinary action against the person based on one or both of the follow-22ing:

23 "(a) The conduct underlying the letter of informal reproval; or

24

"(b) The failure to comply with the terms of the letter of informal reproval.

25"(6) If the executive director of the commission determines that a person failed to meet the terms of a letter of informal reproval, the executive director shall report the failure to 2627the commission for the commission to make a final determination pursuant to ORS 342.176.

28"(7) The documents and materials used in an investigation for the purposes of this sec-29tion are confidential and are not subject to public inspection unless the commission makes a final determination to discipline the person pursuant to ORS 342.175. 30

"SECTION 6. Section 5 of this 2009 Act is repealed on June 30, 2012.

32"SECTION 7. The Teacher Standards and Practices Commission shall submit a report to 33 the interim legislative committees related to education no later than October 1, 2012, that 34 evaluates the effectiveness of letters of informal reproval as provided by section 5 of this 352009 Act.".
