SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes definitions for landscape construction professional and landscape contracting business. Makes persons exempted from other landscaping laws subject to prohibitions against misleading or false advertising or other representations regarding licensure status. Exempts plumbing contractors and journeyman plumbers from certain landscaping laws and requirement to obtain construction contractor license when performing certain types of work on irrigation systems. **Removes exemption from landscape architect statutes for landscaping work exempted from landscape contractor statutes.**
