#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of State Board of Clinical Social Workers to State Board of Licensed Social Workers.

Provides for registration of social workers with baccalaureate degrees and for licensing of social workers with master's degrees. Provisions relating to registration of baccalaureate social workers and licensing of master's social workers become operative on January 1, 2011.

Exempts certain persons from licensure and certification requirements for practice of clinical social work.

Increases civil penalty for certain violations of social worker regulatory statutes from \$1,000 to \$3,000 per violation. Permits board to impose civil penalty of up to \$5,000 on certain persons who practice or present themselves as qualified to practice clinical social work without license or certificate. Permits board to impose civil penalty of up to \$3,000 on certain persons who present themselves as regulated social workers or who use title "social worker" to indicate authorization to practice regulated social work.
