16	"(5) Members of the commission who are members of the Legislative Assembly are entitled to

18	not entitled to compensation but a member may be reimbursed for actual and necessary travel and
19	other expenses incurred by the member in the performance of the member's official duties in the
20	manner and amount provided in ORS 292.495.".

22	"(12) The Department of Education shall solicit and award a public contract for services pro-
23	vided by the commission, including the maintenance of the public website and the provision of as-
24	sistance to local school districts. A contract may be procured only as provided by ORS 279B.060 and
25	may not be procured as a sole-source procurement under ORS 279B.075, an emergency procurement
26	under ORS 279B.080 or a special procurement under ORS 279B.085.".

28	Professional Development Commission".
29	In line 32, delete "Six" and insert "Five".
30	In line 33, delete "Six" and insert "Five".
31	In line 35, after "(1)" insert "(a)" and delete "Education Enterprise Steering Commission" and
32	insert "Oregon Educator Professional Development Commission".
33	In line 37, delete "(a)" and insert "(A)".
34	Delete lines 39 and 40 and insert:
35	"(B) Assist local school districts in developing professional development plans to meet school

- 1 improvement objectives.
- 2 "(b) The commission is not restricted to performing the activities described in paragraph (a) of 3 this subsection.".
- 4 On page 3, line 8, delete "Education Enterprise Steering Commission" and insert "Oregon Edu-5 cator Professional Development Commission".
