## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Allows Department of Education to enter into contracts with private entities to perform audits of business practices of school districts and education service districts.]

Imposes duty on Department of Education to evaluate business practices of school districts and education service districts.

Allows department to enter into contracts with Secretary of State to audit business practices of districts and with any other entity to evaluate business practices.

## **3 Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 326.133 is amended to read:

5 326.133. (1) The Department of Education, in consultation with the District Best Business Prac-

6 tices Advisory Committee, shall establish a system for auditing and evaluating the business prac-

tices of districts. The department shall develop a list of best business practices to use for the district
audits and evaluations.

9 (2) Only those districts that volunteer for [*the audit*] **an audit or an evaluation** will be audited 10 **or evaluated** under this section.

11 [(3) The department shall contract with the Secretary of State to audit districts based on the list 12 of best business practices.]

(3)(a) The department shall enter into contracts to audit and evaluate the business
 practices of districts. Contracts may be entered into with the Secretary of State for audits
 and with any other entity for evaluations.

(b) Contracts entered into under this section shall comply with the competitive bidding
 requirements of ORS chapters 279A and 279B.

(4) The [secretary] department shall report the results of [the audit first] an audit or an evaluation to the Governor, the State Board of Education and the district that was the subject of the audit or the evaluation. [Then the secretary] After making the reports required by this subsection, the department may post the results of the audit or the evaluation on the Internet.

If there is a vacancy for any cause, the appointing authority shall make an appointment to become immediately effective. 32(9) The department shall provide staff support to the advisory committee. 33 34 (10) Members of the advisory committee who are not members of the Legislative Assembly are 35 not entitled to compensation, but may be reimbursed for actual and necessary travel and other expenses incurred by them in the performance of their official duties in the manner and amounts pro-36 37 vided for in ORS 292.495. Claims for expenses incurred in performing functions of the advisory 38 committee shall be paid out of funds appropriated to the department for that purpose. (11) All agencies of state government, as defined in ORS 174.111, and all districts are directed 39 to assist the advisory committee in the performance of its duties and, to the extent permitted by 40 laws relating to confidentiality, to furnish such information and advice as the members of the advi-41 sory committee consider necessary to perform their duties. 4243
