26	On page 5, line 9, delete " $(4)(b)$ " and insert " (4) ".

29	able to the land use regulation on the date the claim is filed.".

31	"(B) By appraisals showing the value of the land and harvestable timber, with and without ap-
32	plication of the land use regulation, conducted in accordance with generally accepted forest industry
33	practices for determining the value of timberland.".
34	On <u>page 6</u> , after line 16, insert:
35	"(8) For a claim based on a land use regulation described in ORS 195.300 (14)(e), an authori-

- 1 zation granted to a claimant under subsection (5)(b) or (6)(b) of this section may be used by an owner
- 2 of the property subsequent to the owner who filed the claim.".

- 5 "(2) For a claim based on a land use regulation described in ORS 195.300 (14)(e), an owner:
- 6 "(a) May file a claim only for property that is a lawfully established unit of land;

"(b) May file separate claims for different lawfully established units of land at the same or different times based on the same land use regulation; and

9 "(c) May not file multiple claims for the same lawfully established unit of land based on the 10 same land use regulation.".
