Senate Bill 897

Sponsored by COMMITTEE ON COMMERCE AND WORKFORCE DEVELOPMENT

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases membership of Public Employees Retirement Board from five to seven members. Provides that one new member must be public employee who is in appropriate bargaining unit or retired member of Public Employees Retirement System who retired from position in appropriate bargaining unit. Provides that one new member must have experience in business management, pension management or investing and may not be member of system, beneficiary of member of system, or have any interest in benefits provided by system.

Allows member of system to request verification of retirement data before retirement. Provides that, at member's retirement, board may not use creditable service or final average salary less than that specified in verification, as adjusted by reason of member's service and salary after date specified in verification.

Provides that retired members of Oregon Public Service Retirement Plan are eligible for coverage under health insurance plans contracted for by Public Employees Retirement Board.

Requires that member receive retirement credit for certain retroactive payments of salary. Declares emergency, effective on passage.

6	MEMBERSHIP OF PUBLIC EMPLOYEES RETIREMENT BOARD
7	
8	SECTION 1. ORS 238.630 is amended to read:
9	238.630. (1) The governing authority of the Public Employees Retirement System shall be a
10	board known as the Public Employees Retirement Board and consisting of [five] seven members
11	appointed by the Governor subject to confirmation by the Senate in the manner provided in ORS
12	171.562 and 171.565. Except as otherwise provided in ORS 238.640, the term of each member shall
13	be three years. The Governor shall designate one member to serve as chairperson, who shall serve
14	as chairperson at the pleasure of the Governor.
15	(2) The board shall have:
16	(a) The powers and privileges of a corporation, including the right to sue and be sued in its own
17	name as such board; and
18	(b) The power and duty, subject to the limitations of this chapter and ORS chapter 238A, of
19	managing the system.
20	(3) The board:
21	(a) Shall arrange for actuarial service for the system;
22	(b) Shall employ a director;
23	(c) Shall create such other positions as it deems necessary to sound and economical adminis-
24	tration of the system, which positions the director shall fill by appointment;

1 (d) Shall, with the approval of the Director of the Oregon Department of Administrative Ser-2 vices, and as otherwise provided by law, fix the salaries of all persons employed for purposes of 3 administering the system;

4 (e) Shall publish and distribute to all employer and employee members of the system an annual 5 report including a summary of investments of moneys in the fund, investment earnings, significant 6 legislative or administrative changes in the system and other pertinent information on the operation 7 of the system for the preceding year;

8 (f) Shall determine the actuarial equivalency of optional forms of retirement allowances and 9 pensions and adopt for that purpose the necessary actuarial equivalency factor tables in the manner 10 provided by ORS 238.607, which shall constitute a part of the system; and

(g) Shall adopt rules and take all actions necessary to maintain qualification of the Public Em-11 12 ployees Retirement System and the Public Employees Retirement Fund as a qualified governmental 13 retirement plan and trust under the Internal Revenue Code and under regulations adopted pursuant to the Internal Revenue Code. Rules under this paragraph may impose limits on contributions to the 14 15 system, limits on benefits payable from the system and other limitations or procedures required or 16 imposed under federal law or regulation for the purpose of qualification of the Public Employees Retirement System and Public Employees Retirement Fund under the Internal Revenue Code as a 17 18 governmental retirement plan and trust.

(4) The board established by this section shall succeed to all the duties and prerogatives of the
Public Employees Retirement Board created by chapter 401, Oregon Laws 1945, in relation to the
Public Employees Retirement Fund, and in addition shall perform all duties required of it by ORS
237.950 to 237.980, in regard to moneys payable to or from such fund.

(5) The board shall identify by rule those records that must be maintained by participating public employers for the purposes of subsection (3)(g) of this section. A participating public employer shall maintain records for all employees who are members of the system as required by board rules, and shall provide that information to the board upon request.

SECTION 2. ORS 238.640 is amended to read:

28 238.640. (1) All members of the Public Employees Retirement Board must be at least 21 years 29 of age, be citizens of the United States and have been residents of the state for at least two years 30 immediately preceding appointment to the board.

31 (2) One member of the board must be:

(a) An employee of the state in a management position at the time of appointment and
 throughout the term of appointment; or

(b) A person who holds an elective office, by election or appointment, in the governing body ofa participating public employer, other than the state.

(3) [One] A second member must be a public employee, as defined in ORS 243.650, who is in an appropriate bargaining unit, as defined in ORS 243.650, and who has an exclusive representative at the time of the member's appointment and throughout the term of the member. Membership on the board does not affect the status of the person as a public employee, as defined in ORS 243.650.

40 (4) A third member must either meet the qualifications specified in subsection (3) of this
41 section or be a retired member of the Public Employees Retirement System who retired from
42 a position in an appropriate bargaining unit as defined in ORS 243.650.

[(4)] (5) [Three] Four members of the board must have experience in business management,
 pension management or investing. A member appointed under this subsection may not be a member
 of the Public Employees Retirement System or a beneficiary of a member of the system, and may

1 not have any interest in benefits provided by the system.

2 [(5)] (6) Notwithstanding the qualifications established for members of the board under this 3 section, all members of the board have the same fiduciary duties and must exercise the same degree 4 of independent judgment.

5 [(6)] (7) Any vacancy on the board shall be filled by appointment for the unexpired term of the 6 member replaced. Members of the board may be reappointed.

7 [(7)] (8) Except as provided in subsection [(8)] (9) of this section, a member of the board is en-8 titled to compensation and expenses as provided in ORS 292.495 from the Public Employees Retire-9 ment Fund.

10 [(8)] (9) Any member of the board who is an active member of the system shall be released by the participating public employer who employs the member for the purpose of conducting the official 11 12 business of the board. The wages or salary of the member shall not be reduced during periods that 13 the member is released from duty for the purpose of conducting the official business of the board. The board shall reimburse a public employer for the cost of continuing the wages or salary of the 14 15 member while the member is released from duty under this subsection. A member who continues to 16 receive wages or salary under the provisions of this subsection shall not receive compensation under ORS 292.495, but shall receive travel and other expenses provided for under ORS 292.495. 17 The 18 provisions of this subsection do not apply to any person who is a member of the board and who 19 holds another office that is subject to the provisions of section 10, Article II of the Oregon Consti-20 tution, prohibiting the holding of more than one lucrative office.

SECTION 3. ORS 293.706 is amended to read:

22 293.706. (1) There is created the Oregon Investment Council, consisting of five voting members 23 and one nonvoting member.

(2) The Governor shall appoint four voting members, subject to Senate confirmation in the
manner provided in ORS 171.562 and 171.565. The members appointed by the Governor must be
qualified by training and experience in the field of investment or finance.

(3) The Governor may appoint a member of the council under subsection (2) of this section who
is also a member of the Public Employees Retirement Board appointed under ORS 238.640 [(4)] (5).
Except as provided in this subsection, members appointed by the Governor may not hold any other
public office or public employment.

31 (4) The State Treasurer shall be a voting member.

(5) The Director of the Public Employees Retirement System shall be an ex officio member of
 the council with no voting power.

(6) The term of office of each appointed member of the council is four years, but each appointed
member serves at the pleasure of the Governor. A vacancy in the appointed membership occurring
other than by expiration of term shall be filled in the same manner as the original appointment, but
for the unexpired term only.

year specified in the verification to the member's effective retirement date, in accordance 1 with rules adopted by the board. The amount of unused sick leave at retirement shall be 2 adjusted for the leave used and accrued after the date specified in the verification. 3

(4) A member shall be provided with one verification under this section at no cost. The 4 board may establish procedures for recovering administrative costs from members for ser-5 vices in providing additional verifications. 6

12 238A.050. (1) The Oregon Public Service Retirement Plan is part of the Public Employees Re-13 tirement System and is administered by the Public Employees Retirement Board.

(2) Section 7 of this 2009 Act and ORS 238.225, 238.229, 238.231, 238.410, 238.445, 238.450, 14 15 238.455, 238.458, 238.460, 238.465, 238.470, 238.600, 238.601, 238.605, 238.610, 238.615, 238.618, 238.630, 238.635, 238.640, 238.645, 238.655, 238.660, 238.661, 238.665, 238.675, 238.692, 238.694, 238.695, 238.696, 16 238.698, 238.700, 238.705, 238.710 and 238.715 apply to the Oregon Public Service Retirement Plan. 17

The Oregon Investment Council may invest assets of the indi-2122vidual account program and pension program differently than the other assets of the Public Em-23ployees Retirement System.

(4) Investment of the assets of the Oregon Public Service Retirement Plan is not subject to the 94 limitations imposed by ORS 293.726 (6). 25

(5) The board may contract with a private provider for the administration of the individual ac-2627count program. The board is not subject to the provisions of ORS chapter 279A or 279B in awarding a contract under the provisions of this subsection. The board shall establish procedures for inviting 28proposals and awarding contracts under this subsection. 29

RETIREMENT CREDIT FOR RETROACTIVE PAYMENTS

SECTION 9. Section 10 of this 2009 Act is added to and made a part of ORS chapter 238. 33 34 SECTION 10. (1) For the purpose of computing salary under this chapter and ORS chap-35ter 238A, the salary of a member includes retroactive payments made to an employee to correct a clerical error. 36

37 (2) For the purpose of computing salary under this chapter and ORS chapter 238A, the 38 salary of a member includes retroactive payments made to an employee pursuant to a judgment, administrative order, arbitration award, conciliation agreement or settlement agree-39 ment that resolves a dispute or claim based on an employee's rights under employment or 40 wage law or under a collective bargaining agreement. 41

42(3) Retroactive payments included in a member's salary under this subsection shall be allocated to and deemed paid in the periods in which the work was done or in which the work 43 would have been done, and the member shall receive retirement credit for the period of time 44 to which the payment is allocated. 45

2 238.005. For purposes of this chapter:

3 (1) "Annuity" means payments for life derived from contributions made by a member as provided4 in this chapter.

(2) "Board" means the Public Employees Retirement Board.

6 (3) "Calendar year" means 12 calendar months commencing on January 1 and ending on De-7 cember 31 following.

8 (4) "Continuous service" means service not interrupted for more than five years, except that 9 such continuous service shall be computed without regard to interruptions in the case of:

(a) An employee who had returned to the service of the employer as of January 1, 1945, and
who remained in that employment until having established membership in the Public Employees
Retirement System.

(b) An employee who was in the armed services on January 1, 1945, and returned to the service of the employer within one year of the date of being otherwise than dishonorably discharged and remained in that employment until having established membership in the Public Employees Retirement System.

(5) "Creditable service" means any period of time during which an active member is being paid a salary by a participating public employer and for which benefits under this chapter are funded by employer contributions and earnings on the fund. For purposes of computing years of "creditable service," full months and major fractions of a month shall be considered to be one-twelfth of a year and shall be added to all full years. "Creditable service" includes all retirement credit received by a member.

(6) "Earliest service retirement age" means the age attained by a member when the member
 could first make application for retirement under the provisions of ORS 238.280.

(7) "Employee" includes, in addition to employees, public officers, but does not include:

(a) Persons engaged as independent contractors.

(b) Seasonal, emergency or casual workers whose periods of employment with any public em ployer or public employers do not total 600 hours in any calendar year.

(c) Persons, other than workers in the Oregon Industries for the Blind under ORS 346.190, pro vided sheltered employment or made-work by a public employer in an employment or industries
 program maintained for the benefit of such persons.

(d) Persons employed and paid from federal funds received under the Emergency Job and Unemployment Assistance Act of 1974 (Public Law 93-567) or any other federal program intended primarily to alleviate unemployment. However, any such person shall be considered an "employee" if not otherwise excluded by paragraphs (a) to (c) of this subsection and the public employer elects to have the person so considered by an irrevocable written notice to the board.

(e) Persons who are employees of a railroad, as defined in ORS 824.020, and who, as such employees, are included in a retirement plan under federal railroad retirement statutes. This paragraph
shall be deemed to have been in effect since the inception of the system.

(8) "Final average salary" means whichever of the following is greater:

(a) The average salary per calendar year paid by one or more participating public employers to
an employee who is an active member of the system in three of the calendar years of membership
before the effective date of retirement of the employee, in which three years the employee was paid
the highest salary. The three calendar years in which the employee was paid the largest total salary
may include calendar years in which the employee was employed for less than a full calendar year.

1 If the number of calendar years of active membership before the effective date of retirement of the

2 employee is three or fewer, the final average salary for the employee is the average salary per cal-

3 endar year paid by one or more participating public employers to the employee in all of those years,

4 without regard to whether the employee was employed for the full calendar year.

(9) "Firefighter" does not include a volunteer firefighter, but does include:

9 (a) The State Fire Marshal, the chief deputy fire marshal and deputy state fire marshals; and

(b) An employee of the State Forestry Department who is certified by the State Forester as a
 professional wildland firefighter and whose primary duties include the abatement of uncontrolled
 fires as described in ORS 477.064.

(10) "Fiscal year" means 12 calendar months commencing on July 1 and ending on June 30 fol lowing.

(12)(a) "Member" means a person who has established membership in the system and whose
membership has not been terminated as described in ORS 238.095. "Member" includes active, inactive and retired members.

(c) "Inactive member" means a member who is not employed in a qualifying position, whose

(g) Police officers appointed under ORS 276.021 or 276.023.

(h) Employees of the Port of Portland who are classified as airport police by the Board ofCommissioners of the Port of Portland.

(i) Employees of the State Department of Agriculture who are classified as livestock police of ficers by the Director of Agriculture.

(j) Employees of the Department of Public Safety Standards and Training who are classified by
 the department as other than secretarial or clerical personnel.

25 (k) Investigators of the Criminal Justice Division of the Department of Justice.

26 (L) Corrections officers as defined in ORS 181.610.

(m) Employees of the Oregon State Lottery Commission who are classified by the Director of the
 Oregon State Lottery as enforcement agents pursuant to ORS 461.110.

(n) The Director of the Department of Corrections.

(o) An employee who for seven consecutive years has been classified as a police officer as de fined by this section, and who is employed or transferred by the Department of Corrections to fill
 a position designated by the Director of the Department of Corrections as being eligible for police

(p) An employee of the Department of Corrections classified as a police officer on or prior to July 27, 1989, whether or not that classification was authorized by law, as long as the employee remains in the position held on July 27, 1989. The initial classification of an employee under a system implemented pursuant to ORS 240.190 does not affect police officer status.

(q) Employees of a school district who are appointed and duly sworn members of a law
 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as
 police officers commissioned by the district.

(r) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
Department of Corrections or the Oregon Youth Authority.

45 (s) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de-

1 scription involves the custody, control, treatment, investigation or supervision of juveniles placed

3 (t) Employees of the Oregon Youth Authority who are classified as juvenile parole and probation
4 officers.

5 (17) "Public employer" means the state, one of its agencies, any city, county, or municipal or 6 public corporation, any political subdivision of the state or any instrumentality thereof, or an agency 7 created by one or more such governmental organizations to provide governmental services. For 8 purposes of this chapter, such agency created by one or more governmental organizations is a gov-9 ernmental instrumentality and a legal entity with power to enter into contracts, hold property and 10 sue and be sued.

(18) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2) to (6) (1999 Edition).

(19) "Qualifying position" means one or more jobs with one or more participating public employers in which an employee performs 600 or more hours of service in a calendar year, excluding any service in a job for which a participating public employer does not provide benefits under this chapter pursuant to an application made under ORS 238.035.

(20) "Retirement credit" means a period of time that is treated as creditable service for the
 purposes of this chapter.

(21)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public employer in return for services to the employer, plus the monetary value, as determined by the Public Employees Retirement Board, of whatever living quarters, board, lodging, fuel, laundry and other advantages the employer furnishes the employee in return for services.

41 (D) Any lump sum payment for accumulated unused sick leave;

42 (E) Any accelerated payment of an employment contract for a future period or an advance 43 against future wages;

44 (F) Any retirement incentive, retirement severance pay, retirement bonus or retirement 45 gratuitous payment;

(10) "Member" means an eligible employee who has established membership in the pension program or the individual account program of the Oregon Public Service Retirement Plan and whose membership has not been terminated under ORS 238A.110 or 238A.310.

(11) "Participating public employer" means a public employer as defined in ORS 238.005 that
 provides retirement benefits for employees of the public employer under the system.

(12) "Pension program" means the defined benefit pension program of the Oregon Public Service
 Retirement Plan established under ORS 238A.025.

(13) "Police officer" means a police officer as described in ORS 238.005.

(14) "Qualifying position" means one or more jobs with one or more participating public employers in which an eligible employee performs 600 or more hours of service in a calendar year,
excluding any service in a job for which benefits are not provided under the Oregon Public Service
Retirement Plan pursuant to ORS 238A.070 (2).

(15) "Retired member" means a pension program member who is receiving a pension as provided

(16)(a) "Salary" means the remuneration paid to an active member in return for services to the participating public employer, including remuneration in the form of living quarters, board or other items of value, to the extent the remuneration is includable in the employee's taxable income under Oregon law. If any period over which salary is determined is less than 12 months, the \$200,000 limitation for that period shall be multiplied by a fraction, the numerator of which is the number of months in the determination period and the denominator of which is 12. The board shall adopt rules adjusting this dollar limit to incorporate cost-of-living adjustments authorized by the Internal Revenue Service.
