

OVERALL EXPLANATION: OF ALL TAXES COLLECTED FROM JOSEPHINE COUNTY









### WHY DOES IT TAKE SO MANY EMPLOYEES?

For comparison purposes:

**County Jail** 

500 inmates

4,800 (actual number)

State Prison

500 inmates

rollover in 12 months 200

- County Jails are more labor intense due to the high rate of inmate turnover, classifications, special needs, etc.
- Our new jail was modeled after a prison paradigm. (state of the art facility)





### **PATROL**

#### **NOW**

- Now providing 20hr./7day coverage.
- Providing 24/7 emergency coverage.
- · Improved response times.
  - · Instead of 20 waiting calls we now average 2.
- Most new hires are now fully qualified.
- Traffic enforcement unit.
  - 18% Fewer DUIIs
  - · 2 Traffic Deputies / Accident reconstructionists
  - Proactive enforcement measures.
    - · 187% increase in Officer initiated actions


#### 2013

- Provide one 8hr/7 day coverage.
- Providing 24/7 emergency response.
  - Response time ? Call out from home
  - · Overtime through the roof.
- · Massive layoff.
- Loss of traffic enforcement unit
- Loss of proactive enforcement measures.

#### Additionally:

 Loss of Civil deputies, Court security, and the Investigation unit.

## PATROL DIVISION

### REVERT TO PAST PRACTICES (NOT SAFE)

- > 1,642 sq. miles
- Patrol Deputies: 12
- > 55,000 residents (approx.)
- > 3-4 Deputies on one 8 hr./7 shift

#### **Elevated Risks:**

- Officer Safety
- > Prohibitive overtime costs
- Liability risks increase

#### Adverse Impact:

- > Respond to in-progress and life threatening calls only
- > Slow response time.
  - > Deputies may be call from home, off-duty status.
- Medical service will wait for law enforcement arrival.
- <u>Drastically</u> curtailed, or discontinued services:
  - > Follow-up investigations
  - Civil process
  - > Phone/reporting
  - Dispatching
  - > Criminal Investigations
  - > Evidence tracking
  - Court Security
  - > Prisoner transport
  - > No traffic accident investigations
  - > Search and Rescue

Funding County law enforcement is the responsibility of the Commissioners, according to Oregon law.

It is the responsibility of the Sheriff to provide the citizens with the highest quality of law enforcement services, in a professional, ethical, and fiscally responsible manner.

We are approaching an unprecedented shortfall relative to necessary funding in providing "adequate" levels of service. As the Sheriff, I must exercise due diligence in seeking out any available resources or revenue, wherever possible.
