Dear Co-Chair Burdick, Co-Chair Bailey, Co-Chair Berger and Members of the Committee:

I am writing to you today on behalf of the Oregon Housing Alliance to express support for HB 3168 and HB 2154. Both of these bills pertain to the Farmworker Housing Tax Credit which is used to build affordable housing for farmworkers across Oregon.

Farmworker Housing Tax Credit Program:

Many rural areas in Oregon lack the housing they need for their workers, particularly for farmworkers. The Farmworker Housing Tax Credit (ORS 315.164) is a tool Oregon has used effectively since 1989 to help build housing for farmworkers and their families.

Our communities are better and stronger when we have safe, stable and affordable housing for all our residents. We can ensure everyone has access to safe housing they can afford by maintaining tools to make it easier to build and maintain affordable housing, like the Farmworker Housing Tax Credit. A variety of tools and strategies are needed to create affordable housing opportunities in these communities, and this tax credit has been a proven and effective part of the "toolkit."

- Clarify that Oregon Housing and Community Services may allocate credits to housing developments on a pro-rata basis, reflecting the number of units in a development that will be dedicated to farmworkers.
- Clarify and simplify the application process, and extend the period during which the owners can apply for credits.
