SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows sponsor and public charter school to enter into cooperative agreement with other school districts for purpose of forming partnership to provide educational services.

Allows public charter school to give admission priority to students who reside in school district that is sponsor or school district that is party to cooperative agreement.

Specifies that public charter school that provides educational services under cooperative agreement to at least 25 students, regardless of school district in which students are residents, meets enrollment requirement for public charter schools.

Directs Department of Education, Department of Community Colleges and Workforce Development and Bureau of Labor and Industries to collaborate on issues related to career and technical education.

Establishes Career and Technical Education Revitalization Grant Program for purpose of awarding grants to enhance collaboration between education providers and employers.

Appropriates moneys from General Fund to Department of Education for purpose of grant program.

Declares emergency, effective July 1, 2011.

A BILL FOR AN ACT

2 Relating to collaboration in education; creating new provisions; amending ORS 338.115 and 338.125;
3 appropriating money; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2011 Act is added to and made a part of ORS chapter 338.**

6 **SECTION 2. (1) A sponsor and a public charter school may enter into a cooperative**
7 **agreement with other school districts for the purpose of forming a partnership to provide**
8 **educational services.**

9 **(2) A cooperative agreement entered into as provided by this section must:**

10 **(a) Be incorporated into the charter of the public charter school; and**

11 **(b) Describe the terms of the partnership between the sponsor, the public charter school**
12 **and other school districts.**

13 **SECTION 3. ORS 338.125 is amended to read:**

14 338.125. (1)(a) Student enrollment in a public charter school shall be voluntary.

15 **(b) All students who reside within the school district where the public charter school is located**
16 **are eligible for enrollment at a public charter school.**

1 **(c) Except as provided in paragraph (d) of this subsection,** if the number of applications
2 from students who reside within the school district exceeds the capacity of a program, class, grade
3 level or building, the public charter school shall select students through an equitable lottery se-
4 lection process.

5 **(d)** [*However,*] After a public charter school has been in operation for one or more years, the
6 public charter school may give priority for admission to students **who:**

7 [(a)] **(A)** [*Who*] Were enrolled in the school in the prior year; [*or*]

8 [(b)] **(B)** [*Who*] Have siblings who are presently enrolled in the school and who were enrolled
9 in the school in the prior year[.]; **or**

10 **(C) If the public charter school is a party to a cooperative agreement described in section**
11 **2 of this 2011 Act, reside in the school district that is the sponsor of the public charter school**
12 **or in a school district that is a party to the cooperative agreement.**

13 (2)(a) If space is available, a public charter school may admit students who do not reside in the
14 school district in which the public charter school is located.

15 (b) Notwithstanding paragraph (a) of this subsection, if a public charter school offers any online
16 courses as part of the curriculum of the school, then 50 percent or more of the students who attend
17 the public charter school must reside in the school district in which the public charter school is
18 located.

19 (3) A public charter school may not limit student admission based on race, religion, sex, sexual
20 orientation, ethnicity, national origin, disability, income level, proficiency in the English language
21 or athletic ability, but may limit admission to students within a given age group or grade level.

22 (4) A public charter school may conduct fund-raising activities. However, a public charter school
23 may not require a student to participate in fund-raising activities as a condition of admission to the
24 public charter school.

30 **SECTION 6. (1) Representatives from the Department of Education, the Department of**
31 **Community Colleges and Workforce Development and the Bureau of Labor and Industries**
32 **shall meet at least four times each year for the purpose of promoting collaboration between**
33 **the agencies on issues related to career and technical education.**

34 (2) Issues to be addressed by the agencies shall include the development and implemen-
35 tation of long-term goals that:

36 (a) Ensure that career and technical education programs are available at the public
37 schools of this state, are founded on partnerships with business and industry and receive
38 appropriate investments of time, money and other resources.

39 (b) Develop regional centers of partnerships between public schools, community colleges,
40 state institutions of higher education, businesses, unions and other entities and ensure that
41 every student of this state has access to a regional center in person or online.

42 (c) Implement accelerated college credit programs that allow students to move
43 seamlessly from public schools to post-secondary education or training to the workforce.

44 (d) Increase professional development opportunities for teachers and learning opportu-
45 nities for students through industry mentorships, internships, summer programs, after-

1 school programs and career-based student leadership opportunities.

2 (e) Establish partnerships between public and private entities for the purpose of educat-
3 ing students, parents, teachers, school advisors, policymakers and the general public about
4 the benefits and opportunities related to career and technical education.

5 (3) The agencies identified in subsection (1) of this section shall make a joint report each
6 year to the appropriate legislative committees concerning progress on the development and
7 implementation of the goals described in subsection (2) of this section and may submit rec-
8 ommendations for legislation that will promote opportunities related to career and technical
9 education.

10 **SECTION 7. (1) The Career and Technical Education Revitalization Grant Program is**
11 **established within the Department of Education.**

12 (2) Subject to the availability of funds, the department shall award grants each biennium
13 to school districts, education service districts, public schools or public charter schools, or
14 any combination thereof, for the uses described in subsection (3) of this section.

15 (3) Grants received under this section must be used to enhance the collaboration between
16 education providers and employers by:

17 (a) Developing or enhancing career and technical education programs of study;

18 (b) Expanding the professional growth of and career opportunities for students through
19 career and technical education programs;

20 (c) Assessing the ability of each career and technical education program to meet
21 workforce needs and give students the skills required for jobs in this state that provide high
22 wages and are in high demand; and

23 (d) Supporting the achievement of the high school diploma requirements established un-
24 der ORS 329.451.

25 (4) Any school district, education service district, public school or public charter school,
26 or any combination thereof, may apply for a grant under this section.

27 (5)(a) The department shall award grants based on the ability of the applicant to use a
28 grant as described in subsection (3) of this section.

29 (b) In addition to the requirement of paragraph (a) of this subsection, the department
30 shall give priority to:

31 (A) Awarding grants to applicants so that the grants awarded represent a diverse number
32 of students served and a diverse selection of geographic locations; and

33 (B) Applicants that have received commitments from business, industry, labor or educa-
34 tion providers to enhance collaboration and to provide resources for any collaborative ef-
35 forts.

36 (c) For the purpose of awarding grants, the department shall jointly convene with the
37 Bureau of Labor and Industries a committee that represents business, industry, labor and
38 education providers for the purpose of reviewing applications for grants and recommending
39 determinations on the applications.

40 (6) The State Board of Education may adopt any rules necessary for the implementation
41 of this section.

42 (7) The department may pay the expenses incurred by the department in administering
43 this section out of moneys that are available to the department for purposes of awarding
44 grants under this section. For each biennium, the department may spend on administrative
45 expenses an amount that does not exceed five percent of the total amount of moneys avail-

1 able to the department during the biennium for purposes of awarding grants under this
2 section.

3 **SECTION 8.** In addition to and not in lieu of any other appropriation, there is appropri-
4 ated to the Department of Education, for the biennium beginning July 1, 2011, out of the
5 General Fund, the amount of \$2,000,000, which may be expended for the purpose of awarding
6 grants under the Career and Technical Education Revitalization Grant Program established
7 under section 7 of this 2011 Act.

8 **SECTION 9.** This 2011 Act being necessary for the immediate preservation of the public
9 peace, health and safety, an emergency is declared to exist, and this 2011 Act takes effect
10 July 1, 2011.
