Steve dedicated his career to resource conservation and was one of Oregon's and the nation's top recycling experts. From his early days as a recycling pioneer in Illinois to his thirteen years as a senior policy analyst at Metro, he earned a reputation as a visionary steward of the environment.

Steve had a brilliant mind and was an effective advocate and teacher. He used his deep knowledge and analytical skills to help the region and state evaluate options for improving our recycling efforts. Steve also focused his efforts on getting Metro to improve its own operations by establishing Metro's Green Team. As a result, we have a comprehensive waste prevention and recycling program and a strong focus on improving the efficiency and sustainability of our operations.

Metro is better off today because of Steve's leadership, work and dedication. He was an inspiration to those around him and will be sorely missed.
