SB 474

Adds raccoon to list of potentially habituated wildlife.

SB 287

Makes person allowing livestock to run at large subject to reduced maximum penalty if certain conditions met.

SB 357 A

Requires State Board of Forestry to appoint advisory committee to study and develop recommendations regarding pace and scale of federal forest management projects that may provide benefits justifying state or local government financial support of projects.
