SB 68

Eliminates mandatory minimum sentence for persons under 18 years of age convicted of committing crime of using child in a display of sexually explicit conduct. 180 \*\* \*\*Subsequent Referral(s) to Ways and Means

- SB 180 \*\*
  - Reduces portion of fine imposed in criminal action that is payable to state.
- SB 622

Defines "record of the case" and "supplemental confidential file" in juvenile court proceedings.

SB 696

Modifies exemption from execution applicable to certain firearms.

Amendment to be considered: SB 696-1 which prohibits a person from obtaining a concealed handgun permit if the person has been convicted of a misdemeanor crime involving domestic violence consistent with federal law that prohibits a person with a misdemeanor domestic violence conviction from possessing a firear Prohibits a person from obtaining a concealed firearm permit if subject to a restraining order from another state or a restraining for elderly or child abuse. Allows a person to obtain a concealed handgun permit with only one conviction for misdemeanor or violation conviction for possession of marijuana or who completed a diversion program for marijuana possession.

#### SB 713

Permits firearms training facilities in exclusive farm use zones.

SB 30

CARRIED OVER FROM THE 4/16/2013 AGENDA - Adds crimes to list of sex crimes requiring person convicted of sex crime or adjudicated for act that constitutes sex crime to register as sex offender after being discharged, paroled or released from correctional or detention facility.

#### SB 40

CARRIED OVER FROM THE 4/16/2013 AGENDA - Reduces unlawful manufacture of marijuana to Class B felony.

SB 69

CARRIED OVER FROM THE 4/16/2013 AGENDA - Modifies sentence that court is required to impose when certain persons are convicted of felony driving under the influence of intoxicants.

SB 70

CARRIED OVER FROM THE 4/16/2013 AGENDA - Eliminates July 1, 2013, sunset of provision that limits length of incarceration court may impose when certain probationary sentences are revoked for reasons other than commission of new crime.

SB 71

Imposes restrictions on use of drones by private parties and public entities.

SB 92

CARRIED OVER FROM THE 4/16/2013 AGENDA - Increases maximum penalty when certain crimes are committed against judicial officer and are related to officer's official duties.

SB 125 A

Requires state agency to provide notice to parties in contested case hearing describing rights that active duty servicemembers have to stay proceedings under federal law and providing contact information for legal resources.

SB 694

CARRIED OVER FROM THE 4/16/2013 AGENDA - Requires law enforcement agency to alter police vehicle so that it no longer resembles police vehicle before selling or transferring title.

SB 780

Requires grand jury proceeding involving use of deadly force by police officer to be recorded, transcribed and made available to public.

SB 834

CARRIED OVER FROM THE 4/16/2013 AGENDA - Increases penalty for crime of initiating false report to maximum of one year's imprisonment, \$6,250 fine, or both.
