Relating to the Oregon Health and Science University; creating new provisions; amending ORS 40.275, 44.550, 90.440, 124.050, 133.005, 133.525,
133.721, 133.726, 136.595, 146.003, 147.425, 153.005, 161.015, 163.730, 165.535,
181.010, 181.610, 181.715, 181.860, 236.350, 348.270, 353.050, 414.805, 419B.005,

756.160, 801.395, 811.720, 811.745, 811.747, 823.081 and 830.005; and declaring an emergency.

9 Be It Enacted by the People of the State of Oregon:

<u>SECTION 1.</u> (1) The Oregon Health and Science University Board of Directors, or Oregon Health and Science University officials acting under the authority of the board, may establish a police department and commission one or more employees as police officers. A police department established under this section has all of the authority and immunity of a municipal police department of this state.

16 (2) Police officers commissioned under this section:

(a) May enforce criminal laws and any administrative rules and
 policies adopted by the university; and

(b) Have all the authority and immunity of a peace officer or police
 officer of this state.

(3) When the university establishes a police department and commissions one or more employees as police officers under this section,
the university, in cooperation with the chief of the police department,
shall establish a process by which the university will receive and respond to complaints involving the policies of the police department
and the conduct of the police officers.

7 (4) The university may:

(a) Enter into an agreement with a municipal corporation or any
department, agency or political subdivision of this state for the provision of mutual aid by their respective police officers; and

11 (b) Adopt rules to carry out the provisions of this section.

representative of the unit of government if the information was furnished to

(a) If the identity of the informer or the informer's interest in the subject
matter of the communication has been disclosed to those who would have
cause to resent the communication by a holder of the privilege or by the

(b) If it appears from the evidence in the case or from other showing by 3 a party that an informer may be able to give testimony necessary to a fair 4 determination of the issue of guilt or innocence in a criminal case or of a 5material issue on the merits in a civil case to which the unit of government 6 is a party, and the unit of government invokes the privilege, and the judge 7 gives the unit of government an opportunity to show in camera facts relevant 8 to determining whether the informer can, in fact, supply that testimony. If the removed tenant does not have an emergency departure plan, a representative of the group recovery home shall offer to take the removed tenant to a public shelter, detoxification center or similar location if existing in the community.

(6) The date and time for moving out specified in a notice under sub-15 section (3) of this section must be at least 24 hours after the date and time 16 the notice is delivered to the tenant. If the tenant remains on the group re-17covery home premises after the date and time for moving out specified in the 18 notice, the tenant is a person remaining unlawfully in a dwelling as de-19 scribed in ORS 164.255 and not a person described in ORS 105.115. 9 (3) Make any and all contracts and agreements, enter into any partner-10 ship, joint venture or other business arrangement, create and participate 11 fully in the operation of any business structure, including but not limited to 12 the development of business structures for health care delivery systems and 13 networks with any public or private government, nonprofit or for-profit per-14 son or entity that in the judgment of the university or the board is necessary 15 or appropriate to carry out the university's missions and goals.

(4) Acquire, purchase, receive, hold, control, convey, sell, manage, oper ate, lease, license, lend, invest, improve, develop, use, dispose of and hold
 title to real and personal property of any nature, including intellectual
 property, in its own name.

(5) Sue in its own name and be sued, plead and be impleaded in all actions, suits or proceedings in any forum brought by or against it by any and all private or state, local, federal or other public entities, agencies or persons.

(6) Encourage gifts and donations for the benefit of the university, and
subject to the terms of the gift, retain, invest and use such gifts as deemed
appropriate by the university or the board.

(7) Acquire, receive, hold, keep, pledge, control, convey, manage, use, lend,
expend and invest all funds, appropriations, gifts, bequests, stock and revenue from any source to the university.

30 (8) Borrow money for the needs of the university, in such amounts and 31 for such time and upon such terms as may be determined by the university

1 or the board.

2 (9) Erect, construct, improve, develop, repair, maintain, equip, furnish,
3 lease, lend, convey, sell, manage, operate, use, dispose of and hold title to
4 buildings, structures and lands for the university.

5 (10) Purchase any and all insurance, operate a self-insurance program or 6 otherwise arrange for the equivalent of insurance coverage of any nature and 7 the indemnity and defense of its officers, agents and employees or other 8 persons designated by the university to carry out or further the missions of 9 the university.

10 (11) Create, develop, supervise, control and adopt academic programs, in-11 cluding standards, qualifications, policies or practices relating to admissions, 12 curriculum, academic advancement, grading policy, student conduct, credits 13 and scholarships and the granting of academic degrees, certificates and other 14 forms of recognition.

(12) Authorize, create, eliminate, establish, operate, reorganize, reduce or
 expand any program, school, institute, health care facility or other unit of
 operation.

(13) Establish, charge, collect and use charges for enrollment into the 18 university, including charges such as tuition for education and general ser-19 vices, incidental fees and such other charges found by the university to be 2021necessary to carry out its educational programs. Fees realized in excess of amounts allocated and exceeding required reserves shall be considered sur-22plus incidental fees and shall be allocated for programs under the control 23of the board and found to be advantageous to the cultural or physical de-24velopment of students of the university upon the recommendation of the re-25cognized student government of the university. 26

(14) Establish, charge, collect and use charges and fees for university
services and the use of university facilities.

(15) Impose charges, fines, fees and such other regulations considered convenient or necessary to control and regulate traffic and parking of vehicles to the same extent allowed the State Board of Higher Education. This

authority includes the authority to enforce the regulations of the university
in a court to the extent allowed the State Board of Higher Education in
enforcing the state board's regulations as provided in ORS 352.360 (7).

[(16) Commission special campus security officers to be known as university 4 police. University police commissioned under this subsection have all the 5powers and authority given by statute to peace officers and police officers of 6 this state. University police shall complete training necessary for certification 7 as police officers at an academy operated or authorized by the Department of 8 Public Safety Standards and Training at the expense of the Oregon Health 9 and Science University Board of Directors. University police are not author-10 ized to carry firearms as police officers and are not police officers for purposes 11 12of ORS 238.005, 243.005 or 243.736. The university is a criminal justice agency for purposes of ORS 181.715 and 181.720 and a law enforcement unit within 13 the meaning of ORS 181.610 (12).] 14

[(17)] (16) Enforce and recover for payment to the university any fines
that are authorized by this chapter.

[(18)] (17) Adopt, amend or repeal bylaws, administrative rules, regulations and orders applicable to the matters that are the subject of this chapter.

[(19)] (18) Contract with any state agency for the performance of such duties, functions and powers as is appropriate. A state agency shall not charge the university for such services an amount that is greater than the actual cost of the services.

[(20)] (19) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock or other equity or interests in or obligations of any other entity. Separate funds may be established for such investments. The State of Oregon shall have no proprietary or other interest in such investments or such funds.

30 [(21)] (20) Make available, by lease or otherwise, or control access to any 31 health care facilities or services or other of its properties and assets to such

persons, firms, partnerships, associations or corporations and on such terms as considered appropriate, charge and collect rent or other fees or charges therefor and terminate or deny any such access or any such lease or other agreement for such reasons as considered appropriate and as may be consistent with its obligations under any such lease or other agreement.

6 [(22)] (21) Contract for the operation of any department, section, equip-7 ment or holdings of the university and enter into any agreements with any 8 person, firm or corporation for the management by said person, firm or cor-9 poration on behalf of the university of any of its properties or for the more 10 efficient or economical performance of clerical, accounting, administrative 11 and other functions relating to its health care facilities.

12 [(23)] (22) Select and appoint faculty as medical and dental staff members and others licensed to practice the healing arts, delineate and define the 13 privileges granted each such individual, adopt and direct a plan for faculty 14 clinical income and set the terms and conditions of that plan (including such 15 modifications to any such existing plan as considered necessary or appro-16 priate upon expiration of the term of such plan), and determine the extent 17to which and the terms upon which each such individual may provide 18 teaching, research, consulting or other services at the university or any 19 other health care facility. 20

[(24)] (23) Enter into affiliation, cooperation, territorial, management or other similar agreements with other public or private universities or health care providers for the sharing, division, allocation or furnishing of services on an exclusive or a nonexclusive basis, referral of patients, management of facilities, formation of health care delivery systems and other similar activities.

[(25)] (24) Perform any other acts that in the judgment of the board or university are requisite, necessary or appropriate in accomplishing the purposes described in or carrying out the powers granted by this chapter.

30 [(26)] (25) Exercise these powers, notwithstanding that as a consequence 31 of the exercise of such powers, the university engages in activities that

1 might otherwise be deemed anticompetitive within the contemplation of state2 or federal antitrust laws.

10 (2) The Oregon Health and Science University may adopt rules or 11 take any other action necessary to enable the university to exercise, 12 on and after the operative date specified in subsection (1) of this sec-13 tion, all the duties, functions and powers conferred on the university 14 by this 2013 Act.

<u>SECTION 63.</u> This 2013 Act being necessary for the immediate
 preservation of the public peace, health and safety, an emergency is
 declared to exist, and this 2013 Act takes effect on its passage.
