Public hearings on the budget for the Department of Forestry are scheduled from Monday, April 15 to Thursday, April 18. Public testimony will be taken on Thursday.

The Department of Forestry implements policies and programs that promote sustainable management of Oregon's public and private forests. More specifically, ODF provides fire protection on 16 million acres in private and public ownership; manages several state forests, including those that are Common School Fund lands; administers the Oregon Forest Practices Act to protect natural resources; and maintains around 390 structures across the state to support its activities.

Materials on OLIS include the Legislative Fiscal Office budget review document and an issue brief on fire funding; the Department's budget presentation; the Department of Administrative Services budget overview; and the Governor's recommended 2013-15 budget. They are posted under SB 5521 on April 15.

Cost savings, efficiencies, cost avoidance in administering Forest Practices Act

The Department of Forestry will contract with an independent third-party to assess and make recommendations on cost savings, efficiencies, and cost avoidance strategies that could prove effective for the administration of the Forest Practices Act. The Department is to work with representatives from other state agencies and private and public forest land owners, to develop a recommendation on the potential budgetary, programmatic, and service delivery alternatives. The report and recommendations are to be completed and submitted to the interim Joint Committee on Ways and Means or Emergency Board no later than July 1, 2012. (Page 107 of agency presentation)
