Senate Business and Transportation Committee Testimony in support of SB 833, April 11, 2013, 3pm., Room B

Chair Beyer, Vice Chair Starr, Sens. Edwards, Girod, and Thomsen:

The Oregon Advocacy Commissions are submitting testimony in support of SB 833 which creates a distinct, 4-year Short-Term Driver License for anyone who cannot provide the proper documentation for a standard driver license. Along with access to jobs, shopping, and medical appointments for many families, we consider this to be an effective public safety measure designed to improve traffic safety and reduce the number of unlicensed, uninsured drivers on Oregon's roads.
