Prior to 2001, there were a variety of fees charged to register and renew a business. Assumed business names had a base fee of \$12 up to \$82 if doing business in each of 36 counties (\$2 county fee). Fees were higher for the original filing than the fee for renewal. Approximately \$11.5 million was transferred to the General Fund each biennium.

House Bill 2212 (1999) went into effect July 1, 2001 and changed all Business Registration fees to a flat rate of \$20 to cover the cost of the program only, and eliminated transfers to the General Fund.

House Bill 3656 (2003) went into effect January 1, 2004 and increased all Business Registration fees to \$50. \$20 retained by the Secretary of State to cover the cost of the program, and \$30 of each fee was transferred to the General Fund. Approximately \$21.5 million was transferred to the General Fund each biennium.

House Bill 3405 (2009)/Measure 67 (2010) went into effect March 1, 2010 and increased Business Registration fees for Oregon for-profit entities to \$100, and foreign for-profit entities to \$275. \$20 of each fee is retained by the Secretary of State to cover the cost of the program, and the remaining \$30, \$80, or \$255 is transferred to the General Fund. Approximately \$48 million is projected to be transferred to the General Fund.
