Chair Hass and members of the Senate Education Committee, for the record, my name is Morgan Allen and I am a legislative specialist for the Oregon School Boards Association. I am here today to urge your support for Senate Bill 273, which would represent the first major state investment in school building and renovation since the passage of Ballot Measure 68 in 2010.

# **Background**

When almost 66% of Oregonians approved Measure 68 in May 2010, they made two important changes to our state constitution. The first change broadened the allowable uses for school district capital bonds to allow districts to not only build new schools, but to furnish, equip and maintain those schools with their bond funds. The second change gave the state the same bonding authority to raise funds for capital construction in K-12 districts that it has for community colleges and the Oregon University System. These bond proceeds can only be used as matching funds to help pay for capital costs incurred by school districts that have voter approved bonds.

The funds raised by Senate Bill 273 will help create incentives for local districts to pass bonds for their schools and will especially help communities that may have a low tax base make major investments in their school buildings.

You may remember that the legislature established a school facilities task force in 2009 and extended their work in 2011. Unfortunately, the funding to provide Oregon's first comprehensive assessment of the facilities needs in our school districts was not made available. However, the task force did reinforce the need for major capital investments in school districts across Oregon. You only need to drive into almost any district in Oregon to see old buildings or portable classrooms that were never intended to serve as permanent facilities dotting the landscape.

#### **Prioritizing Limited Resources**

In Senate Bill 273 we have prioritized funding for five different areas that facilities experts tell us are of the greatest need or will be needed to help districts prepare for new state educational mandates:

- Building or retrofitting instructional space for full-day kindergarten. We know that many districts will need to do this in advance of the kindergarten formula change in 2015.
- Building or retrofitting space available for physical education. There is ample data that shows districts will need to increase space for the PE mandate that begins in 2017.
- Tsuanmi and earthquake upgrades and retrofits. There are literally dozens of shovel-ready projects that have applied for state funding but there is not enough funding available.
- Health and safety projects to address health hazards like mold and asbestos, which students across Oregon are exposed to every day.
- Projects designed to improve student achievement. A top priority if we are going to achieve the 40-40-20 goal.

Oregon's students deserve to go to school in healthy environments, which includes safe, modern buildings in good working condition and free from preventable health hazards. Our members believe that the state has a shared responsibility to provide a quality education in a quality facility.
