2013-2015 Significant Changes

Fund Shifts- \$3.5 million in GF restored

The Governors Balanced Budget reverses one-time fund shifts that occurred in the 2011-2013 budget. New fund shifts from GF to OF occurred in Administration (\$330,907) and were taken from the agency's 10% reduction list. In addition internal fund shifts occurred in Administration (\$83,883) to help fund the Wolf Compensation package and Plant Health (\$159,924) to help fund the Ag Water Quantity package.

Lottery Fund Revenue Shortfall- (\$1,195,467)

Anticipated lottery fund revenues for the 2013-2015 biennium are not sufficient to fund current service level expenditures. Reductions occurred in the following programs:

*Weed Program- (\$518,896), (1) Position, (2.40) FTE

*Plant Threatened and Endangered Program- (\$304,760), (1) Pos., (1.00) FTE (reduction restored with OF/FF in Pkg. 330) *Insect Pest Prevention Program- (\$371,811), (1) Position, (1.00) FTE (reduction partially restored with \$353, 789 GF in Pkg. 335)

Note: Net lottery reduction was at \$841,678

PERS Rate Adjustments- (\$1.6 million)

The Governors Budget includes reductions related to the Public Employee Retirement System. The total generated savings equals \$1.6 million in all funds. This package reduces GF \$344,685, LF \$118,165, OF \$1,078,304, and FF \$92,082.

Statewide Administrative Savings- (\$359,465)

The Governors Budget includes a placeholder for administrative efficiencies to be found in the areas of Finance, Information Technology, Human Resources, Payroll, and Procurement activities. There will be on-going work to determine how best to proceed in these areas. This placeholder package reduces GF by \$86,272 and Other Funds by \$273,193. This represents a 5.45% holdback in agency budgets.

Oregon Invasive Species Council – (\$50,000 LF)

The Governor's budget does not contain state funding for the council. This was an oversight and is on a technical adjustment list for consideration by LFO.

Policy Option Packages – Budget Enhancement

- <u>420 Ag Water Quantity (\$249,267 GF)</u>: As the state's population increases, challenges related to surface and ground water availability increase. This is a growing area of importance to Oregon farmers and ranchers. This request provides the Oregon Department of Agriculture (ODA) the resources to address upcoming challenges relating to water availability. At this time, ODA has limited expertise to guide and aid agricultural producers with this issue. We believe that a specialist in surface and groundwater matters in ODA will provide farmers and ranchers a point of contact and assistance in understanding state laws and processes as they relate to agricultural management. This package will allow ODA to adequately represent agriculture in discussions regarding future water availability. Agriculture is an important component of the state's economy and requires access to water to maintain its ability to provide food and other products.
- <u>320 Pesticide Stewardship Monitoring Collaboration (\$1,380,438* GF/OF equal split)</u>: This policy package requests funds for the development of a statewide Pesticide Stewardship Partnership (PSP) Program to provide an effective collaborative approach to addressing pesticide-related water quality issues across all land uses and a more cost-efficient alternative to possible regulatory approaches. This package, in conjunction with a package submitted by the Oregon Department of Environmental Quality (DEQ), would establish a joint collaborative program between DEQ and the Oregon Department of Agriculture (ODA) and be funded with \$1.5 million in revenue comprised of \$750,000* General Funds and \$750,000* Other Funds obtained from pesticide registration and pesticide user license fees. The agencies have agreed that any decrease in General Funds would result in an equal reduction in Other Funds.
- <u>415 Specialty Crop Program</u>: The Oregon Department of Agriculture (ODA) has received USDA Specialty Crop Grant allocations averaging over \$1 million since 2008. These funds are used for state run projects or subsequently sub-granted to partner organizations for the purpose of improving the competitive advantage of Oregon specialty crops. Each year the ODA awards approximately 25 sub-grants that must be completed within a three year time period and, therefore, has some 75 active grant activities annually. The ODA has been informed it will receive a 2012 allocation of approximately \$1.5 million in September 2012 and anticipates another five years of funding when the Farm Bill is passed later this year or early 2013. The cost of administering this program is covered by Federal Funds and requires no General Fund support. We believe full time dedicated staff to administer the program and support the sub-grantee partners will ensure that Oregon continues to receive and manage its share of these funds which benefit so many in Oregon's agricultural community.

Policy Option Packages – Budget Continuation

- <u>105 Wolf Compensation (\$100,000 GF)</u>: This policy option package continues the funding for the wolf depredation compensation and financial assistance grant program.
- <u>315 Pesticide Outreach & Compliance (\$463,534 OF)</u>: Continue current level of outreach and compliance monitoring activities in the Base Pesticides Program conducted during the 2011-13 biennium. Outreach focuses on educating pesticide users about lawfully using pesticides. Compliance monitoring includes documenting how pesticides were used, determining if specific uses were conducted lawfully, and taking enforcement action for unlawful actions.
- <u>325 Ag Water Quality Effectiveness (\$962,654 GF)</u>: The Oregon legislature, other state and federal agencies, and the public look to the Oregon Department of Agriculture (ODA) to address agricultural water quality issues in Oregon. ODA frequently receives requests for information on the effectiveness of programs identified in ORS 568 to help achieve state goals for water quality, habitat, and fisheries. This policy option package addresses this need by making three limited duration positions permanent to continue to support a monitoring program that includes: evaluating riparian conditions along agricultural lands; monitoring ambient water quality monitoring sites that reflect strong agricultural influence; and establishing the expertise within the ODA to analyze, report, and fully participate in state water quality monitoring efforts.
- <u>410 Commodity Commission Oversight (\$184,342OF)</u>: This policy package will increase Other Funds spending authority to align it with the amount needed to operate the ODA Commodity Commission oversight program. The limit on ODA's budget authority will not permit spending the additional Other Fund collected from the commodity commissions to reimburse ODA for the full cost of operating the legally mandated oversight program.
