Dear Co-Chairs and Members of the Subcommittee:

On behalf of the Oregon Youth Authority (OYA), I am pleased to provide the following responses to the questions posed by subcommittee members during the agency's presentation on April 29, 2013.

Q. Is there a community that is more accepting of re-entry of OYA youth into local high schools?

A. OYA Parole and Probation officers work closely with local communities to plan the transition of offenders from close custody back to local schools. OYA does not maintain data that would rank local communities by degree of acceptance.

Q. What is the OYA cost per day including the amount spent on education?

A. The close-custody cost per day in the 2013-15 Governor's Balanced Budget is \$269 General Fund. OYA uses the same methodology as the Oregon Department of Corrections (DOC) to calculate cost per day. The following table summarizes the OYA cost per day components in the same program categories as DOC:

Education for younger youth in OYA custody is provided by the Oregon Department of Education (ODE) as part of the Youth Corrections Education Program. Including ODE funding in the OYA budget would add approximately \$23 to the OYA cost per day.

Q. How many positions and FTE are in Facility Programs and Community Programs?

A. The following table summarizes OYA positions and FTE by program:

Q. Can any of the proposed funding for deferred maintenance be used to move the OYA Central Office?

A. These funds are earmarked for 12 high priority projects that address critical program needs:

We are exploring options to identify the most cost-efficient location for Central Office. These options include remaining at our current leased site or relocating to a facility owned by the Oregon Department of Administrative Services or OYA.

Q. How closely is OYA working with the Oregon Trades Council?

A. OYA does not provide any formal apprenticeship programs. Barriers to such programs include developing an appropriate wage rate and providing adequate insurance coverage for participating youth. However, we continue to explore opportunities with DOC to develop a formal apprenticeship program for OYA youth. OYA currently offers non-apprenticeship vocational training in welding, electrical, wastewater treatment, firefighting, and barbering. We also offer youth programs in woodworking, food service, gardening, horticulture, and dog care.
