

HB 2407 Political Tax Credit

Testimony for Tax Credits 5.9.2013

Means testing the Political Tax Credit makes sense. This is a change we would support.

A cut off at \$75,000 for all tax filers, or \$60 for single and head of household and \$100 for couples seems appropriate. This is well above the Oregon median household income in 2011 of \$46,800. The chart below is a mix of single, and head of household and couple full-year filers. The \$60k/\$100k limits would remove the benefit for 20-25% of the population. This would allow most households for whom political giving is a stretch to continue to participate in the political progress.
